The OxBlue Corporation Retirement Plan "the Plan" was established effective July 1, 2007. The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. As the January 13, 2023 the Plan was terminated with the net assets of the plan as of that date being transferred to the new plan.

#### *General:*

The OxBlue Corporation retirement Plans a defined contribution plan which was organized for the primary purpose of providing a retirement benefit for eligible employees and their beneficiaries. The Plan was established under the provisions of Section 401(a) of the Internal Revenue Code (the "IRC") which includes a qualified cash or deferred arrangement as described in Section 401 (k) of the IRC, for the benefit of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### *Eligibility:*

Employees are eligible for salary deferrals upon reaching the age of twenty one. Employees are eligible for matching contributions and profit sharing contributions following the date on which the employee has completed one year of service, as defined by being credited with at least 1,000 hours of service and provided the employee is at least twenty-one years of age.

#### *Contributions:*

Participants may elect to contribute an amount up to 75% of their eligible compensation, as defined in the Plan document, subject to statutory limits under the IRC. Participants who are age 50 or older may contribute additional amounts as provided in the Economic Growth and Tax Relief Reconciliation Act of 2001. Changes in participant deferral amounts take effect on the beginning of each month. Participants who are employed on the last day of the year and who have completed one year of service during the year are eligible to receive an employer contribution. The Company provides safe harbor matching contributions equal to 100% of the employee's salary deferrals that do not exceed 3% of the employee's compensation plus 50% of the employees salary deferrals between 3% and 5% of the employees compensation.

#### *Participant accounts:*

Individual accounts are maintained for each of the Plan's participants which reflect the participants' share of the Plan's income (loss), expenses, contributions, and net realized and unrealized gains and losses on investments. Participants choose investments for their accounts from offered investment funds.

#### *Participant loans:*

Participants may borrow from their vested fund accounts a minimum of \$1,000 up to maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Loans bear a reasonable rate of interest as provided in the Plan document and are repayable through payroll deductions over periods ranging up to 60 months. The maximum number of Plan loans that an employee may have outstanding at any one time is one.

#### **A** Description of Plan (continued)

##### *Vesting:*

Participants are fully vested at all times in their voluntary as well as employer match contributions and earnings thereon. Participant's vested percentage in their account attributable to discretionary profit sharing contribution is determined under the following schedule:

##### *Investments options:*

Upon enrollment, participants may direct the investments of their entire account balance, including all Company and participant contributions, into various investment options offered by the Plan. Participants may change their elections and request transfers at any time through the third party administrator, FuturePlan.

##### *Payment of benefits:*

Distributions are permitted only upon attainment of normal retirement age, termination of employment, or the event of financial hardship, as defined. On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount, or in annual installments over a period of time not to exceed the employee's life expectancy or the joint expectancy of the employee and spouse, if applicable. If an employee's vested account balance upon distribution is less than \$5,000, the employee will automatically be paid in one cash payment.

##### *Administrative expenses:*

The Company has elected to fund substantially all administrative costs for participants, other than those associated with certain participant directed transactions, such as participant loan fees.

##### *Plan termination:*

Although the Company intends for the Plan to continue, the Company reserves the right to discontinue annual contributions or to terminate the Plan. In the event of the Plan's termination, the account of each participant will be fully vested and nonforfeitable as of the effective date of termination of the Plan.

##### *Tax status:*

The Sponsor adopted a prototype 401(k) Profit Sharing Plan. The Internal Revenue Service determined and informed the Plan's trustees that the Plan is designed in accordance with applicable sections of the Internal Revenue Code. Accordingly, the Plan is exempt from income taxes.

#### **B** Summary of Significant Accounting Policies

##### *Basis of accounting:*

The Plan's financial statements are prepared on the modified cash basis of accounting as permitted under the Department of Labor Rules and Regulations. Under the modified cash basis of accounting, contributions, securities transactions, and distributions are recorded on the basis of cash receipts and disbursements. Investment earnings are recorded based on the fair value of the investments at the end of the Plan year.

##### *Use of estimates:*

The preparation of financial statements in conformity with the modified cash basis of accounting requires the trustees to make estimates and assumptions that affect the reported amounts of assets and liabilities that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

##### *Method used to value investments and income recognition:*

The Plan's investments are stated at fair value which is valued at contract value. Investments in securities traded on a national securities exchange are valued at the last reported sales price on the last business day of the year. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses on sales of investments and unrealized appreciation and depreciation in fair value of investments are based upon beginning of year market values or cost, if acquired during the year. Interest and dividend income is recorded when earned and received on the last day of the quarter.

##### *Date of management's review:*

Management has evaluated events and transactions occurring after the statement of net assets available for benefits (modified cash basis) date through November 13, 2023, which is the date the financial statements were available to be issued. Management has determined that none of the events occurring after the date of the balance sheet through the date of management's review substantially affect the amounts, presentation and disclosure of the accompanying financial statements.

##### *Risks and uncertainties:*

The plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

#### **C Party-in-Interest Transactions**

Ascensus, the trustee of the Plan's assets, manages certain Plan investments. Therefore, these transactions qualify as party-in-interest transactions. During 2022, the Plan paid \$45,968 in administration fees, respectively.

#### **D Information Prepared and Certified by Trustee**

The Administrative Committee has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

Investments as shown transferred out as of January 13, 2023.

Investment activity, as shown in the statement of changes in net assets available for benefits for the period ended January 13, 2023.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

#### **E Fair Value Measurements**

The Fair value measurements enable the reader of the financial statements to assess the inputs used to develop those measurements by establishing a hierarchy for ranking the quality and reliability of the information used to determine fair values. The Plan classifies and discloses assets carried at fair value in of the following three categories. Refer to Note A for details in the procedures used to value investments in common collective trust funds measured at NAV, which is used as a practical expedient to estimate fair value.

Level 1: Inputs are unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date.

Level 2: Inputs are observable inputs other than quoted (Level 1) prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3: Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The assets fair value measurements level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### **F** Concentrations of Risks and Uncertainties

In accordance with accounting principles generally accepted in the United States of America, the Plan administrator has evaluated the Plan's risks and uncertainties. The Plan administrator believes that all significant risk has been disclosed in Plan documents and participant literature. The Plan's investments are exposed to various risks such as interest rates, market, and credit risks. In consideration of the nature and level of risk associated with certain investments, it is at least reasonably possible that changes in investment values will occur in the near term, and that such changes could materially affect participants account balances and the amounts included on the statements of net assets available for benefits.

#### **G** Termination of Plan and Transfer of Asset to New Plan

In As of January 13, 2023 the plan was terminated. Total assets of the plan plan was transferred to the Hexagon Employee Retirement Savings Plan, the parent company of OxBlue Corporation. A final Form 5500 was filed closing the plan.
