Note 1 - Description of Plan

The following brief description of the Mizell Memorial Hospital, Inc. 401(a) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering all full-time employees of the Plan Sponsor who had one year of service and were age eighteen or older. The Plan was sponsored by Mizell Memorial Hospital, Inc. (the "Plan Sponsor" or "Company"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan Termination

The Board voted to terminate the Plan effective June 2022 via merger with the Mizell Memorial Hospital, Inc. 403(b) Retirement Savings. However, participants were given the option to have their balances distributed to participant IRA accounts, the participant's current employer's plan, or directly to the participants, according to the request of the participants, thereby liquidating the Plan. All balances were distributed as of August 2022.

Contributions

No Company contributions were received by the Plan in 2022 or 2021.

Participant Accounts

Each participant's account was credited with the Company's contribution, if any, and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that are paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants were immediately vested in their share of the Company contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants were allowed to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans were secured by the balance in the participant’s account and bore interest at a rate of 4.25% - 6.50% for the eight months ended August 31, 2022 and year ended December 31, 2021. These rates were commensurate with local prevailing rates as determined by the plan administrator. Principal and interest were collected ratably through payroll deductions, which ceased upon the participant’s withdrawal from the Plan due to the Plan termination.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant’s vested interest in his or her account, or annual installments over a 10-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Hardship Withdrawals

Participants may make hardship withdrawals using the “deemed hardship” rules if they have an immediate and heavy financial need and other resources are not available to meet the need. Only the employee’s share of Company’s contributions from the 401(a) Plan may be withdrawn, excluding Plan earnings.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared using the liquidation basis of accounting in accordance with principals generally accepted in the United States of America (“GAAP”) as of August 31, 2022 and for the eight months then ended, and the accrual basis in accordance with GAAP as of December 31, 2021.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

All investment values were considered to materially approximate the liquidation basis of accounting.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses was recorded as of December 31, 2021. All loan balances were paid in full as of August 31, 2022.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Date of Management's Review of Subsequent Events

Subsequent events were evaluated through November 8, 2023, which is the date the financial statements were available to be issued.

Note 4 – Fair Value Measurements

Financial Accounting Standards Board (“FASB”) *Accounting Standards Codification* (“ASC”) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs, which must be observed for substantially the full-term of the asset or liability, to the valuation methodology include:

- (a) Quoted prices for similar assets or liabilities in active markets;
- (b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- (c) Inputs other than quoted prices that are observable for the asset or liability; and
- (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at August 31, 2022 and December 31, 2021.

Pooled Separate Accounts are valued at the net asset value (“NAV”) of units held by the separate account. The NAV, as provided by the custodians, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a pooled separate account, the investment advisor reserves the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidations will be carried out in an orderly business manner.

Guaranteed Interest Accounts are valued at contract value by the custodians by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. Participants transact at contract value, which approximates fair value (See Note 5).

Note 5 – Investment Contract with Insurance Companies

The Plan has entered into non-fully benefit-responsive investment contracts with Empower Retirement, who maintains the Plan’s contributions in guaranteed interest accounts. The accounts are credited with earnings on the underlying investments and charged for plan withdrawals and expenses. The contracts are included in the financial statements at contract value, which approximates fair value, as reported to the Plan by the custodian.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value, which approximates fair value, of the guaranteed interest accounts was \$0 and \$468,874 as of August 31, 2022 and December 31, 2021, respectively. The crediting interest rate was based upon a formula agreed upon with the issuer, but could be no less than 2.00% for accounts set up after December 1, 2003. The crediting interest and average yield rates with adjustment to reflect the rate credited to participants was approximately 3.00% for the eight months ended August 31, 2022 and year ended December 31, 2021. Such interest rates were reviewed on an annual basis for resetting.

Note 6 – Related-Party Transactions and Party in Interest Transactions

Certain plan investments were managed by the custodians of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid to the custodians amounted to \$188 and \$780 for the eight months ended August 31, 2022 and year ended December 31, 2021, respectively.

Note 7 – Tax Status

The Plan Sponsor had adopted a prototype defined contribution plan which received a favorable opinion letter from the Internal Revenue Service on March 31, 2014, which stated that the prototype plan, as then designed, was in compliance with the applicable provision of the IRC. The prototype plan was amended since receiving the opinion letter and the Plan itself had not received a determination letter. However, the plan administrator believed that the Plan was designed and operated in compliance with the applicable requirements of the IRC and was therefore qualified and exempt from taxation.

Note 7 – Tax Status (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of August 31, 2022, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

Note 8 – Risks and Uncertainties

The Plan invested in various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, market, and credit risks.
