Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Young Harris College Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of January 31, 2023 (Date of Transfer) and June 30, 2022, and the related statement of changes in net assets available for benefits for the period July 1, 2022 through January 31, 2023 (Date of Transfer), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Young Harris College Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by banks or similar institutions or insurance carriers that are regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the banks or similar institutions or insurance carriers in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from qualified institutions as of January 31, 2023 (Date of Transfer) and June 30, 2022 and for the period July 1, 2022 through January 31, 2023 (Date of Transfer) stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Young Harris College Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Young Harris College Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1: DESCRIPTION OF PLAN

The following description of the Young Harris College Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Young Harris College (the Sponsor, Employer, or Plan Administrator). The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Sponsor's Board of Trustees (Board) is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance.

Plan assets are held and managed by Teachers Insurance and Annuity Association - College Retirement Equities Fund (TIAA, CREF), the qualified institutions for the Plan, which invest contributions and Plan earnings, make investment transactions as directed by the Board and provide certain recordkeeping services. TIAA and CREF shall herein be referred to collectively as the Qualified Institutions.

Transfer from Plan

Effective February 1, 2023, the Sponsor formally adopted the GICA Multiple Employer Plan and the Plan's net assets were transferred to the GICA Multiple Employer Plan on January 31, 2023. As a result, the Plan was effectively terminated.

Eligibility

All employees that normally work more than 20 hours per week and 1,000 hours per year are immediately eligible to participate in the Plan upon hire. An eligible employee may enter the Plan on the first payroll period after all entry requirements have been met.

Contributions

Participants may contribute any amount of their eligible compensation by means of payroll deductions, subject to certain limitations prescribed by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants hired on or after July 1, 2019 receive a fixed nondiscretionary Employer contribution of 4% of eligible compensation each pay period. Existing Plan participants as of June 30, 2019 will receive nondiscretionary Employer contributions as a percentage of eligible compensation, calculated as follows based on the years of service earned prior to June 30, 2019.

Participant Accounts

Each participant's account is credited with the participant's contribution, Employer contributions, and Plan earnings. Participant accounts are charged with withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, any rollover contributions, employer contributions and actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must be fully repaid within five years from date of issuance, except those loans used to purchase the principal residence of a participant, which must be fully repaid over a reasonable amount of time, not to exceed twenty years. The notes receivable are secured by the balance in the participant's account and bear interest rates at the prime rate plus 1%, as defined.

Plan Loans

Plan loans are no longer available to participants effective January 1, 2022. Participants were able to take plan loans directly from TIAA until January 1, 2022. A participant was able to borrow the lesser of 45% of the participant's vested account balance or \$50,000, as defined in the Plan document. Plan loans were issued directly from TIAA and loan proceeds were not removed from participant account balances. The plan loans are secured by vested funds in the participant's TIAA Traditional annuity accounts equaling 110% of the outstanding loan balance are reserved or held in collateral for each plan loan. The loan must be repaid over a period not extending beyond five years from the date of the loan, unless the loan is used to acquire a primary residence, in which case the loan may be repaid over a reasonable amount of time, not to exceed ten years.

Loans which are not repaid under the terms of the agreement are defaulted and reported in one of two ways. If a participant defaults on a loan and has reached a distributable event, the defaulted loan is considered a distribution and included with benefits paid to participants. However, if a participant defaults on the loan when the participant has not reached a distributable event, the defaulted loan is treated as a deemed distribution. In this case, the outstanding loan balance is deducted from the participant's account and the loan collateral is held in a separate Loan Default Fund. The interest rate is based on prevailing market conditions and may be fixed or variable over the life of the loan.

At January 31, 2023 (Date of Transfer) and June 30, 2022, outstanding plan loans were \$81,537 and \$87,984, respectively. These loans are collateralized by account balances of \$89,691 and \$96,782 as of January 31, 2023 (Date of Transfer) and June 30, 2022, respectively. As of January 31, 2023 (Date of Transfer) and June 30, 2022, the Loan Default Fund totaled \$74,554 and \$72,755, respectively.

Benefit Payments

Upon termination of service due to death, disability, or severance of employment or attaining the age of 59½, a participant may elect to receive either a lump sum amount, installments, or an annuity equal to the value of the participant's vested interest in his or her account.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments generally are reported at fair value, but may also be reported at contract value or net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5 for further discussion of fair value measurements, contract value and NAV. The Board determines the Plan's valuation policies utilizing information provided by the insurance companies.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of January 31, 2023 (Date of Transfer) or June 30, 2022.

Payment of Benefits

Distributions to participants are recorded when paid.

Young Harris College Retirement Plan Notes to Financial Statements

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Investment related expenses are included in net depreciation of fair value of investments.

Participants have the option to enroll in investment advisory agreements through the Plan; in this case, investment advisory fees are charged directly to the participant's account and are included in administrative expenses on the statement of changes in net assets available for benefits. During the period July 1, 2022 through January 31, 2023 (Date of Transfer), these fees of \$1,933 were paid by the Plan and charged to the participant's account.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, November 15, 2023, and determined there were no events that occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

Note 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTIONS

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by the Qualified Institutions:

- a) Total investments, at fair value and contract value, included in the statements of net assets available for benefits at January 31, 2023 (Date of Transfer) and June 30, 2022.
- b) Notes receivable from participants, included in the statements of net assets available for benefits at January 31, 2023 (Date of Transfer) and June 30, 2022.
- c) Investment income and interest income on notes receivable from participants included in the statement of changes in net assets available for benefits for the period July 1, 2022 through January 31, 2023 (Date of Transfer).
- d) All amounts included in Note 4, *Fair Value Measurements*.
- e) All amounts included in Note 5, *Investments Reported at Contract Value*.

Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 31, 2023 (Date of Transfer) and June 30, 2022.

Fixed annuity contracts (non-benefit responsive): These fixed annuity contracts are not actively traded, and significant other observable inputs are not available. Therefore, the fair value of the fixed annuity contracts is determined using an income approach by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. These contracts have liquidity restrictions and are non-benefit responsive.

Variable annuity contracts: Valued at the NAV of units held by the Plan at period end based on the fair value of the underlying investments. NAV is a readily determinable fair value which is published daily and is the basis for current transactions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

Changes in Fair Value of Level 3 Assets

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

We evaluate the significance of transfers between levels based upon the nature of the financial instruments and size of the transfer relative to total net assets available for benefits.

Note 5: INVESTMENTS REPORTED AT CONTRACT VALUE

The Plan invests in a fully benefit-responsive guaranteed investment contract with TIAA: TIAA Traditional account – Benefit Responsive. TIAA maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The contract value and crediting interest rates of the guaranteed investment contract as of June 30, 2022, is as follows:

There are no other restrictions that affect the ability of the Plan to transact at contract value.

TIAA is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan.

The crediting rate is based on a formula established by the contract issuer but may not be less than the percentages disclosed in the table above. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 6: TAX STATUS

The Plan has adopted a volume submitter plan sponsored by TIAA. The Internal Revenue Service issued an opinion letter, dated August 7, 2017, stating that the volume submitter plan document is designed in accordance with applicable sections of the IRC. Although the volume submitter plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

Tax positions are recognized only if it is "more likely than not" that the tax position be sustained in a tax examination, with a tax examination being presumed to occur. The amount recognized is the largest amount that is greater than 50% likely of being realized on examination. For tax positions not meeting the "more likely than not" test, no tax position is recorded. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by TIAA and CREF. TIAA and CREF are the trustees and record-keepers for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Note 8: PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. See Note 1.
