Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements

We have performed an audit of the financial statements of the HVAC Investigators, LLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements (2022 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

As discussed in Note 3 to the financial statements, the Plan Sponsor approved the merger of the Plan into the Donan Engineering Co., 401(k) Plan and Trust. The effective date of the merger was December 31, 2022 and the transfer of assets occurred on December 30, 2022. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2022 Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements* section of our report, our objectives are to obtain reasonable assurance about whether the 2022 financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Notes to Financial Statements

1. Description of the Plan

The following description of the HVAC Investigators, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the comprehensive Plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan originally effective January 1, 2012 adopted by HVAC Investigators, LLC (the Company, or Employer). The Plan was subject to the Employee Retirement Income Security Act of 1974, as amended (ERISA). Alpine Intel, LLC is the ultimate parent company of the Employer.

Trustee and Administration of the Plan

The trustee and recordkeeper of the Plan was Principal Trust Company (Principal or trustee). The administrator of the Plan was the Company. The trustee held all assets of the Plan in accordance with the service provider contract with the Company. The Investment Committee determined the appropriateness of the Plan's investment offerings and monitored investment performance.

Eligibility

Employees were eligible to participate in the Plan on the later of their date of employment or upon turning 21 years of age and completing six months of service. The Plan excluded leased employees, nonresident aliens and employees covered by a collective bargaining agreement. Participants were eligible for the profit-sharing contribution if they met the eligibility requirements above and were employed on the last day of the Plan year.

Contributions

The Plan included a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants were permitted to elect to have a percentage, limited by Plan provisions, of their eligible compensation contributed as pre-tax 401(k) or Roth contributions to the Plan. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions.

The Company could, at its discretion, elect to make a matching contribution to the Plan. For the year ended December 31, 2022, the Company's matching contribution was 100% of the first 3% of eligible compensation deferred that a participant contributed to the Plan, plus 50% of elective deferral contributions which are over 3% but not over 5% of eligible compensation.

The Company could, at its discretion, elect to make a profit-sharing contribution to the Plan. There were no Company profit-sharing contributions for the year ended December 31, 2022.

Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants directed the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account was credited with the participant's contributions, the Company's matching contribution, an allocation of the Company's profit-sharing contribution, and an allocation of Plan earnings or losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the vested portion of their account.

Vesting

Participants were immediately vested in their contributions and the Company's matching contribution plus actual earnings thereon. Vesting in the Company profit sharing portion of their accounts, plus actual earnings thereon, was based on years of credited service. A participant was 100% vested after six years of credited service. Notwithstanding the above, a participant was fully vested upon reaching normal retirement age, death, or permanent disability.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant elected to receive the value of the vested interest in his or her account in the form of a lump sum distribution or installments. The Plan allowed for in-service distributions if a participant reached age 59½ and hardship distributions subject to Plan provisions. If a participant terminated employment and the participant's account balance did not exceed \$1,000, the Plan administrator would have authorized the benefit payment without the participant's consent. If the balance of the terminated participant's account was between \$1,000 and \$5,000, the Employer may have authorized that the benefit payment be rolled into an individual retirement account in the participant's name.

Forfeitures

Forfeited nonvested accounts were first used to reduce administrative expenses and then were used to reduce future Employer contributions. Forfeited nonvested accounts as of December 31, 2022 and 2021 totaled \$0. There were no forfeitures used to pay administrative expenses or reduce Employer contributions for the year ended December 31, 2022.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments were reported at fair value (except for fully benefit-responsive investment contracts, which were reported at contract value - see Note 6). Fair value is the price that is received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determined the Plan's valuation policies utilizing information provided by the investment advisers, trustees, and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation or depreciation included the Plan's gains or losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Payment of Benefits

Benefits were recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were included in net depreciation in fair value of investments.

3. Transfer Out to Other Qualified Plan

Effective December 31, 2022, the Plan transferred the assets out to a related plan sponsored by Alpine Intel, LLC. The amount transferred out to the Donan Engineering Co., Inc. 401(k) Plan & Trust (d/b/a Alpine Intel 401(k) Plan) was \$3,908,518. The funds were transferred out on December 30, 2022 and received by the Alpine Intel 401(k) Plan on January 3, 2023.

4. Certified Investment Information

Certain information related to investments disclosed in the accompanying financial statements, including investments at December 31, 2022 and 2021, and net depreciation in fair value of investments, and interest and dividend income for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal (and its affiliates), a qualified institution.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

5. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of my input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There is not a fair value hierarchy table as of December 31, 2022 since the investments of the Plan were transferred out on December 30, 2022, as more fully described in Note 3. The following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2021:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Collective Funds: Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and was the basis for current transactions. Participant transactions (purchases and sales) occurred daily.

Pooled Separate Accounts: Valued at the net asset value of units as determined by the insurance company. NAV is a readily determinable fair value and was the basis for current transactions.

The preceding method described above may have produced a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

The following table sets forth by level within the fair value hierarchy the Plan's investments measured at fair value on a recurring basis:

6. Group Annuity Contract with Insurance Company

The Plan had a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company. Principal Life Insurance Company maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but may not be less than 0% or the actual interest floor. The crediting rate was reviewed on a quarterly basis for resetting. The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could have been affected by future economic and regulatory developments.

Certain events could have limited the ability of the Plan to transact at contract value with the issuer. Such events included (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Employer or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. As more fully described in Note 3, the Plan merged with a related plan on December 30, 2022. As a result of the merger, there was no material impact to the contract value of the fund.

In addition, certain events allowed the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events included (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

7. Risks and Uncertainties

The Plan invested in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities would have occurred in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

8. Tax Status

The Plan used a pre-approved plan document sponsored by Principal Life Insurance Company. Principal Life Insurance Company received an opinion letter from the IRS dated June 30, 2020, which stated that the pre-approved plan document, as then designed, satisfied the applicable provisions of the IRC. The Plan itself had not received a determination letter from the IRS and had since been amended. However, the Plan's management believed that the Plan was currently designed and operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

9. Related Party and Party-in-Interest Transactions

Certain Plan investments were in funds and accounts that were managed by Principal or its subsidiaries and affiliates. Participant distribution processing fees were paid to Principal by participants. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions were party-in-interest transactions, which are exempt from prohibited transaction rules.

10. Subsequent Events

The Plan has evaluated subsequent events through November 10, 2023, the date the financial statements were available to be issued.



HVAC Investigators, LLC 401(k) Profit Sharing Plan is timely filing its Federal Form 5500 utilizing a valid extension on Form 5558 for the plan year ended December 31, 2022. However, the independent auditor has not been able to complete the necessary audit work in order to issue its audit report for the year. The independent auditor is currently working with the Plan Administrator and service providers to obtain the information necessary to issue its audit report. HVAC Investigators, LLC 401(k) Profit Sharing Plan expects to have the audit report within the next 30 days and HVAC Investigators, LLC 401(k) Profit Sharing Plan will file an amended Form 5500, with the audited financial statements attached, as soon as the report is issued.
