Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Atlanta Athletic Club 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 31, 2023 and December 31, 2022 and the related statement of changes in net assets available for benefits for the period ended May 31, 2023 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of May 31, 2023 and December 31, 2022, and for the period ended May 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Description of the Plan:

The following description of the Atlanta Athletic Club 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan sponsor is the Atlanta Athletic Club (the Club, Plan Administrator). Effective May 31, 2023, the Plan was terminated and all remaining assets were transferred to Pooled Employer Plan arrangement. The Plan was a defined contribution plan covering substantially all employees of the Club who had completed one year of eligible service as defined in the Plan document and were age 21 or older. Upon attaining the eligibility requirements of the Plan, participants were allowed to enter the Plan on the first day of the month following the day on which the eligibility requirements are met. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Investment Committee determined the appropriateness of the Plan's investment offerings and monitored investment performance.

Contributions

Each year participants could contribute up to 100% of annual compensation, as defined by the Plan, subject to the annual limits set under the Internal Revenue Code (IRC). Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Effective January 1, 2016, the Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 6% of eligible compensation, with annual increases of 1% up to a maximum of 10%, and their contributions invested in a designated default investment fund until changed by the participant. The Club made safe harbor contributions and could make discretionary matching contributions and other discretionary contributions determined annually. During the period ended May 31, 2023, the Club made safe harbor contributions for all eligible participants equal to 4% of the participant's compensation for a total of \$147,000. There were no discretionary matching or other discretionary contributions made in 2023. Participants directed the investment of their contributions into various investment options offered by the Plan.

Note 1 - Description of the Plan - continued:

Participant accounts

Each participant's account was credited with the participant's contributions, an allocation of the Club's contributions and Plan earnings and was charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the vested portion of the participant's account.

Vesting and forfeitures

Participants were immediately vested in their voluntary contributions and any safe harbor contributions plus actual earnings thereon. Vesting in the Club's discretionary matching and other discretionary contributions and earnings thereon was based on years of service. The participant was 25% vested upon the completion of one year of service, 50% vested upon the completion of two years of service, and 100% vested upon the completion of three years of service. Participants were also immediately vested upon reaching normal retirement age, upon reaching early retirement age of 55 with 3 years of service, or upon death or disability while still employed by the Club. Forfeitures of terminated participants' non-vested accounts were used to pay administrative expenses or reduce Club contributions. No forfeitures were used during 2023 to reduce Club contributions and no forfeitures were used to pay administrative expenses. At May 31, 2023 and December 31, 2022, forfeited non-vested accounts in the Plan totaled \$0.

Notes receivable from participants

Participants could borrow from the Plan in any amount greater than \$1,000 up to 50% of the participant's vested account balance, not to exceed \$50,000. Note terms were for a period not exceeding five years unless for the purchase of a principal residence, in which case the note repayment period could not extend beyond 30 years. Notes were secured by the balance in the participant's account and bore interest at an agreed-upon percentage based on prevailing market rates. Principal and interest was paid ratably through payroll deductions. Participants were allowed one outstanding note receivable.

Note 1 - Description of the Plan - continued:

Payment of benefits

On termination of service, the participant would receive the value of his or her account in a lump sum. Payments that represent vested benefits less than \$1,000 would be paid in a lump sum on the first Plan distribution date. The timing of payments that represent benefits greater than or equal to \$1,000 would be paid based on the participant's election. In-service distributions for participants age 59½ or older and hardship withdrawals could be made from the Plan in accordance with provisions specified in the Plan document.

Administrative expenses

Certain expenses of maintaining the Plan were paid directly by the Plan Administrator and were excluded from these financial statements. The Club reserved the right to elect to pay, or have the Plan pay, administrative costs in the future. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation in fair value of investments.

Note 2 - Summary of significant accounting policies:

Basis of accounting

The financial statements of the Plan were prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Common/collective trust fund

Investments in the common/collective trust fund were required to be reported at fair value. The common/collective trust fund was composed primarily of fully benefit-responsive investment contracts held by the fund. These contracts were not considered fully benefit-responsive to the Plan as the underlying contracts were not direct investments between the Plan and the issuer. The statements of net assets available for benefits present the fair value of the investment in the common/collective trust fund. The statement of changes in net assets available for benefits was also prepared on the fair value basis.

Note 2 - Summary of significant accounting policies - continued:

Investment valuation and income recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determined the Plan's valuation policies utilizing information provided by the investment advisors and Principal Life Insurance Company (Principal).

Purchases and sales of investments were recorded on a trade-date basis. Interest income was accrued when earned. Dividend income was recorded on the ex-dividend date.

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make certain estimates and assumptions. These estimates and assumptions affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they are incurred. No allowance for credit losses were recorded as of May 31, 2023 or December 31, 2022. If a participant ceased to make note repayments and the Plan Administrator deemed the participant note to be in default, the participant note balance was reduced and a benefit payment was recorded.

Payment of benefits

Benefits were recorded when paid.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

For all pooled separate accounts, refer to the specific fund's prospectus and annual report for a full description of each fund's investment holdings and significant concentrations of credit risk. The pooled separate accounts prospectus and annual reports can be obtained by contacting Principal.

Recent legislative developments

In December 2019, Congress passed the SECURE Act which included numerous reforms to existing retirement law and allows plan sponsors to make certain immediate plan operational changes without formal amendment of the plan document. If adopted, plan documents are required to be formally amended in accordance with IRS guidelines.

In March 2020, Congress passed the CARES Act which included optional immediate changes to distribution and loan provisions without formal amendment of the plan document. If adopted, plan documents are required to be formally amended in accordance with IRS guidelines.

The Plan Administrator operationally implemented various changes and timely amended the Plan for these changes.

Subsequent events

The Plan has evaluated subsequent events through November 8, 2023, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of May 31, 2023, have been incorporated into these financial statements.

Note 3 - Information certified by Principal:

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.130-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Principal held the Plan's investment assets and executed all investment transactions. Management has determined that Principal is a qualified institution and the information prepared and certified by Principal meets the requirements of ERISA Section 103(a)(3)(C). Certain information disclosed in the accompanying financial statements, including investments and notes receivable from participants held at May 31, 2023 and December 31, 2022, and net appreciation in fair value of investments and interest income on notes receivable from participants for the period ended May 31, 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Principal.

Note 4 - Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

- Units of participation in pooled separate accounts are valued at the NAV provided by the fund's trustee as a practical expedient to estimate fair value. The NAV is based on the quoted market prices of the underlying investments held in the pooled separate accounts at year end.
- Units of participation in the common/collective trust fund is valued based on the value of the underlying investments in the fund. The fund invests in conventional and synthetic investment contracts, cash equivalents and wrap contracts. The fair value of conventional investment contracts is determined using a discounted cash flow methodology where the individual contract cash flows are discounted at the prevailing interpolated yield curve rate as of year end. Individual assets of the synthetic investment contracts are valued as follows: domestic and foreign fixed income securities, futures and options are valued at fair value based on market values obtained from independent pricing services, quotes by dealers who are market makers in these securities, or by a methodology approved by Principal; commercial paper and other investment securities with less than 60 days to maturity when purchased are valued at amortized costs, which approximates fair value; and investments in regulated investment companies or collective investment trusts are valued at the NAV per share/unit at the valuation date. Cash equivalents include money market instruments; the NAV of the instrument represents the price at which the fund believes it would be able to initiate a transaction. The fair value of the wrap contracts is determined using the market approach discounting methodology which incorporates the difference between current market level rates for contract level wrap fees and the wrap fees being charged.

Note 4 - Fair value measurements - continued:

- Mutual funds are valued by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Related party transactions:

Certain Plan investments were shares of pooled separate accounts and a common/collective trust fund managed by Principal. Principal held all Plan investments and executed investment transactions, and therefore, these transactions qualified as party-in-interest transactions under ERISA and were specifically exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services were included in net appreciation.

Note 6 - Plan termination:

The Club has the right under the Plan, although it has not expressed any intent to do so, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, all participants' accounts would become 100% vested.

Effective May 31, 2023, the Club decided to merge the Plan out of existence into a Pooled Employer Plan on June 1, 2023.

Note 7 - Tax status:

The underlying non-standardized pre-approved profit sharing plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the IRC and; therefore, the related trust is tax-exempt. The Plan Administrator has determined that it is eligible to, and has chosen to, rely on the current IRS pre-approved plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
