We have performed audits of the financial statements of Tripp Lite 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### Note 1 - Plan Description

The following description of Tripp Lite 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of Trippe Manufacturing Co. and Tri-Lite, Inc. (collectively, the "Company") who have completed three months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On January 29, 2021, the Company was purchased by Eaton Corporation. Effective January 1, 2022, employees of the Company began participating in the Eaton Savings Plan. As a result, no employee or employer contributions were made to the Plan subsequent to January 1, 2022. Effective June 1, 2022, the Plan was merged into the Eaton Savings Plan.

#### **Contributions**

The Plan provided for employee 401(k) deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants who attained age 50 before the end of the plan year were eligible to make catch-up contributions. Employees were automatically enrolled in the Plan at a 3 percent pretax contribution rate unless they elected otherwise. Participants could designate all or a portion of their contributions as Roth deferral contributions. Participants could also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provided for discretionary employer matching contributions. Such contributions were made to those participants who worked over 500 hours during the year to the extent of 100 percent of the first \$375 contributed by each participant who was employed on the last day of the year. The Company could also make additional discretionary contributions.

#### **Participant Accounts**

Each participant's account was credited with the participant's contributions and allocations of the Company's contributions, plan earnings, and forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations were based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants could direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants were immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Participants became 100 percent vested in the employer discretionary matching contributions after three years of credited service. Participants vested in employer additional discretionary contributions 20 percent after two years of service and another 20 percent per year thereafter until they became fully vested after six years of service. Participants also became fully vested upon normal retirement, death, or disability.

#### **Benefit Payments**

Distributions were payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account.

Participants could request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The Company must approve any such hardship withdrawals.

**Note 1 - Plan Description (Continued)**

***Forfeitures***

If a participant was not fully vested on his or her termination date, the nonvested amount of the account was forfeited. Forfeitures may be used to reduce employer contributions, pay administrative expenses, or be allocated to the remaining eligible participants. At June 1, 2022 and December 31, 2021, forfeited account balances totaled \$0 and \$35,180, respectively. Forfeitures could be used to reduce future employer contributions or pay plan administrative expenses.

***Participant Notes Receivable***

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable were secured by the balance in the participant's account and bore interest at a rate of prime plus 1 percent. Principal and interest were paid ratably through monthly payroll deductions.

***Party-in-interest Transactions***

Certain plan assets were managed by Empower Annuity Insurance Company of America (Empower), formerly Great-West Life & Annuity Insurance Company, or its affiliates. The Plan had investments in certain annuity contracts that were managed by Voya and New York Life Insurance Company (New York Life). Empower, Voya, and New York Life are the service providers of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

The fully benefit-responsive unallocated contract is valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are paid by the Company.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including November 7, 2023, which is the date the financial statements were available to be issued.

**Note 3 - Plan Merger**

Effective June 1, 2022, the Plan merged and combined with the Eaton Savings Plan. Accordingly, all assets, participants, and their related account balances were transferred to the Eaton Savings Plan on June 1, 2022.

**Note 4 - Certified Information**

Empower Annuity Insurance Company of America, formerly Great-West Life & Annuity Insurance Company, and Empower Trust Company, LLC, formerly Great-West Trust Company, LLC, (collectively, the "Custodians") held the majority of the Plan's investments and participant notes receivable and executed all related transactions. The majority of the investment and participant notes receivable balances and related income and losses included in the accompanying financial statements are based solely on information certified by the Custodians.

The Plan's investments in the fixed annuity life insurance contracts totaling \$0 and \$504,674 at June 1, 2022 and December 31, 2021, respectively, were not certified by the Custodians mentioned in the previous paragraph.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Note 5 - Fair Value Measurements (Continued)**

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management’s own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

**Mutual Funds**

Mutual funds are valued at quoted prices reported in active markets.

**Unallocated Fixed Annuity Contracts**

The unallocated fixed annuity contracts are not considered benefit responsive and are presented at fair value. The contracts invest in the general assets of Voya and New York Life Insurance Company; however, since there are no specific securities related to these contracts and due to the contract terms, including the frequency of the interest rate reset intervals, contract value approximates fair value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

**Note 6 - Tax Status**

The Plan was a prototype plan. The prototype plan received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, was qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 7 - Investment Contracts**

The Plan had a benefit-responsive investment contract with Empower. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a quarterly basis for resetting but may not be less than 2 percent. The interest crediting rate is based on a formula agreed upon with the issuer.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (iii) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is not probable. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time. This contract was transferred to the Eaton Savings Plan at contract value on June 1, 2022.
