Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Capital Communications Federal Credit Union Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 31, 2023, December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the period from January 1, 2023 through January 31, 2023 and for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of January 31, 2023, December 31, 2022 and 2021, and for the period from January 1, 2023 through January 31, 2023 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year from the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Capital Communications Federal Credit Union Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering all full-time employees of Capital Communications Federal Credit Union and subsidiaries (the “Company”) who have three months of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan. The Retirement Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s Board of Directors.

Effective August 1, 2022, the Company merged with and into SEFCU, a credit union headquartered in Albany, New York. As of the merger date, the Company and SEFCU are operating as divisions of Broadview Federal Credit Union (“Plan Sponsor”).

Effective January 31, 2023, the Plan merged its entire balance of net assets available for benefits of \$72,675,127 into the Broadview Retirement Savings Plan.

Contributions: Each year, participants may contribute up to 100% of pretax annual compensation, and after-tax Roth contributions, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make “catch-up” contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of contributions into various investment options offered by the Plan.

The Plan automatically enrolls newly eligible employees for salary deferral under its automatic enrollment feature. This automatic enrollment is at a 6% deferral rate of an eligible employee’s compensation that is contributed to the Plan as pre-tax contributions unless the employee elects not to make an elective deferral or elects to make changes in contribution percentages. Automatically enrolled participants pre-tax deferral rates are automatically increased by 1% annually on October 1st. This automatic escalation increases annually until the participant’s pre-tax deferral rate reaches 10%. Participants can elect to change the pre-tax deferral rate or opt out of automatic increases at any time.

The Plan includes a safe harbor provision which requires the Company to contribute 3% of eligible compensation to the Plan. In addition, the Company may also make a discretionary matching contribution and a discretionary profit sharing contribution to the Plan. For the year ended December 31, 2022, the Company made a discretionary matching contribution of 50% of the first 6% of eligible compensation that a participant contributed to the Plan. For the year ended December 31, 2022, the Company also made a discretionary profit sharing contribution of 3% of eligible compensation.

Effective December 31, 2022, the Plan was closed to new participation and all Elective Deferral Contributions, Discretionary Contributions, Matching Contributions and Qualified Nonelective Contributions to the Plan have ceased. Effective January 1, 2023, participants of the Plan became eligible to contribute to the Broadview Retirement Savings Plan.

Participant Accounts: Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contributions and, (b) Plan earnings, and is charged with an allocation of administrative expenses, Plan losses and his or her withdrawals. Allocations are based on participant’s earnings on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are immediately vested in their contributions and safe harbor contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contribution portions of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are limited to having two outstanding loans. The loans are secured by the balance in the participant's account and bear interest at prime lending rate as published in the Wall Street Journal at the time the loan is taken. The interest rates are commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits: On termination of service due to death, disability or retirement, a participant may elect to receive the value of the participant's vested interest in his or her account either in a lump-sum amount, or in an installment form of payment. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Active participants may also take distributions from the Plan in the event of a hardship or upon attainment of age 59 ½. All optional annuity and installment forms of distributions were eliminated effective as of the commencement of the blackout period on January 23, 2023 for the merger of the Plan with and into the Broadview Retirement Savings Plan.

Forfeitures: Forfeited non-vested accounts are used to reduce future Company contributions. During the period from January 1, 2023 through January 31, 2023, no forfeitures were used to reduce Company Contributions and the remaining forfeiture account balance was transferred to the Broadview Retirement Savings Plan. During the year ended December 31, 2022, \$124,709 of forfeited accounts were used to reduce Company Contributions. Forfeiture account balances were \$0, \$7,387 and \$539 at January 31, 2023, December 31, 2022 and 2021, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are carried at fair value, other than the fully benefit responsive investment contract, which is carried at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance has been recorded for credit losses as of January 31, 2023 or December 31, 2022.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Administrative expenses for the Plan were paid by either the Plan or the Company for the period from January 1, 2023 through January 31, 2023 and year ended December 31, 2022.

Subsequent Events: The Plan has evaluated subsequent events through November 17, 2023, the date the financial statements were available to be issued.

NOTE 3 – CERTIFIED INFORMATION – INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2022 and 2021, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2023 through January 31, 2023 and for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (“Principal Trust Company”), the trustee of the Plan.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

Level 1 – Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 – Quoted prices for similar assets or liabilities in active markets, quoted prices in markets that are not active, or inputs that are observable, either directly or indirectly, for substantially the full term of the asset or liability;

Level 3 – Prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable (i.e., supported by little or no market activity).

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021. There were no assets held as of January 31, 2023.

Mutual Funds: Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trusts: Valued at the NAV which is the price at which the Plan would be able to initiate a transaction. The NAV is based on the fair value of the underlying investments held by the funds less their liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There are currently no redemption restrictions on these investments.

Pooled Separate Accounts: The NAV of each of the pooled separate accounts is determinative of their fair value and represents the price at which the Plan would be able to initiate a transaction. The pooled separate accounts generally invest in actively managed stocks. The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. There are currently no redemption restrictions on these investments.

The methods described above may produce a fair value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no assets held as of January 31, 2023. The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value:

Guaranteed Investment Contract with National Insurance Company: The guaranteed investment contract (“Principal Fixed Income Guarantee Option”) is a benefit responsive group annuity contract issued by Principal Life Insurance Company. Because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported by Principal Life Insurance Company, represents contributions, plus earnings, less withdrawals. Principal Life Insurance Company guarantees the Plan a return of principal and interest under the terms of the guaranteed investment contract. The interest-crediting rate is updated semi-annually, based upon contract provisions.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the ability of the Plan to transact at contract value with Principal Life Insurance Company. Such events include but may not be limited to: transfers by participants or the Company to one or more competing Plan investment options, all such transfers involving a competing Plan investment option will be subject to an equity wash; transfers by the Company in excess of 10% of the accumulated Company’s transfer percentage as of the date of the transfer will be subject to a surrender charge; and termination of the Plan’s interest without providing sufficient notice and without meeting the minimum cumulative transfer percentage will be subject to a surrender charge. The Plan administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring. Participant initiated events are ordinarily treated at contract value.

Effective January 31, 2023, the guaranteed investment contract was terminated and liquidated, however, this did not limit the Plan’s ability to transact at contract value prior to or at liquidation date.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties in interest are defined under the Department of Labor’s regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Certain administrative expenses of the Plan are paid directly by the Company. Any direct or indirect expenses paid for by the Plan are considered party-in-interest transactions.

For 2023, 2022 and 2021, certain Plan investments are shares of mutual funds managed by Principal Funds, Inc., shares of collective trusts managed by Principal Global Investors Trust Company, and shares of pooled separate accounts and an investment contract with Principal Life Insurance Company. Principal Funds, Inc., Principal Global Investors Trust Company, Principal Life Insurance Company, and Principal Trust Company, the trustee of Plan, are members of the Principal Financial Group. Therefore, these transactions qualify as party-in-interest transactions.

Notes receivable from participants also qualify as party-in-interest transactions.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 – TAX STATUS

The Company has adopted a Non-Standardized Pre-Approved Profit Sharing Plan. The IRS issued on June 30, 2020, an opinion letter which stated that the Non-Standardized Pre-Approved Profit Sharing Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself. Although the Plan has been amended since the opinion letter was received, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 31, 2023, December 31, 2022 and 2021, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2019.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are subject to exposure to various risks such as interest rate risk, financial market risk, liquidity risk and credit risk. Due to the level of risk associated with investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

In my role as Plan Sponsor and Administrator and former executive Vice President and Chief Financial Officer of Capital communications federal Credit union, I am bringing to your attention the reason for the late filing of the Form 5500 accompanied by the Accountant's Opinion for Capital Communications Federal Credit Union Retirement Plan (the "Plan") for the reporting period ending January 31, 2023. It is my hope that the following explanation will be accepted as reasonably explain the late filing.

The Plan was merged into the Broadview Federal Credit Union plan as of January 31, 2023, at which time the plan assets were transferred to the administrator of the Broadview plan. When issuing the financial report along with the Accountant's Opinion produced by Crowe LLP, an erroneous supplemental schedule was included in the report that required significant investigation. It was determined that a singular report issued by Principal Financial was the cause of the error. Thus the Accountant's Opinion as well as the supplemental schedules had to be modified as well as the Form 5500. Had Principal Financial not erred in their reporting, the Accountant's Opinion as well as the Form 5500 would have been filed timely.

It is my hope that this explanation will reasonably explain the reason for the tardiness of the filing by two (2) days and thus result in the late penalty fee being waived. The Plan is now merged with and into Broadview's plan resulting in this return being the final Form 5500 filed for the CAP COM Plan.
