INDEPENDENT AUDITOR'S REPORT

To the Management of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of TBI, Inc. 401(k) Plan, (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) [“ERISA Section 103(a)(3)(C) audit”]. The financial statements comprise the statements of net assets in liquidation available for benefits as of May 3, 2023, December 31, 2022 and 2021, and the related statements of changes in net assets in liquidation available for benefits for the period ended May 3, 2023 and the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from qualified institutions as of May 3, 2023, December 31, 2022 and 2021 and for the period ended May 3, 2023 and the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN

The following description of the TBI, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions. The Plan was terminated effective May 3, 2023.

General. The Plan is a defined contribution plan covering all full-time employees of TBI, Inc. (the “Company” or “Employer”), who are at least 21 years old and have six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The assets of the Plan were managed and administered under the terms of an agreement between the Plan and Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (the “Trustees”). The Trustees were responsible for the investment of such assets and the accounting for all related receipts and disbursements.

Contributions. The Plan was funded through participant contributions, as well as Employer matching contributions. Participants were able to contribute a percentage or fixed amount of their pre-tax compensation and/or a percentage or fixed amount of their post-tax compensation as defined in the Plan, subject to Internal Revenue Service (“IRS”) limits. The Plan also provided for a traditional safe harbor matching contribution in which 100% on the first 3% of participant compensation that is deferred as an elective deferral is matched and then 50% on the next 2%.

The Plan accepted rollovers and transfers in accordance with certain rules. Rollover contributions consisted of transfers from other qualified plans which participants have elected to include with the Plan.

Participant Accounts. Each participant’s account was credited with the participant’s elective deferral and allocation of the Employer contributions, if any. Plan earnings or losses and administrative fees were allocated to participant accounts based on their proportionate share of identified fund balances and other Plan assets.

Investment Options. Participants could direct their contributions among one or more funds subject to the allocation limitations set forth in the Plan.

Vesting. Participants were immediately vested in their contributions plus actual earnings thereon. Participants were also immediately vested in all Employer contributions as the Plan is a safe harbor plan.

Notes Receivable from Participants. Participants could borrow from their vested account balance a minimum of \$500 up to a maximum of \$50,000 or 50% of their vested balance, whichever was less. Loan terms shall not exceed five years unless used to purchase a primary residence. Payments are to be made not less frequently than quarterly. A loan was secured by the balance in the participant’s account and bore interest at the Wall Street Journal Prime Rate plus 2.00%.

Payments of Benefits. Benefit payments were generally made in lump sum upon termination, death, retirement, or resignation. The Plan permitted hardship withdrawals and in-service distributions if certain criteria were met.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The accompanying financial statements have been prepared on the liquidation basis of accounting. The accompanying statements of changes in net assets in liquidation are presented for the period from January 1, 2023 through May 3, 2023 (the “period ended May 3, 2023”) and the year ended December 31, 2022.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates. Future events and their effects cannot be predicted with certainty; accordingly, accounting estimates require the exercise of judgment. Accounting estimates used in the preparation of these financial statements change as new events occur, as more experience is acquired, as additional information is obtained, and as the operating environment changes.

Concentration of Credit Risk. Substantially all of the Plan’s investments were held by the Trustees. The Trustees are qualified institutions pursuant to ERISA.

Investment Valuation and Income Recognition. Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between willing market participants as of the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan’s gains and losses on investments bought and sold (realized), as well as held during the period presented (unrealized).

Notes Receivable from Participants. Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits. Benefits were recorded when paid.

Party-In-Interest Transactions. Substantially all administrative expenses pertaining to the operation of the Plan are paid by the Company. Additionally, various administrative, legal, and accounting services are performed by Company personnel on behalf of the Plan for which no charges are made to the Plan, and for which the Company does not intend to obtain reimbursement. Investment expenses, however, are charged against the Plan’s investment income. Therefore, these transactions qualify as party-in-interest transactions.

Reclassifications. Certain amounts in the 2021 financial statements have been reclassified to conform with the 2022 presentation.

NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEES

The following is a summary of the unaudited information regarding the Plan, included in the Plan’s financial statements and supplemental schedules that were prepared by the Trustees of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the Trustees that such information is complete and accurate:

- Investments as shown in the statements of net assets in liquidation available for benefits as of May 3, 2023, and December 31, 2022 and 2021.
- Investment income (loss) as shown in the statements of changes in net assets in liquidation available for benefits for the period ended May 3, 2023 and the year ended December 31, 2022.
- Note 4: All investment balances.
- Investments in the schedule of assets held for investment purposes at end of year as of December 31, 2022, as shown on Form 5500, Schedule H, Part IV, Line 4i.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 4 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2022 and 2021.

Mutual Funds. Valued at closing price reported on the active market on which the mutual funds are traded.

Pooled Separate Account. The pooled separate account is valued at the net asset value per share (or its equivalent) of the funds, which is based on the fair value of the funds’ underlying assets.

Guaranteed Interest Option. The Guaranteed Interest Option (“GIO”) provides for a minimum guaranteed interest rate. However, the actual rate of interest credited during the time over which funds are invested in the GIO option is declared periodically and therefore is subject to change. Withdrawals for participant benefits from the GIO are permitted as specified in the contract and are not subject to any market value adjustment. The value in the GIO at any time will equal contributions and transfers to that option, plus interest, minus withdrawals and transfers out of the option and charges that are deducted.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – GUARANTEED INVESTMENT OPTION WITH INSURANCE COMPANY

The Plan held a traditional investment contract, Principal Fixed Income Guaranteed Option, which met the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

NOTE 5 – GUARANTEED INVESTMENT OPTION WITH INSURANCE COMPANY (Concluded)

The traditional investment contract held by the Plan was a guaranteed investment contract. The contract issuer was contractually obligated to repay the principal and interest at a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but could not be less than 1.00%. The crediting rate was reviewed on a quarterly basis for resetting. The contract could not be terminated before the scheduled maturity date.

NOTE 7 – PLAN TERMINATION

The Plan Sponsor terminated the Plan effective May 3, 2023 by transferring all of the Plan assets to the App Direct 401(k) Plan.

NOTE 8 – EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were shares of mutual funds managed by the Trustees. These transactions were allowable party-in-interest transactions under ERISA and the regulations promulgated thereunder.

NOTE 9 – DELINQUENT PARTICIPANT CONTRIBUTIONS

During the year ended December 31, 2022, the Company inadvertently failed to remit participant contributions totaling \$159,213 to the Plan timely. Delinquent participant contributions totaling \$435,069 were not corrected as of May 3, 2023 and December 31, 2022. The Company will use the self-correction program to remit lost earnings to the Plan and file Form 5330 with the IRS to pay applicable excise taxes, which will be paid from Company funds and not Plan assets.

The Plan as adopted is a prototype nonstandardized profit sharing plan. The sponsoring organization has received an opinion letter covering the prototype plan, dated June 30, 2020. A separate determination providing that the Plan, as adopted, and the related trust are designed in accordance with applicable sections of the Code has not been sought from the IRS. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 11 – RISKS AND UNCERTAINTIES

The Plan provides for various investment options in any combination of stocks, bonds, fixed income securities, registered investment companies and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the financial statements and supplementary schedules.

NOTE 12 – SUBSEQUENT EVENTS

Management has evaluated all known subsequent events from May 3, 2023 through October 9, 2023, the date the accompanying financial statements were available to be issued, and is not aware of any material subsequent events occurring during this period that have not been disclosed in the notes to the financial statements.
