Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed the audit of the financial statements of DS Services of America, Inc. Frozen Defined Benefit Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statement of net assets available for benefits as of June 30, 2023 (in liquidation) and December 31, 2022 (in liquidation), and the related statements of changes in net assets available for benefits for the period from January 1, 2023, through June 30, 2023 (in liquidation) and the year ended December 31, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of June 30, 2023, and December 31, 2022 and for the for the period January 1, 2023 through June 30, 2023 and the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Retirement Committee approved a plan liquidation on December 2, 2021, and management determined liquidation is imminent. In accordance with accounting principles generally accepted in the United States of America, the Plan has reported balances on the liquidation basis in the presenting the June 30, 2023 and December 31, 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Notes to Financial Statements

June 30, 2023 and December 31, 2022

(1) Description of Plan

The following description of the DS Services of America, Inc. Frozen Defined Benefit Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description and the plan document, for a more complete description of the Plan’s provisions.

Effective December 31, 2021, the Plan was terminated. The Plan was in process of liquidation as of December 31, 2022 and full liquidation was completed in May 2023.

(a) General

The Plan is a defined benefit plan covering employees of DS Services of America, Inc. (the “Company” or “Plan Sponsor”) who were either members of the Beverage Management, Inc. Hourly Rate Pension Plan on December 31, 1987 or the Hinckley & Schmitt, Inc. division of Suntory Water Group, Inc. Anjou Pension Plan on or after March 29, 1996. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) as amended.

(b) Pension Benefits

Effective January 31, 1997, the Plan was frozen and the accrued benefit of each participant of the Plan was frozen. No further employees will become active participants, no future accrual for service will be credited, and no further changes in compensation will be taken into account in the determination of a participant’s accrued benefit.

A participant’s monthly pension benefit is a product of the participant’s benefit multiplier and years of credited service, calculated through January 31, 1997 for the former Hinckley and Schmitt, Inc. division. For all other participants, the monthly retirement benefit is determined by multiplying a participants credited services after March 28, 1996 by the sum of (i) 0.6% of his average monthly compensation averaged over five years) up to covered compensation and (ii) 1.2% of his average monthly compensation in excess of his covered compensation below, to which (iii) the participant’s benefit amount accrued under the Anjou Pension Plan prior to March 29, 1996 will be added. The Plan permits early retirement between the ages of 55 and 64 after the completion of 10 years of service. Benefits are paid in the form of an annuity unless the present value of such benefit is \$5,000 or less. If the present value of the benefit is between \$1,000 and \$5,000, participants must make an election to receive a lump sum paid directly to them or rolled over to a qualified individual retirement account (“IRA”). If the present value of the benefit is less than \$1,000, the benefit is automatically paid in a lump sum to the participant. If a participant dies prior to their benefit commencement date but after completing five years of service, the Plan will pay a pre-retirement survivor annuity to the eligible spouse beginning no earlier than the earliest date on which the participant could have elected to begin receiving plan benefits. The monthly annuity will approximate 50% of the deceased participant’s accrued benefit as if the participant’s retirement had occurred on the day before his or her death and he or she had elected 50% joint and survivor annuity on such date.

(b) Pension Benefits - Continued

If a participant dies prior to their benefit commencement date but after completing five years of service, the Plan will pay a pre-retirement survivor annuity to the eligible spouse beginning no earlier than the earliest date on which the participant could have elected to begin receiving plan benefits. The monthly annuity will approximate 50% of the deceased participant's accrued benefit as if the participant's retirement had occurred on the day before his or her death and he or she had elected 50% joint and survivor annuity on such date.

(c) Vesting

Effective January 31, 1997, all participants were deemed 100% vested in their accrued benefit.

(d) Administration

The Company serves as the plan administrator, and overall responsibility for administering the Plan rests with the Company's Retirement Plan Administrative Committee. The plan administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, but are not limited to, establishing procedures, maintaining records, interpreting provisions of the Plan and making determinations regarding questions which may affect eligibility for benefits.

The plan administrator engaged John Hancock Trust Company, LLC ("John Hancock"), as a third-party administrator, to serve as Trustee of the Plan pursuant to the plan document. The Trustee receives all contributions made under the Plan, holds plan assets and pays benefits to participants as directed by the plan administrator.

The Plan Sponsor utilized the actuarial services of Sage View Consulting Group (actuarial services provider). The actuarial service provider assisted in calculating the actuarial present value of accumulated plan benefits and the amount of funding that the Plan will require from year to year and at final distribution upon termination.

(2) Summary of Accounting Policies

(a) Basis of Accounting

In accordance with accounting principles generally accepted in the United States of America ("US GAAP"), the Plan uses the liquidation basis of accounting used for financial reporting purposes and was used in presenting the June 30, 2023 and the December 31, 2022 financial statements.

(b) Use of Estimates in Financial Statements

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

(c) Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those estimated future periodic payments, including lump-sum distributions, which are attributable under the Plan for services rendered by participants through the valuation date. Accumulated plan benefits include benefits expected to be paid to retired or terminated employees or their beneficiaries, and present employees or their beneficiaries. Benefits for all plan participants are based on their credited service earned prior to the valuation date. Benefits payable under the following circumstances - retirement, death, disability and termination of employment - are included, to the extent they are deemed attributable to employee service rendered through the valuation date.

(d) Payment of Benefits

Benefit payments to participants or their beneficiaries are recorded upon distribution.

(e) Expenses

Administrative expenses of the Plan are primarily paid by the Plan. These expenses include, but are not limited to, investment expenses and certain recordkeeping fees.

(f) Risks and Uncertainties

The Plan's investment assets include a money market fund as of December 31, 2022. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the plan's investment balances and the amounts reported in the statements of net assets available for benefits.

(3) Information Certified by the Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock, the Plan's trustee, has certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate with respect to investments:

- Investments, at fair value
- Non-interest bearing cash
- Interest income
- Net depreciation in fair value of investments

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in these financial statements.

(4) Fair Value Measurements

Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurement*, provides a common definition of fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Observable inputs such as quoted prices in active markets;

Level 2: Inputs to the valuation methodology include:

- (a) quoted prices for similar assets or liabilities in active markets;
- (b) quoted prices for identical or similar assets or liabilities in inactive markets;
- (c) inputs other than quoted prices that are observable for the asset or liability;
- (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Fund is valued at quoted market prices in active markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Funding Policy

Prior to termination, the Company's funding policy for the Plan was to contribute such amounts as are necessary on an actuarial basis to provide the Plan with assets sufficient to meet the benefits to be paid to the plan participants at their retirement dates. This was accomplished by funding the Plan under the minimum funding standards for single employer defined benefit plans as described in Internal Revenue Service Code Section 430.

(6) Income Tax Status

In a letter dated November 29, 2022, the Plan obtained a favorable determination from the Internal Revenue Service subject to the adoption of certain proposed amendments identified in the letter requesting a determination related to the proposed termination date of December 31, 2021. These amendments were adopted in 2022 and prior. The Plan administrator believes that the Plan is currently designed and being operating in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Actuarial Present Value of Accumulated Plan Benefits

The actuarial present value of accumulated plan benefits was determined by Sage View Consulting Group at January 1, 2022. With the Plan termination effective December 31, 2021, the actuarial assumptions and other factors were applicable in determining the present value of accumulated plan benefits as of January 1, 2022 and January 1, 2023 which differed from prior years. During 2023, the plan benefits were settled in full in the amount of approximately \$7,400,000.

(8) Exempt Party-in-Interest Transactions

The Plan made direct payments to the third-party administrator of \$14,922 and \$28,549 for the period from January 1, 2023 through June 30, 2023 and the year ended December 31, 2022, respectively. The Plan made direct payments to Sageview Consulting Group and Sageview Advisory Group for actuarial services and investment advising services of \$36,682 and \$66,151 for the period from January 1, 2023 through June 30, 2023 and the year ended December 31, 2022, respectively. The Plan made direct payments to Mayer Hoffman McCann, P.C. for audit services of \$0 and \$18,112 for the period from January 1, 2023 through June 30, 2023 and the year ended December 31, 2022, respectively. The Plan made direct payments to Winston & Strawn LLP for assistance with the plan termination process of \$11,546 and \$36,854 for the period from January 1, 2023 through June 30, 2023 and the year ended December 31, 2022, respectively. These transactions qualify as party-in-interest transactions and are exempt from applicable prohibited transaction rules.

(9) Group Annuity Contract

The Plan finalized a nonparticipating single premium group annuity contract issued by Midland National Life Insurance Company (“Midland Life”) with a liability assumption date of April 21, 2023. Midland Life’s services under this contract include providing certain participants with their monthly annuity benefits. The contract remains in effect until the date no further annuity payments are payable under the contract. The amount paid to Midland Life for the provision of benefits and administrative services to annuitants covered under this contract was \$3,508,000.

(10) Subsequent Events

In preparing these financial statements, plan management has evaluated events and transactions for potential recognition or disclosure through November 13, 2023, the date the financial statements were available to be issued.
