Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Glynn Electric, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C), which comprise the statements of net assets available for benefits (in liquidation) as of July 7, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits (in liquidation) for the period from January 1, 2022 to July 7, 2022 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of July 7, 2022 and December 31, 2021, and for the period from January 1, 2022 to July 7, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP"); and
- The certified investment information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Plan sponsor’s Board of Directors approved the termination of the Plan effective December 30, 2021, and the Plan was liquidated as of July 7, 2022. Therefore, the financial statements are presented under the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal controls relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements* section of our report, our objective is to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Notes to Financial Statements

1. Description of Plan

The following description of the Glynn Electric, Inc. 401(k) Plan, (the “Plan”) provides only general information. Participants should refer to the plan document and summary plan description for a more complete description of the Plan’s provisions.

General

The Plan includes a 401(k) contribution plan and a supplemental discretionary contribution plan both covering substantially all employees of Glynn Electric, Inc. (the “Employer”). Employees are eligible to make elective contributions after three months of service following their employment and must be 18 years of age. Participants are required to have worked for three months during the year in addition to having been employed at the end of the plan year to be eligible for employer discretionary matching contributions, unless the employee is not employed due to death, total and permanent disability, or normal retirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Termination

Effective December 30, 2021, the Board of Directors of Glynn Electric, Inc. voted to terminate the Plan in conjunction with the sale of the Employer. The provisions of the termination of the Plan prohibited further participant entry into the Plan after the effective termination date and prohibited further participant deferrals and employer contributions into the Plan. All participants became fully vested in their account balances as of December 30, 2021.

During the period from January 1, 2022 to July 7, 2022, the Employer worked with the trustee and recordkeeper of the Plan to liquidate and distribute participant balances.

Contributions

Each year, eligible participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan, subject to Internal Revenue Service (“IRS”) limitations. Participants may also elect to defer Roth 401(k) contributions of up to 100% of after tax annual compensation, as defined by the Plan, subject to IRS limitations. Participants that have attained age 50 before the end of the plan year are eligible to make “catch-up contributions.” Participants may also contribute amounts representing rollover distributions from other qualified plans. The Plan includes an auto-enrollment feature whereby all eligible employees are automatically enrolled in the Plan with a set contribution rate of 6% as soon as the participant becomes eligible, unless the participant affirmatively elects to change or revoke such deferral contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Each year, the Employer may make discretionary matching contributions, discretionary profit-sharing contributions, or Qualified Non-Elective Contributions, as defined. There were no Employer discretionary matching contributions, qualified non-elective contributions or discretionary profit-sharing contributions during the period from January 1, 2022 to July 7, 2022.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and the allocations of (a) the Employer’s contribution, if any, (b) the Plan’s earnings, and (c) certain expenses. Allocations are based on participant deferrals or account balances, as defined.

Notes to Financial Statements

Vesting and Forfeitures

Effective December 30, 2021, all participants became 100% vested in their account balances. Prior to this date, participant were immediately vested in their participant deferrals and earnings thereon. Participants became 100% vested in the Employer's discretionary contributions and earnings thereon after completion of their third year of service. An employee must complete 1,000 hours of service in order to complete a year of service. A participant who left the Employer forfeited any non-vested balance. At July 7, 2022 and December 31, 2021, forfeited non-vested accounts totaled \$-0- and \$12,267, respectively. For the period from January 1, 2022 to July 7, 2022, the Plan applied \$995 in forfeitures against the plan expenses.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of (1) \$50,000 (reduced by the excess, if any, of the participant's highest outstanding loan balance from the Plan during the one-year period ending before the date of the new loan over the current outstanding balance of the participants outstanding loan as of the date of the new loan) or (2) 50% of their vested account balance immediately preceding such receivable. Notes from the plan are secured by the balance in the participant's account and bear interest ranging from 5.25% to 7.50% during the period from January 1, 2022 to July 7, 2022 and the year ended December 31, 2021, which are commensurate with the bank prime lending rate as set by the Federal Reserve Board plus 1%, as determined by the plan administrator. Notes from the Plan must be fully repaid within five years or within 30 years for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions and interest is recognized as income when received. Certain direct fees are charged to the participant to set up and maintain the notes from the plan.

Effective January 1, 2022, the Plan was amended to allow participants to rollover loan balances directly into the retirement plan held by the buyer of the Employer.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared under the liquidation basis. The basis was adopted when liquidation was deemed imminent in accordance with Accounting Standards Update ("ASU") 2013-07, *Liquidation Basis of Accounting*. Plan management determined that liquidation was imminent at December 30, 2021. Under the liquidation basis of accounting, assets are measured at their net realizable value, estimated by fair value reduced by surrender charges, penalties and redemption charges, and disposal expenses, to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process. Liabilities are measured using the accrual basis of accounting, including any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

Notes to Financial Statements

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income (Loss) Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the Plan.

Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment adviser and trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through November 16, 2023, the date the financial statements were available to be issued.

3. Certified Investments

The plan administrator has elected the method of compliance permitted by Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Minnesota Life Insurance Company ("Minnesota Life"), the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits (in liquidation) as of July 7, 2022 and December 31, 2021, and the related investment activity on the statement of changes in net assets available for benefits (in liquidation) for the period from January 1, 2022 to July 7, 2022. The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under *Financial Accounting Standards Board* (“FASB”) *Accounting Standard Codification* (“ASC”) 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to their fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts

Pooled separate accounts are stated at fair value based on the quoted market prices of the underlying securities. The unit value of the pooled separate account is calculated by dividing the total value of the assets of the pooled separate account by the number of units in the pooled separate account. The pooled separate accounts invest exclusively in mutual funds; therefore, the value of the assets is based on the net asset value (“NAV”), or price per share, of the underlying mutual funds as traded on a national exchange.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Fully Benefit-Responsive Investment Contract

The Plan's guaranteed interest contract is a fully benefit-responsive investment contract with Minnesota Life. Minnesota Life maintains the contributions in a separate account used solely to satisfy the claims of the contract holder. The account is credited with participant contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan.

The guaranteed investment contract is included in the financial statements at contract value as reported to the Plan by Minnesota Life. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average crediting interest rate is set quarterly.

6. Party-in-Interest Transactions

Certain plan investments are funds managed by affiliates of Minnesota Life; therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as a party-in-interest transaction.

7. Plan Termination

The Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. As described in Note 1, the Board of Directors of Glynn Electric, Inc. voted to terminate the Plan effective December 30, 2021. All participants became fully vested in their account balances as of December 30, 2021.

During the period from January 1, 2022 to July 7, 2022, net assets of \$12,426,590, were distributed out of the Plan. Participants chose from several options regarding the type of distributions, including lump sum payment and individual retirement account rollover.

8. Tax Status

The Plan has adopted the Minnesota Life Insurance Company Volume Submitter 401(k) Profit Sharing Plan, which received an opinion letter from the IRS dated June 30, 2020, stating that the prototype plan document is qualified under Section 401(a) of the Internal Revenue Code ("IRC"). Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan's administrator believes the Plan is currently designed and being operated in compliance with the IRC and that the Plan continues to be tax-exempt.

GAAP requires plan management to evaluate tax positions take by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.
