## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of  
Lighting Resources, LLC 401(K) Profit Sharing Plan and Trust

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of Lighting Resources, LLC 401(K) Profit Sharing Plan and Trust employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 31, 2022, and December 31, 2021, and the related statement of changes in net assets available for benefits for the eight months ended August 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Lighting Resources, LLC 401(K) Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 31, 2022, and December 31, 2021, and for the eight months ended August 31, 2022, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). #### ***Emphasis of Matter***

As described in Note 1 to the financial statements, the Plan intends to merge with CoAdvantage Corporation Retirement Savings Plan (an unrelated plan) effective September 1, 2022. Our opinion is not modified with respect to this matter.

## NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Lighting Resources, LLC 401(K) Profit Sharing Plan and Trust, (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

### Merger

On July 15, 2022, the trustees of the Plan and Sponsor agreed to merge the Plan with CoAdvantage Corporation Retirement Savings Plan effective September 1, 2022. The merger was executed on September 29, 2022, at which date all Plan assets were transferred to the surviving plan (See note 6).

### Eligibility

The Plan is a defined contribution plan that includes all employees who are at least the age of 21 and have completed one year of eligible service. A year of eligible service is accomplished after completing 1,000 hours of service during a 12-month period. The participant enters the Plan on the first day of the month following the completion of eligibility requirements.

The Plan was established and became effective January 1, 1997, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

### Contributions

Participants may make pre-tax elective deferrals or Roth elective deferrals from his or her annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. If a participant does not direct contributions, the contributions are credited to the default investment option fund.

Lighting Resources, LLC (the “Sponsor”) elected safe-harbor matching contributions and contributes 100 percent of the first 6% of the participant’s compensation which is deferred as an elective deferral. Additional matching contributions may be made at the discretion of the Sponsor. The matching Sponsor contribution is invested as directed by the participant. Contributions are subject to certain IRS limitations.

### Participant Accounts

Each participant’s account is credited with participant elective deferrals, Sponsor matching contributions as well as Plan earnings. Participants’ accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Administrative fees for certain services or transactions requested by the participant may be charged directly to the participant’s account.

### Vesting

Vesting is based upon years of continuous service. Participants are always 100% vested in elective deferral, safe harbor, and rollover contributions. A participant is 100% vested after six years of credited service for discretionary matching contributions.

A participant becomes 100% vested in the participant's total account balance if termination is due to death, disability or attaining the age of 65.

### Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. Loan terms range up to 5 years, or longer for the purchase of a primary residence or other legislative priorities. The loans are secured by the balance in the participant's account and bear a reasonable interest rate; generally the published prime rate plus two percent.

### Payment of Benefits

On termination of service due to death, disability, or retirement a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or to receive installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

### Forfeited Accounts

There were no forfeited non-vested account balances at August 31, 2022, and December 31, 2021. For the eight months ended August 31, 2022, there were no administrative fees paid from the forfeitures account. The Plan is paying all administrative costs (e.g., Audit fees and third-party administrator fees).

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

### Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest rates on loans are at the published prime rate plus two percent. No allowance for credit losses has been recorded at August 31, 2022, and December 31, 2021.

### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. For the eight months ended August, 2022, and year ended December 31, 2021, there were no excess contributions.

### Payments of Benefits

Benefits are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan and are included in these financial statements. Fees related to the administration of notes receivable and distributions from/to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

## NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in an active market for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Generally Accepted Accounting Principles (GAAP) are:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 31, 2022, and December 31, 2021.

**Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common Collective Trust Fund:** Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

## NOTE 4 – RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The Plan pays directly any fees related to the Plan's operations other than those fees initiated by a participant (i.e. loan request and withdrawal). As described in Note 2, for the eight months ended August 31, 2022, the Plan paid no administrative fees from the forfeiture account. The Trustee of the Plan does not manage any of the Plan investments.

## NOTE 5 – TAX STATUS

The Internal Revenue Service has determined and informed the Plan by a letter dated March 31, 2008, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended from time to time, to remain in compliance with applicable laws and regulations of the Department of Labor and Internal Revenue Service.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's annual tax return generally remains open for examination for the three preceding years.

## NOTE 6 – PLAN TERMINATION

The Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their entire account balance. Upon termination of the Plan each participant will be 100% vested in their entire account balance and may rollover their account balance to the new retirement plan.

On July 15, 2022, the trustees of the Plan and Sponsor agreed to merge the Plan with CoAdvantage Corporation Retirement Savings Plan effective September 1, 2022. The merger was completed on September 29, 2022.

All assets and liabilities (if any) of the Plan were vested in CoAdvantage Corporation Retirement Savings Plan ("CoAdvantage"), a qualified plan, as a result of the merger and Plan participants became participants of CoAdvantage and subject to its plan document and related provisions. The Plan assets were not impaired nor

do the assets revert as a result of the merger. The participants of the Plan, and all Sponsor employees became employees of CoAdvantage Resources, Inc. a Professional Employee Organization or PEO. The participants and employees will continue to work for the Sponsor at its various locations.

## NOTE 7 – ADMINISTRATION OF PLAN ASSETS

Certain administrative and accounting functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan.

## NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests, at the direction of the participants, in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risks. Due to the level of risk associated with the investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## NOTE 9 – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at August 31, 2022, net appreciation or depreciation in fair value of investments, and interest and dividends for the eight months ended August 31, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).
