INDEPENDENT AUDITORS' REPORT

To the Plan Sponsor of the California-Nevada Methodist Homes, Inc. 403(b) and Matching Plan
Oakland, California

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of California-Nevada Methodist Homes, Inc. 403(b) and Matching Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year that ended June 30, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of California-Nevada Methodist Homes, Inc. 403(b) and Matching Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 

Our opinion is not modified with respect to this matter.

NOTE 1: DESCRIPTION OF PLAN

The following description of the California-Nevada Methodist Homes, Inc. 403(b) and Matching Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan covering all eligible employees of the California-Nevada Methodist Homes, Inc. (the Organization) with retirement benefits in accordance with section 401(k) of the Internal Revenue Code (the IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on April 1, 2001.

On December 5, 2022, the sale of California-Nevada Methodist Homes (CNMH), including Lake Park and Forest Hills was completed. All employees were terminated and contributions to the Plan ceased immediately. Participants' accounts became fully vested, and all participants' accounts have been distributed or rolled over to an individual IRA on January 25, 2023.

On December 22, 2022, the Senate passed the Consolidated Appropriations Act of 2023 (the "CAA") to fund the government through September 30, 2023. Division T of the legislation is the SECURE 2.0 Act of 2022 ("SECURE 2.0"), which builds upon 2019's Setting Every Community Up for Retirement Enhancement Act (the "SECURE Act"). SECURE 2.0 contains 90 provisions aimed at modernizing the retirement system, encouraging additional retirement savings, and easing administrative requirements. Most of SECURE 2.0's provisions take effect on or after 2024.

Eligibility

Eligible employees shall enter the Plan upon commencement of employment. To be eligible to receive Organization contributions, employees must have reached the age of eighteen. Employees who are eligible to participate in a plan of the Employer offering a qualified cash or deferred election are excluded from participating in the Plan.

Contributions

Participant Contributions: Participants elect to have amounts withheld from their paychecks and contributed to the Plan by the Organization. Participants may contribute the maximum of 90% of their annual compensation in pre-tax deferrals, as defined as in the Plan and by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or contribution plans.

NOTE 1: DESCRIPTION OF PLAN (CONTINUED)

Contributions (Continued)

Qualified Automatic Contribution Arrangement (QACA): The Plan includes QACA provisions that allow the enrollment of eligible employees to participate in the plan. Eligible employees are automatically enrolled with a 3% elective deferral for an initial period and an automatic 1% increment each year until the rate reaches a maximum of 6% of the election.

Employer Contributions:

- *QACA Safe Harbor Contributions:* The Company can make a QACA safe harbor contributions in an amount equal to 100% of the participant's contributions that are not in excess of 1% of their eligible compensations; plus 50% of the amount of the participants' eligible compensations that exceed 1% but that do not exceed of 6% of their eligible compensations. The Organization has made QACA safe-harbor contributions in the amount of \$45,363 during the plan year ended June 30, 2023.
- *Qualified Non-Elective Contributions (QNEC):* The Organization may also make QNECs in the ratio that each participant's compensation bears to the compensation to all eligible participants.

All of the forgoing contributions are subject to limits as set by federal law.

Investment Options

Participants may direct the investment of all contributions into various investment options offered by the Plan and Nationwide Trust Company, FSB (Nationwide) and The Lincoln National Life Insurance Company (Lincoln).

Participant Accounts

Each participant's account is credited with the participant's own contributions and an allocation of net earnings from investments and changes in investment values. Allocations are based on each participant's contributions, earnings, or account balances, as defined by the Plan agreement. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant's account. Participants select the investments into which their contributions are invested. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan.

Vesting

Participants are immediately vested in their own contributions, Organization's QNECs, and all earnings thereon. Participants are fully vested in Organization's QACA safe harbor contributions after 2 years of credited service with the Company.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Terminated participants whose balances are less than \$5,000 will be automatically distributed. For such balances exceeding \$5,000, subject to certain requirements, participants may leave their account balance in the Plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may request withdrawal from their contribution accounts for financial hardship or after attaining the age of 59½. The distribution of the participant's account must commence no later than April 1 following the calendar year in which the participant attains age 72.

Forfeitures

Generally, when a participant terminates participation in the Plan, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures are utilized to reduce the Company's matching contributions for the Plan year. However, if the participant is reemployed and fulfills certain requirements, as defined in the Plan, the participant's account will be reinstated.

Participant Loans

Loans to participants consist of promissory notes received from participants in exchange for the distribution of cash from the Plan. A participant is allowed to borrow a minimum of \$1,000, up to one-half of the vested balance of their Plan account, up to a maximum of \$50,000. The maximum number of outstanding loans allowed at any time is one. Loans must be repaid over no more than a five-year period with the exception of a loan for the participant's principal residence that may have a repayment period beyond five years. Principal and interest are paid ratably through payroll deductions. Loans to participants are stated at the principal amount outstanding, which approximates fair value.

Plan Termination

Effective December 5, 2022, the Company announced the termination of the plan and the intention to transfer existing account balances to participants. The Company has adopted amendments to the plan discontinuing all contributions as of December 5, 2022, and terminated the Plan as of that date.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with U.S. generally accepted accounting principles (U.S. GAAP). Certain prior period disclosures have been revised to conform to the current year's presentation. Effective December 5, 2022, the Plan committee adopted a resolution to terminate the Plan. As a result, the Plan's financial statements as of June 30, 2023, and for the year ended June 30, 2023, have been prepared on a liquidation basis, in accordance with U.S. GAAP. This basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable and the net realizable value of assets is reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amounts. The estimated net realizable cash value for investments as of June 30, 2023, would be fair value. There were no material changes to the 2023 financial statements as a result of the change under the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair Value is the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by its investment advisors, custodians, and insurance companies. See Note 4 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade date basis.

Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3: INFORMATION CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Nationwide and Lincoln, the custodians of the Plan, have certified as being complete and accurate the following information as of June 30, 2023 and 2022, and for the year that ended June 30, 2023.

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits
- Net appreciation in fair value of investments and interest on participant loans reflected on the accompanying statement of changes in net assets available for benefits
- Investments reflected on the schedule of assets (held at the end of the year)

NOTE 4: FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

- Level 1) Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
- Level 2) Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3) Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 4: FAIR VALUE MEASUREMENTS (CONTINUED)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on June 30, 2023 and 2022.

Interest-bearing cash: Valued at the daily closing value as reported by the fund.

Registered investment companies (Mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: The fair values of the mutual funds, stocks, and bonds within the self-directed brokerage accounts are based on quoted market prices when available.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Net appreciation in fair value of investments includes net unrealized and net realized gains and losses on investments during the year and is presented net of investment expenses. Investment income is allocated to individual participant accounts based on the participant's share of the investment fund.

There were no assets held in the plan on June 30, 2023.

NOTE 5: PLAN TERMINATION

On December 5, 2022, the Plan sponsor approved the termination of the Plan. Subsequent to December 5, 2022, no contributions were allowed into the Plan. Shortly after the termination approval date, the plan began the process of distributing participant balances. All accounts became fully vested and non-forfeitable. Plan assets will be used to pay expenses before being distributed to participants. Participant balances were transferred to participants as of June 30, 2023.

NOTE 6: TAX STATUS

The Plan is intended to qualify as tax exempt deferred compensation plan pursuant to Internal Revenue Code 403(b). The Internal Revenue Service has not yet established a process for issuing determination and opinion letters for 403(b) plans. However, the plan administrator believes that the plan is being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, no provision for income taxes has been reflected in the accompanying financial statements.

NOTE 7: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8: PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Nationwide and Lincoln. The Nationwide and Lincoln are the custodians, as defined by the Plan, and therefore, these transactions qualify as party-in-interest. Additionally, the Plan Sponsor, California-Nevada Methodist Homes, Inc. is also party-in-interest. Any purchase and sales of investments in the custodian are open market transactions at fair market value. Fees incurred by the Plan for investment management services are included in net depreciation in the fair value of investments. These fees are paid to the investment fund manager and may include certain revenue-sharing fees that are paid to Nationwide, Lincoln, other investment custodians, and investment advisors.

The Plan also allows for the issuance of notes receivable to participants in accordance with the related regulations. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.
