NOTE A - DESCRIPTION OF THE PLAN

The following brief description of the Elkay Manufacturing Company Retirement and Savings Plan (the Plan) is provided for general information purposes. Participants should refer to the Plan document and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the Plan sponsor.

General

Effective July 1, 2022, Elkay Manufacturing Company, the Plan Sponsor, merged with and into Zurn Elkay Water Solutions Corporation. Effective January 1, 2023, the Elkay Manufacturing Company Retirement and Savings Plan merged with the Zurn 401(k) Plan. To effectuate the merger, the Plan's investments of \$126,806,812 were liquidated on December 30, 2022. All assets were transferred into the Zurn 401(k) Plan on January 3, 2023.

The Plan is a defined contribution plan covering non-union employees of Elkay Manufacturing Company (the Company). Employees are eligible to participate in the Plan after attainment of age 18 and completing three months of service and are eligible to receive profit-sharing contributions after six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan is administered by the Company. Record-keeping services are provided by Great-West Financial Retirement Plan Services, LLC and trustee services are provided by Great-West Trust Company, LLC.

Contributions

Participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Upon enrollment, participants may direct their contributions to any of the fund options offered through the Plan's trustee. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company will make a matching contribution up to 4% of each participant's compensation. The Plan provides for true-up matching contributions at the end of the year.

The annual Company profit-sharing contribution (limited by the Internal Revenue Code (the IRC)) is determined by the board of directors of the Company. Profit-sharing contributions are allocated to participants who complete 1,000 hours of service during the year and who are still employed on the last day of the Plan year. The profit-sharing contribution was \$844,546 and \$1,235,639 in 2022 and 2021, respectively. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, Company profit-sharing contributions, and allocations of the Plan's earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

Participants are immediately vested in their contributions and the Company's matching contribution, plus actual earnings thereon. Vesting in any additional Company contributions is based on years of continuous service. A participant is fully vested after six years of credited service. Forfeited balances of terminated participants' non-vested accounts are used to reduce the Company's matching contributions or reduce the profit-sharing contributions. Unallocated forfeiture balances as of December 31, 2022 and 2021, were \$0 and \$149,711, respectively. Forfeiture balances of \$494,737 and \$142,651 were used to reduce Company

contributions in 2022 and 2021, respectively. Subsequent to year end, forfeitures of \$0 and \$175,000 were used to reduce the profit-sharing Company contribution included as a receivable at December 31, 2022 and 2021, respectively.

Payment of Benefits

Payments of benefits are made to participants or their beneficiaries upon death, retirement, disability or termination of employment. The Plan allows for certain withdrawals, subject to limitations and eligibility requirements as defined by the Plan. Benefits are payable in a lump-sum or by other methods as described in the Plan.

Notes Receivable from Participants

Participants may borrow from their Plan account up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance relating to their contributions. Loan terms range from one to five years for a general-purpose loan and one to 15 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator. A participant may only have one loan outstanding from the Plan at any time.

Administrative Expenses

Certain general and administrative expenses have been paid directly by the Company. Costs and expenses incurred with regard to the purchase, sale or transfer of investments and other assets, and for investment managers' fees in connection with the operation of the Plan are borne by the Plan. As well, specific accounting and other professional fees are paid by the Plan.

Transfer of Assets

Throughout the year, employees may transfer to various positions within the Company. This may result in a transfer to or from the Plan to another plan sponsored by the Company. There were \$4,983 inter-plan transfers related to employees' change in position within the Company for the year ended December 31, 2022.

Plan Mergers

Effective March 7, 2022, employees of Elkay Interior Systems, Inc. and Digney York Associates, LLC were transferred out of the Plan and into the Elkay Interior Systems 401 (k) Plan. These mergers are reflected as a transfer out on the statement of changes in net assets available for benefits of \$21,495,926.

Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts. In connection with the merger of the Plan Sponsor with Zurn Water Solutions Corporation, effective July 1, 2022, Zurn Water Solutions Corporation has decided to merge the Plan into the Zurn 401(k) Plan effective January 1, 2023.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note C for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

NOTE C - FAIR VALUE MEASUREMENTS

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e. an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets or liabilities.

Level 2 - Inputs other than quoted prices in active markets for identical assets and liabilities that are observable, either directly or indirectly, for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in markets that are not active;
- Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals); and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value by the Plan. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual Funds

The shares of mutual funds are valued at quoted market prices, which represent the net asset value (NAV) of the shares held by the Plan at year end. Investments in the self-directed accounts are invested in mutual funds.

Collective Trusts

Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used to determine when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Redemptions are permitted by participants on any business day. Redemptions at the Plan level are permitted with 12 months' written notice for the fixed income fund and on any business day for the equity fund. The collective trusts have no unfunded commitments.

NOTE E - INCOME TAX STATUS

The underlying non-standardized prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2014, stating that the form of the Plan is qualified under Section 401 of the IRC and, therefore, the related trust is tax-exempt. In accordance with Revenue Procedure 2019-04, the Plan sponsor has determined that it is eligible, and has chosen, to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan has recognized no interest or penalties related to uncertain tax positions.
