We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.



Emphasis of Matter

As discussed in Notes 1 and 8 to the financial statements, ownership of the Plan's assets were transferred to a multiple employer plan, on December 31, 2022. Effective January 1, 2023, the Plan merged with the Hoag Clinic Medical Groups 401(k) Plan. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. generally accepted accounting principles, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. generally accepted accounting principles.



Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2022 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

(1) Description of Plan

The following summary description of the Hoag Medical Group, Inc. 401(K) (the Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information, copies of which may be obtained from the plan sponsor.

(a) General

The Plan is a defined-contribution plan covering employees of Hoag Medical Group, Inc. (the Medical Group) subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

An employee of the Medical Group is eligible to participate on the first day of the month following employment and attaining the age of 21.

On December 31, 2022, Empower transferred all assets to Fidelity Investments Institutional Services Company, Inc (Fidelity). Great-West Trust Company, LLC (Empower) served as trustee of the Plan from August 15, 2013 through December 31, 2022. Effective January 1, 2023, the Plan became a part of the Hoag Clinic Medical Groups 401(k) Plan, a multiple employer plan with Fidelity. Fidelity will be the administrator of the Plan as of January 1, 2023.

(b) Contributions and Forfeited Amounts

A participant is permitted to make contributions to the Plan in an amount up to 100% of his or her compensation subject to Internal Revenue Service (IRS) limitations. The Medical Group may match contributions at its own discretion.

Participants' rights to their contributions to the Plan are 100% vested at all times. All Medical Group contributions are 100% vested after participants have earned two years of service as defined by the Plan.

Forfeitures of terminated participants' nonvested accounts are allocated to reduce net assets by the Medical Group. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

The Medical Group unintentionally delayed the remittance of certain participant contributions. The total amount of delinquent contributions was \$ 674,070. Interest for lost earnings will be remitted to participants in 2023 by the Medical Group.

(c) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance less their highest outstanding loan balance within the past 12 months. Loan terms range from 1 to 5 years or up to 15 years for the purchase of a primary residence. The loans are at a fixed rate commensurate with 1% over prime rates as determined by the plan administrator at the time of borrowing, and the rates of outstanding loans as of December 31, 2022, were zero.

(d) Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions in any increments of the investment options available. In addition, participants may change their investment options daily.

(e) Withdrawals

Certain participant in-service withdrawals, including the case of financial hardship, are permitted. In addition, Medical Group contributions to a participant's account may only be withdrawn to the extent that such contributions are vested. On termination of service, a participant may receive a lump-sum amount equal to the vested value of his or her account, or upon death, disability, or retirement, elect to receive annual installments over a period not to exceed the life expectancy of the participant or designated beneficiary.

Participants may withdraw funds on account of financial hardship if the participant satisfies certain conditions. This hardship distribution is not in addition to other participant benefits and will therefore reduce the value of the benefits participants will receive upon termination of employment or other event entitling the participant to distribution of their account balance. Participants may request a hardship distribution only from the vested portion of their elective deferral contributions.

(f) Plan Termination

As of December 31, 2022, the Plan will stop existing as a single employer Plan. The Medical Group has retained the right to terminate the Plan subject to the provisions of ERISA. Upon termination, all Plan participant interests shall become fully vested.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

(b) Investment Valuation, Income Recognition, and Credit Risk

The Plan's investments are stated at fair value. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

The Plan invests in group annuity contracts.

The Empower Select Guaranteed Fund is invested in highly rated fixed income securities. It seeks to maintain a return like a short-term bond with a risk profile like a money market fund and is designed for use as a stable value option in the Plan. The Empower Select Guaranteed Fund is subject to liquidity restrictions and can not be liquidated for a 36-month period. Empower is the custodian for the entirety of the 36-month period.

(2) Summary of Significant Accounting Policies (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's net gains and losses on investments bought and sold, as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. The Plan's exposure to credit loss in the event of nonperformance of investments is limited to the carrying value of such instruments.

(c) Administrative Expenses

All administrative expenses may be paid in whole or in part by the Medical Group. Any expenses not paid by the Medical Group shall be paid for by the Plan. Administrative expenses paid by the Plan were \$57,178 for the year ended December 31, 2022. Expenses paid by the Medical Group were \$0 in 2022.

(d) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

(e) Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued, but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 or 2021. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

(f) Payments of Benefits

Benefits are recorded when paid.

(g) Other Expense

Other activity represents the net activity of forfeitures and loan payments. Forfeitures result in a decrease in net assets.

(3) Fair Value Measurements

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, defines fair value, establishes a framework for measuring fair value, and expands disclosures about fair value measurements. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price).

ASC Topic 820 includes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1. Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2. Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:
 - Quoted prices for similar assets and liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in markets that are not active
 - Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3. Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest-level input that is significant to the fair value measurement in its entirety.

Assets and liabilities measured at fair value are based on one or more of three valuation techniques noted in the tables below.

- a) Market approach: Prices and other relevant information generated by market transactions involving identical or comparable assets or liabilities
- b) Cost approach: Amount that would be required to replace the service capacity of an asset (replacement cost)
- c) Income approach: Techniques to convert future amounts to a single present amount based on market expectations (including present value techniques, option-pricing, and excess earnings models)

(4) Tax Status of the Plan

The underlying plan has received a determination letter from the IRS dated June 30, 2020 stating that the form of the Plan is qualified under Section 401(a) of the Code, and therefore, the related trust is tax exempt. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2022 and 2021, there were no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(5) Investments

All investment information disclosed in the accompanying financial statements on December 31, 2022 and 2021, and dividends, interest, and net depreciation in fair value of investments for the year ended December 31, 2022, was obtained or derived from information supplied from the plan administrator Empower.

(6) Party in Interest Transactions

The Plan held shares of a certain group annuity funds that is managed by the trustee of the Plan. These transactions qualify as party in interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

(7) Information Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for the 2022 plan year. Accordingly, Empower, the trustee of the Plan, has certified to the completeness and accuracy of:

- Investments, at fair value
- Notes receivable from participants
- Net depreciation in the fair value of investments
- Dividend and interest income
- Interest income from notes receivable from participants
- Investment balances included in note 3 (excluding level designations)

(8) Subsequent Events

Effective January 1, 2023, the Plan merged with the Hoag Clinic Medical Groups 401(k) Plan, a closed multiple employer plan with Fidelity. On December 31, 2022, ownership of all assets was transferred to the multiple employer plan.

Management has evaluated subsequent events for the Plan through October 20, 2023, the date on which the financial statements were available to be issued.
