Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2022 Financial Statements

We have performed an audit of the financial statements of Creative Hospice Care, Inc. 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2022, and the related statement of changes in net assets available for benefits for the six months then ended, and the related notes to the financial statements (2022 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2022 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1: Description of the Plan

The following description of Creative Hospice Care, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan for the exclusive benefit of eligible employees of Creative Hospice Care, Inc. (the Company) and their beneficiaries. The plan was restated effective November 1, 2020, when the assets of the Plan were transferred from John Hancock Life Insurance Company (USA) (John Hancock) to Reliance Trust Company (Reliance). Employees become eligible to participate in the Plan at 21 years of age and completion of 60 days of service and enter the Plan on the first day of the month coinciding with or next following the date eligibility requirements are met. The Plan is subject to the provision of the *Employee Retirement Income Security Act of 1974* (ERISA).

During 2021, Creative Hospice Care, Inc. was acquired by Traditions Health, LLC. On June 30, 2022, the Plan sponsor approved the merger of the Creative Hospice Care, Inc. 401(k) Plan into the Traditions Health, LLC 401(k) Plan effective immediately. As a result, all investments were transferred from the Plan into Traditions Health, LLC 401(k) Plan on that date.

Contributions

Participants may contribute up to 100 percent of pretax annual compensation to their account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employee rollover contributions are also permitted from other qualified plans. The Company may make discretionary employer matching contributions. During 2022 or 2021, the Company contributed a matching contribution equal to 50 percent of the employee contribution up to 6 percent of eligible compensation. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Investment Account Options

Participants have the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company matching contribution portion of their accounts plus earnings thereon is based on years of continuous service with the Plan Sponsor or an affiliate. A participant is fully vested after six years of continuous service.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of their account. A participant may elect to receive a distribution of their rollover contributions at any time. The Plan allows for hardship distributions, subject to plan provisions.

Forfeited Accounts

At June 30, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$75,364, respectively. Forfeited nonvested accounts may be used to pay administrative fees or reduce future employer contributions. In 2022 and 2021 employer contributions remitted to the Plan for 2022 and 2021 were reduced by \$51,382 and \$163,810 from forfeited nonvested accounts, respectively.

Notes Receivable from Participants

The plan document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan is \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50 percent of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on prime rate plus 1 percent. The maximum number of loans a participant may have outstanding at one time is one.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. Collective investment trusts are invested in collective trust funds as well as a variety of mutual funds. The fair value as determined by the custodian is the NAV and is the basis for current transaction and is readily determinable.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's' discretion.

Note 3: Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified the following information included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of June 30, 2022, and December 31, 2021.
- Investment income (loss) and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the periods ended June 30, 2022, and December 31, 2021.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

Note 4: Disclosures About Fair Value Measurements

Fair value measurement is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the periods ended June 30, 2022 and December 31, 2021. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities including mutual funds and collective investment trusts are valued at the net asset value (NAV) of shares held by the Plan at year-end. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics, or discounted cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 5: Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Fees incurred by the Plan for recordkeeping, administrative, and investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are primarily paid through revenue sharing, rather than a direct payment. The plan directly paid \$39,889 and \$61,490 of recordkeeping fees to ADP, Inc., and \$14,659 and \$55,857 of investment advisory fees to IFG Advisory, LLC during the periods ended June 30, 2022, and December 31, 2021, respectively. The Company provides certain additional administrative services at no cost to the Plan.

Note 6: Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions accounts.

Note 7: Tax Status

The Plan operates under an adoption agreement in connection with a non-standardized pre-approved profit sharing plan document sponsored by ADP, LLC. This plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10: Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. Participant loan repayments of \$403 were not remitted to the Plan before the six months ended June 30, 2022.

Note 11: Subsequent Events

Subsequent events have been evaluated through October 31, 2023, which is the date the financial statements were available to be issued.

Note 1: Description of the Plan

The following description of Creative Hospice Care, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan for the exclusive benefit of eligible employees of Creative Hospice Care, Inc. (the Company) and their beneficiaries. The plan was restated effective November 1, 2020, when the assets of the Plan were transferred from John Hancock Life Insurance Company (USA) (John Hancock) to Reliance Trust Company (Reliance). Employees become eligible to participate in the Plan at 21 years of age and completion of 60 days of service and enter the Plan on the first day of the month coinciding with or next following the date eligibility requirements are met. The Plan is subject to the provision of the *Employee Retirement Income Security Act of 1974* (ERISA).

During 2021, Creative Hospice Care, Inc. was acquired by Traditions Health, LLC. On June 30, 2022, the Plan sponsor approved the merger of the Creative Hospice Care, Inc. 401(k) Plan into the Traditions Health, LLC 401(k) Plan effective immediately. As a result, all investments were transferred from the Plan into Traditions Health, LLC 401(k) Plan on that date.

Contributions

Participants may contribute up to 100 percent of pretax annual compensation to their account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employee rollover contributions are also permitted from other qualified plans. The Company may make discretionary employer matching contributions. During 2022 or 2021, the Company contributed a matching contribution equal to 50 percent of the employee contribution up to 6 percent of eligible compensation. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Investment Account Options

Participants have the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company matching contribution portion of their accounts plus earnings thereon is based on years of continuous service with the Plan Sponsor or an affiliate. A participant is fully vested after six years of continuous service.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of their account. A participant may elect to receive a distribution of their rollover contributions at any time. The Plan allows for hardship distributions, subject to plan provisions.

Forfeited Accounts

At June 30, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$75,364, respectively. Forfeited nonvested accounts may be used to pay administrative fees or reduce future employer contributions. In 2022 and 2021 employer contributions remitted to the Plan for 2022 and 2021 were reduced by \$51,382 and \$163,810 from forfeited nonvested accounts, respectively.

Notes Receivable from Participants

The plan document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan is \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50 percent of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on prime rate plus 1 percent. The maximum number of loans a participant may have outstanding at one time is one.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. Collective investment trusts are invested in collective trust funds as well as a variety of mutual funds. The fair value as determined by the custodian is the NAV and is the basis for current transaction and is readily determinable.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's' discretion.

Note 3: Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified the following information included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of June 30, 2022, and December 31, 2021.
- Investment income (loss) and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the periods ended June 30, 2022, and December 31, 2021.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

Note 4: Disclosures About Fair Value Measurements

Fair value measurement is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the periods ended June 30, 2022 and December 31, 2021. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities including mutual funds and collective investment trusts are valued at the net asset value (NAV) of shares held by the Plan at year-end. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics, or discounted cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 5: Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Fees incurred by the Plan for recordkeeping, administrative, and investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are primarily paid through revenue sharing, rather than a direct payment. The plan directly paid \$39,889 and \$61,490 of recordkeeping fees to ADP, Inc., and \$14,659 and \$55,857 of investment advisory fees to IFG Advisory, LLC during the periods ended June 30, 2022, and December 31, 2021, respectively. The Company provides certain additional administrative services at no cost to the Plan.

Note 6: Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions accounts.

Note 7: Tax Status

The Plan operates under an adoption agreement in connection with a non-standardized pre-approved profit sharing plan document sponsored by ADP, LLC. This plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10: Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. Participant loan repayments of \$403 were not remitted to the Plan before the six months ended June 30, 2022.

Note 11: Subsequent Events

Subsequent events have been evaluated through October 31, 2023, which is the date the financial statements were available to be issued.
