Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2023 and 2022 Financial Statements

Emphasis of Matter on the 2023 and 2022 Financial Statements

On December 2022, Plan management approved the merger of the Phoenix Color 401(k) Retirement Plan into the LSC Savings Plan effective February 28, 2023.

In February 28, 2023, all net assets of the Plan were Transfer to the LSC Savings Plan. Our report is not modified with respect to that matter.

Responsibilities of Management for the 2023 and 2022 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Phoenix Color 401(k) Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.



- 1. Description of the Plan** The following description of the Phoenix Color 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Phoenix Color Corp. (the "Company") who have completed six months of service, except for nonresident aliens, employees covered by a collective bargaining agreement, leased employees, residents of Puerto Rico, and any employee who is not a citizen of the United States of America (U.S.) and is working in the U.S. on a non-exclusive or non-permanent basis. The Plan was amended March 31, 2022 to remove PCC Express, Inc. and ALJ Regional Holdings, Inc. as participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective February 28, 2023, the Plan merged into the LSC Savings Plan. The participant account balances remained in the Plan were transferred out of the Plan and into LSC Savings Plan on February 28, 2023.

Contributions: Each year, participants could contribute up to 50 percent of pretax annual compensation, as defined in the Plan. Roth contributions were also permitted. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans (rollovers). The Plan provided for automatic enrollment. Any newly eligible employee who had not affirmatively elected to contribute to the Plan or had not affirmatively declined to participate in the Plan was automatically enrolled in the Plan with a three percent withholding of pretax annual compensation. This withholding was increased by one percent each subsequent year until the automatic election reaches a maximum withholding contribution of 15 percent of compensation. The Company contributed a safe harbor matching contribution of 100 percent of the first three percent of compensation and 50 percent of the next two percent of compensation that a participant contributes to the Plan. The Plan allowed for discretionary non-elective contributions. There were no discretionary nonelective contributions for the period January 1, 2023 to February 28, 2023 and for the Plan year ended December 31, 2022. Contributions were subject to certain limitations.

Participant accounts: Each participant's account was credited with the participant's contributions, the Company's safe harbor matching contributions, as well as allocations of the Company's discretionary non-elective contribution, if any, and Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses. Investment earnings and losses were allocated based upon the investment performance of each investment in the participant's account. Allocations of the Company's discretionary non-elective contributions, if any, were based on the ratio of the participant's eligible compensation to total eligible compensation for the Plan year. The benefit to which a participant is entitled is the benefit that could be provided from the participant's vested account.

Notes receivable from participants: Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms ranged from one to five years or up to fifteen years for the purchase of a primary residence. The loans were secured by the balance in the participant's account and bore interest at the prime rate. Principal and interest were paid through payroll deductions.

Vesting: Participants were vested immediately in their contributions and the Company's safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary non-elective contributions was based on years of continuous service. A participant was 20 percent vested after two years of service is completed, and vested an additional 20 percent per year until full vesting after six years. Different vesting schedules may apply to account balances of participants due to prior Plan provisions as described in the Plan document.

Payment of benefits: Benefits were payable upon retirement at age 62, early retirement at age 55 with at least five years of service, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 were also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions were permitted at any time. Benefits were payable in lump sum installment or partial payments.

Forfeited accounts: At December 31, 2021, forfeited nonvested accounts totaled \$143. There were no forfeited nonvested accounts at December 31, 2022 and February 28, 2023. These accounts were used to reduce future Company contributions or to pay Plan expenses. During 2022 and 2021, no forfeited nonvested accounts were used to reduce Company contributions.

Administrative expenses: Certain expenses of maintaining the Plan were paid by the Company. Transaction expenses, such as loan and distribution administration fees, were charged directly to the participant's account and were included in administrative expenses. Investment consulting fees were also charged to participants based on account balances.

2. Significant accounting policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Investment valuation and income recognition: Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes receivable from participants: Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Delinquent loans were reclassified as distributions based upon the terms of the Plan document.

Payment of benefits: Benefits are recorded when paid.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events for disclosure in these financial statements through November 15, 2023, which is the date the financial statements were available to be issued.

3. Certified information Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at February 28, 2023 and December 31, 2022 and 2021, and net appreciation and depreciation in fair value of investments, interest and dividend income, and interest income from notes receivable from participants for the period January 1, 2023 to February 28, 2023 and for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

4. Fair value measurements The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

The fair value of the shares of mutual funds owned by the Plan is based on quoted net asset values on the last business day of the Plan year.

The fair value of the collective trust funds is based on the net asset value ("NAV") on the last business day of the Plan year provided by the entity holding the trust funds. The NAV of the collective trust is used as a practical expedient to estimate fair value and is determined by the fund trustee based on the fair value of underlying assets in the trust, less its liabilities.

Money market funds are reported at cost, which approximates fair value.

Investments in the Fidelity Managed Income Portfolio II Fund collective trust can be redeemed immediately for participant directed transactions at the current net asset value based on the fair value of the underlying assets in the trust. Full redemption by the Company from the trust requires a 12 month written notice. There are no other withdrawal limits, redemption frequency limits or redemption notice periods. There were no unfunded commitments for this investment as of December 31, 2022 and 2021.

5. Tax status

The Plan is a pre-approved plan of FMR LLC which received an opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

- 6. Party-in-interest transactions** Certain Plan investments are managed by affiliates of Fidelity Management Trust Company ("Fidelity"). Fidelity is the trustee and recordkeeper as defined by the Plan. During 2023 and 2022, the Plan paid Fidelity and other service providers for recordkeeping and other services. These transactions qualify as exempt party-in-interest transactions.

The Company had a service agreement with Fidelity that provided for a "Revenue Credit Account" for the Plan. Under the agreement, Fidelity will deposit an annual amount of \$20,000 into the Revenue Credit Account in equal quarterly installments. The amount in the Revenue Credit Account, which was included in investments, may be used to pay Plan expenses or be allocated to participant accounts. This activity is recorded as a reduction of administrative expenses in the accompanying financial statements.
