Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Alpha Testing, Inc. Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. Description of Plan

The following description of the Alpha Testing, Inc. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General. The Plan was a defined contribution plan established effective January 1, 1998. The Plan covered all employees, excluding union employees and non-resident alien employees, of Alpha Testing, Inc. (the Company) who had completed one year of service and were age 21 or older. The Plan required participants to be employed as of year end to be eligible to receive employer profit share contributions. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan Administrator was responsible for oversight of the Plan. The Plan's investment committee determined the appropriateness of the Plan's investment offerings, monitored investment performance, and reported to the Plan's Plan Administrator.

Contributions. Each year, participants were allowed to contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants could also designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. The Company would contribute 100 percent of the first 3 percent of base compensation that a participant contributed to the Plan and 50 percent of participant contributions between 3 and 5 percent of base compensation. Additional profit sharing amounts could be contributed at the option of the Owners of Alpha Testing, Inc. For the year ended December 31, 2022, the Company did not approve a profit sharing contribution to the Plan. Additional discretionary match could be contributed by the Company at the option of the Owners of the Company. For the year ended December 31, 2022, there were no discretionary matching contributions to the Plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts. Each participant's account was credited with the participant's contributions, Company matching contributions, allocations of the Company's discretionary contributions and an allocation of the Plan's earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting. Participants were vested immediately in their contributions and Company safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts was based on years of continuous service. A participant was 20 percent vested after two years of credited service and continued to vest in increments of 20 percent until 100 percent vested after six years of credited service.

Notes receivable from participants. Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate, determined monthly, was set at 1 percent above the prime rate, as defined. Principal and interest were paid ratably through monthly payroll deductions. Terms ranged from one to five years or greater for the purchase of a primary residence.

Payment of benefits. On termination of service due to death, disability, retirement, or other reasons, a participant could elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. If a terminated participant's vested balance was less than or equal to \$5,000, the amount could automatically be distributed in the form of a lump sum cash payment. In addition, the Plan allowed for hardship distributions if certain criteria were met.

Forfeited accounts. At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$0 and \$0, respectively. In accordance with Plan provisions, the Plan Sponsor utilized the forfeiture accounts to reduce employer contributions or to pay plan administrative expenses. During 2022, employer contributions were reduced by \$9,367 from forfeited nonvested accounts.

Plan Merger. The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon Plan termination, participants became 100 percent vested in their employer contributions. Effective January 1, 2023, Alpha Testing, Inc. Profit Sharing Plan merged into the Universal Engineering Sciences 401(k) Plan ("UES 401k Plan"). This merger resulted in the transfer of all participant and plan sponsor assets transferred into the UES 401k Plan on December 30, 2022. Upon the merger the participants vesting schedule was not altered.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affected the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determined the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

The Plan's investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed as incurred. No allowance for credit losses had been recorded as of December 31, 2022 or 2021.

Payment of Benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation (depreciation) in fair value of investments.

Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2022 and 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds that were held by the Plan were open-end mutual funds that were registered with the U.S Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

4. Fully Benefit-Responsive Investment Contracts

The Plan held a traditional fully benefit-responsive guaranteed investment contract, for which contributions were maintained in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

This contract met the fully benefit-responsive investment contract criteria and was therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the sponsoring trustee, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The traditional investment contract held by the Plan was a guaranteed investment contract. The contract issuer was contractually obligated to repay the principal and interest at the specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but could not have been less than 1 percent. The crediting rate was reviewed on a quarterly basis. The contract could not be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could have been affected by economic and regulatory developments.

Certain events may have limited the ability of the Plan to transact at contract value with the issuer. These events could have been different under each contract. Such events included:

1. amendments to the Plan documents (including complete or partial Plan termination or merger with another plan);
2. changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
3. bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan;
4. the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or,
5. premature termination of the contract.

No events occurred that limited the ability of the Plan to transact at contract value with the contract issuers that also limited the ability of the Plan to transact at contract value with the participants.

In addition, certain events allowed the issuer to terminate the contract with the Plan and settle at an amount different from contract value. These events could have been different under each contract. Such events included:

1. an uncured violation of the Plan's investment guidelines;
2. a breach of material obligation under the contract;
3. a material misrepresentation; or,
4. a material amendment to the agreement without the consent of the issuer.

5. Related-Party and Party In Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary to the Plan or party rendering services to the Plan, the employer and certain others. As such, transactions conducted with the Company, the Company's employees, trustee, custodian, auditor and third-party administrator qualified as party-in-interest transactions.

The Plan invested in certain funds managed by the plan trustee which qualified as party-in-interest transactions. No officer or employee received compensation from the Plan.

6. Tax Status

The Plan adopted a pre-approved plan. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust were designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan had been amended since receiving the IRS Opinion Letter, the plan administrator believed that the Plan was designed, and operated, in compliance with the applicable requirements of the IRC, and, therefore believed that the Plan was qualified, and the related trust was tax exempt.

6. Tax Status (continued)

Plan management was required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there were no IRS audits for any tax periods in progress.

7. Information Certified by Custodian

The plan administrator had elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2022 and 2021. Accordingly, Lincoln Financial Group Trust Company, the Trustee of the Plan, had certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2022 and 2021, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2022, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2022.

8. Delinquent Participant Contributions

For the year ended December 31, 2022, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule of Delinquent Participant Contributions, which totaled \$34,576, were corrected outside of the Department of Labor Voluntary Fiduciary Correction Program in 2022, including any lost earnings.

9. Subsequent Events

Subsequent events were evaluated through November 21, 2023, the date the financial statements were available to be issued.
