Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of Retirement Plan for Employees of Ohio Gas Company (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of July 19, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits – modified cash basis for the period from January 1, 2023 through July 19, 2023 and year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of July 19, 2023 and December 31, 2022, and for the period from January 1, 2023 through July 19, 2023 and year ended December 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of matter – Basis of accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of management for the financial statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's responsibilities for the audit of the financial statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting described in Note 2.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other matter – supplemental schedules required by ERISA

The supplemental schedule of reportable transactions for the period from January 1, 2023 through July 19, 2023 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or

to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 - DESCRIPTION OF PLAN

General

The Retirement Plan for Employees of Ohio Gas Company (the "Plan") is a defined benefit pension plan established to provide pension benefits to Ohio Gas Company (the "Company") employees identified in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Effective December 31, 2010, the Plan was frozen which suspended the accrual of future service benefits and no employees shall be eligible to enter the Plan after December 31, 2010. The following is a brief description of the Plan and its respective provisions. Participants should refer to the Plan document for more complete information.

Plan Administration

The Plan is administered by the Ohio Gas Company Benefits Committee (the "Benefits Committee"). Principal Trust Company ("Principal") serves as the Plan's trustee which administers the investments. The Plan's assets are held by Principal and Principal is the administrator of the Plan's contributions and disbursements.

Participation

Employees were generally eligible to participate in the Plan upon completion of one year of service and attainment of age 21. One year of service is defined as a 12-month period in which an employee completes at least 1,000 hours of service.

Funding Policy

Contributions to the Plan are based upon a valuation performed by an independent actuary. The amounts are calculated to provide for whatever benefits are not covered by the Plan's current assets and the estimated future earnings thereon. Contributions are at least equal to the minimum funding required under ERISA. Annually, an independent actuary is utilized to determine the Plan's funding requirements. The minimum funding requirement was \$0 for the period from January 1, 2023 through July 19, 2023 and year ended December 31, 2022.

Vesting

Participants are 100% vested after completing five years of service, with no vesting before the end of the five-year period.

Pension Benefits

In accordance with the Plan provisions, employees are entitled to monthly pension benefits beginning at the normal retirement age of 65, which are equal to the greater of the average of the last five year's salary multiplied by specified rates or specified rates multiplied by "salary earned," as defined in the Plan. The normal form of benefit is a life annuity; however, married participants will receive a 50% joint and survivor annuity unless elected otherwise. Early retirement benefits are based upon service accrued and "salary earned" up to age 55 and are reduced by an early retirement factor. Subject to the provisions set forth in the Plan, spouses are entitled to a lifetime benefit of up to 100% of the accrued benefit upon the death of an active member.

Plan Termination

In August 2022, the Directors of Ohio Gas Company approved the recommendation to terminate the Plan. In August 2022, the Plan was officially amended by the authority of the Plan Administrator to be terminated

as soon as regulatory approvals may be obtained and the orderly distribution of all benefits may be accomplished in compliance with the standard termination requirements of Title IV of ERISA and the qualification requirements of the Internal Revenue Code ("IRC").

In January 2023, the Plan received the standard termination acknowledgement from the PBGC in response to the Form 500 filing. In April 2023, the Plan received approvals from the Internal Revenue Service ("IRS") that the termination of the Plan does not affect its qualification for federal tax purposes, at which point the termination of the plan was determined to be imminent. See Note 2 for information regarding the Plan's basis of accounting.

The Plan was settled through a combination of lump sum distributions to eligible Plan participants who elected such payments, and the purchase of a group annuity contract from Principal, for all remaining liabilities. Upon completion of the transaction, in June 2023, Principal irrevocably assumed from the Plan the obligation to pay the remaining retirement benefits described in the group annuity contract. The accrued benefits of participants, beneficiaries and annuitants are not affected by the termination of the Plan. As the Plan was in the overfunded status, the final assets remaining the plan of approximately \$1.6 million were transferred to the Plan Sponsor's 401(k) plan, Ohio Gas Company 401(k) Saving Plan, a qualified replacement plan on July 19, 2023, the date of termination.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared using the modified cash basis of accounting which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under the modified cash basis of accounting certain income and the related assets are recognized when received rather than when earned and certain expenses and the related liabilities are recognized when paid rather than when the obligation is incurred.

Although the Plan terminated during 2023 (see Note 1), the liquidation basis of accounting (Generally Accepted Accounting Principles for a liquidating entity) was not used as the termination and liquidation of the Plan occurred during the same period. The Plan used the modified cash basis of accounting for all periods presented. The liquidation basis of accounting requires an entity to accrue estimated costs and income to liquidate assets, measure assets to reflect the estimated amount of cash or other considerations it expects to collect in settling or disposing of those assets, and make all disclosures required to understanding the entity's statement of net assets in liquidation and statement of changes in net assets in liquidation. Should the Plan have used the liquidation basis of accounting in preparing the 2023 financial statements, no additional disclosures would have been necessary to explain the impact to the Plan's financial statements since full liquidation of the Plan occurred in the same period as the regulatory approval of the Plan's termination.

Use of Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recognized when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants prior to liquidation were recorded upon distribution.

Expenses

The Plan pays all costs to the trustee for investment management services. The Company pays substantially all other costs of Plan administration.

NOTE 3 - FAIR VALUE MEASUREMENTS

In accordance with the Financial Accounting Standards Board guidance regarding fair value, a hierarchy is established that requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy defines three levels of inputs that may be used to measure fair value.

- Level 1 - Unadjusted quoted prices in active markets for identical unrestricted assets and liabilities that the reporting entity has the ability to access at the measurement date.
- Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset and liability or can be corroborated with observable market data for substantially the entire contractual term of the asset or liability.
- Level 3 - Unobservable inputs that reflect the entity's own assumptions about the assumption market participants would use in the pricing of the asset or liability and are consequently not based on market activity but rather through particular valuation techniques.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2022:

Mutual funds - Valued at the quoted net asset value ("NAV") of shares held by the Plan at year end.

Pooled separate accounts - The fair value of the pooled separate accounts is measured using the NAV per unit based on the redemption value as determined by the trustee based on the fair value of the underlying investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement result at the reporting date.

The Plan's investments include pooled separate accounts which were invested with or managed by the trustee or a related entity to the trustee and, therefore, qualify as party-in-interest transactions. Fees to the trustee for investment management services were paid by the Plan and amounted to \$100,085 and \$79,239 for the period from January 1, 2023 through July 19, 2023 and year ended December 31, 2022, respectively.

NOTE 6 - TAX STATUS

The IRS has determined and informed the Company by a letter dated February 16, 2017, that the Plan and related trust were designed in accordance with applicable sections of the IRC. The Plan has been amended since the opinion letter was issued. The plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt. The Plan received an updated IRS Determination Letter dated April 2023, related to the termination of the plan, as noted in Note 1.

Plan management must evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of July 19, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

As a result of the Plan's termination in 2023, the Plan fully liquidated through a combination of lump sum distributions to eligible Plan participants who elected such payments, and the purchase of a group annuity contract from Principal, for all remaining liabilities. As a result, there are no future benefit obligations of the Plan.

NOTE 9 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through November 20, 2023, the date the financial statements were available to be issued and has determined that there were no subsequent events that have occurred through the date of the report that would require recognition or disclosure in the financial statements.
