**NOTE 1** DESCRIPTION OF PLAN

The following description of the G2O Technologies, LLC 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document or the Summary Plan Description for more complete information.

**GENERAL**

The Plan was established January 1, 2021 as a defined-contribution plan covering employees of G2O Technologies, LLC (Company), excluding nonresident aliens with no U.S. income, leased employees, residents of Puerto Rico, and union or collective bargaining employees with certain exceptions. Employees are eligible to participate provided the employee attains one month of service with the Company. Effective December 14, 2022, this Plan was merged with and into the USALCO, LLC 401(k) Retirement Savings Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participants and balances were transferred in from the Geo Specialty Chemicals, Inc. Savings Plan and the Gulbrandsen Companies Retirement Savings Plan in 2021.

**CONTRIBUTIONS**

Each year, participants may contribute a portion of their annual compensation, as defined in the Plan, subject to certain annual limitations in the Internal Revenue Code. Participants who turn 50 years old before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans. All eligible participants are automatically enrolled to make a 1% deferral, unless the participant requests otherwise.

The Company may make discretionary contributions in an amount to be determined by the Company for each Plan year. Contributions are subject to certain limitations.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contribution, an allocation of Plan earnings, and any Company contributions. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

**VESTING**

Participants are immediately vested in their voluntary contributions, employer qualified matching contributions, and employer discretionary contributions.

#### INVESTMENT OPTIONS

Upon enrollment in the Plan, participants may direct their contributions into various investment options offered by the Plan. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options at any time.

#### NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow against the balance in their account, up to a maximum of the lesser of 50% of their vested balance or \$50,000 and a minimum of \$1,000. Participants are limited to five loans in any 12-month period. Note terms require amortization of principal and interest over a period not to exceed five years. The notes receivable bear interest at a rate comparable to rates charged by commercial lending institutions for loans of similar terms.

#### PAYMENT OF BENEFITS

Upon retirement, death, disability, or termination of employment, a participant or beneficiary may elect to receive the value of the participant's account in a lump sum.

#### FORFEITED ACCOUNTS

At December 14, 2022, there were no forfeited non-vested accounts. These accounts will be used to reduce future Plan expenses and Company contributions in accordance with the Plan document.

#### ADMINISTRATIVE EXPENSES

Certain administrative expenses of the Plan are paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment-related expenses are included in the net change in investments.

### **NOTE 2** SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### ACCOUNTING STANDARDS CODIFICATION

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

**BASIS OF ACCOUNTING**

The accompanying financial statements are presented on the accrual basis of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**INVESTMENT VALUATION**

Investments are reported at fair value. See Note 3 for a discussion of fair value measurements.

**RISK AND UNCERTAINTIES**

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**SUBSEQUENT EVENTS**

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through November 8, 2023, the date the financial statements were available to be issued.

**NOTE 3 VALUATION OF INVESTMENTS**

Investments are recorded at fair value in accordance with the provisions under the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for

measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the Codification are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below are descriptions of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 14, 2022.

Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

Collective Trust: Valued using NAV. NAV is quoted on a private market that is not active; however, the unit price is based on underlying investments which are traded on an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5** TAX STATUS

The Plan was created based on a Principal Financial Group Prototype Savings Plan, which obtained its latest determination letter in June 30, 2020, wherein the Internal Revenue Service stated the Prototype Plan was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes the Plan is currently designed and operating in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions taken as of December 14, 2022.

**NOTE 6** RELATED-PARTY TRANSACTIONS

Certain Plan investments are managed by the Trustees of the Plan. The Plan paid \$4,080 to parties in interest for the period ended December 14, 2022. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

In addition, administrative fees were paid indirectly through revenue sharing and are included in the net depreciation in fair value of investments.

**NOTE 7** DELINQUENT DEFERRAL TRANSMITTALS

During the year ended December 14, 2022, the Plan Administrator failed to timely remit certain employee deferrals and the corresponding employer matches to the Plan aggregating to \$63,619. The Plan Administrator will compute the lost earnings on these deferrals. The Plan Administrator will then contribute the deferrals, matches, and lost earnings to the USALCO, LLC 401(k) Retirement Savings Plan.
