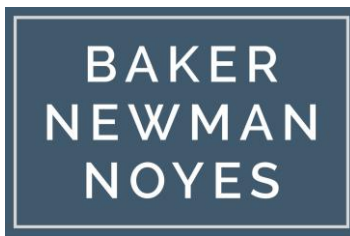

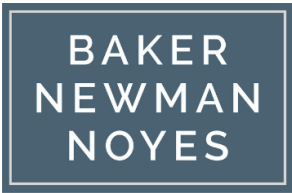

INDEPENDENT AUDITORS' REPORT

Plan Administrator and Participants
MaineHealth Care at Home 403(b) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of MaineHealth Care at Home 403(b) Retirement Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 13, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period ended March 13, 2023 and year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the period ended March 13, 2023 and as of and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate to the best of their knowledge.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note 1 to the financial statements, the Board of Trustees of MaineHealth Care at Home, the Plan's Sponsor, voted on November 8, 2022 to terminate the Plan. The Plan was frozen on January 1, 2023 and subsequently liquidated on March 13, 2023. As a result, the Plan has utilized the liquidation basis of accounting in presenting the 2023 and 2022 financial statements. Our basis of opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of reportable transactions for the period ended March 13, 2023, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

The following description of the MaineHealth Care at Home 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution 403(b) plan sponsored by MaineHealth Care at Home (the Sponsor). The Plan was subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA) and covered substantially all union employees of the Sponsor.

Eligibility

Employees became eligible to make salary deferrals on the first day of employment. Employees were eligible to receive employer matching and discretionary contributions upon the attainment of age 18.

Effective January 1, 2017, Plan eligibility was amended to include only union employees. Nonunion employees became eligible to participate in the MaineHealth 403(b) Retirement Plan.

Contributions

Contributions were made to participants' accounts as follows:

- Participants elected to defer up to the maximum percentage of compensation and dollar amount permissible under Section 402(g) of the Internal Revenue Code (the Code) not to exceed the limits of Code Sections 403(b), 404 and 415.
- The Sponsor matched 50% of the first 4% of compensation that the participant contributed to the Plan.
- The Plan allowed for employer discretionary contributions to the Plan on behalf of the Plan's participants. The percentage of compensation contributed varied depending on the Plan year. For the period ended March 31, 2023 and year ended December 31, 2022, no such contributions were made.
- Rollover contributions were subject to conditions stated in the Plan and in appropriate sections of the Code.
- Participants elected to have their employee deferral and their respective employer matching and discretionary contributions invested in various investments included in the Plan which have different investment objectives. Participants may have changed their salary reduction contribution and investment options at any time during the Plan year.

1. Description of the Plan (Continued)

Participant Accounts

Each participant's account was credited with the participant's contribution and allocations of the Sponsor's contributions and Plan earnings or losses. The benefit to which a participant was entitled was the benefit that was provided from the participant's vested account.

Vesting

Elective and rollover contributions were always fully vested and nonforfeitable. Employer matching and discretionary contributions were immediately vested.

Benefit Payments

Participants were entitled to a distribution of their vested benefits upon attaining age 59 1/2 or upon separation from service. The Plan also provided for distributions upon death or disability, as well as economic hardship subject to certain criteria set forth in the Plan document.

Notes Receivable From Participants

Notes receivable were measured at their unpaid principal balance plus any accrued but unpaid interest.

Participants could have borrowed from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Notes receivable terms ranged from one to five years for general purpose loans or up to ten years for the purchase of a primary residence. The notes receivable were secured by the balance in the participant's account and bore an interest rate of prime plus 1% at the date the loan was issued. As of March 13, 2023, there are no outstanding participant loans.

Administrative Expenses

The Sponsor was responsible for certain administrative costs of the Plan.

Plan Termination

On November 8, 2022, the Board of Trustees voted to discontinue all contributions to the Plan and management determined liquidation was imminent. The Plan was frozen effective January 1, 2023, and a blackout period was instituted. All amounts were distributed from the Plan during 2023 and were transferred to the MaineHealth 403(b) Retirement Plan and the MaineHealth Legacy 403(b) Plan.

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan have been prepared on the liquidation basis of accounting as described by accounting principles generally accepted in the United States of America for a terminating plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, liquidity and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

Investments and Income Recognition

Investments in mutual funds are reported at liquidation value at December 31, 2022, which is based on fair value. Investments in pooled separate accounts are stated at liquidation value at December 31, 2022, which is based on fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date (Note 5). The Lincoln Financial Group Fixed Annuity Contract and Stable Value Account are based upon liquidation value which equals contract value at December 31, 2022 (see Note 4).

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Interest income on notes receivable from participants is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022. If a participant ceases to make loan repayments and the Plan Administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Contributions

Employer match and employee deferrals were recorded during the period in which the associated payroll deductions were made. Employer discretionary contributions were recorded in the period in which the related service was performed. Employer contributions were invested in the same funds as the employee contributions.

Benefit Payments

Benefits were recorded when paid.

Subsequent Events

Events occurring after the statement of net assets available for benefits date are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through November 20, 2023 which is the date the financial statements were available to be issued.

3. **Information Certified by the Trustees**

All Plan asset information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants as of March 13, 2023 and December 31, 2022, and net appreciation (depreciation) in fair value, interest and dividends, and interest income on notes receivable from participants was obtained or derived from information provided to the Plan Administrator and certified as complete and accurate to the best of their knowledge by Lincoln Financial Group Trust Company, Inc. and Lincoln National Life Insurance Company, the trustees of the Plan, as of and for the period ended March 13, 2023 and as of and for the period ended December 31, 2022. Accordingly, as permitted under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the trustees, except for comparing such information certified by the trustees to information included in the Plan's financial statements and supplemental schedule.

4. **Investments**

The Plan maintained two group annuity contracts with Lincoln National Life Insurance Company (Lincoln). Only one of the contracts accepts current contributions. Account balances in the two contracts were credited with guaranteed rates of return. Once invested, the participant was limited under certain circumstances on certain transfers or withdrawals from the investment. In accordance with the provisions of accounting for *Fully Benefit-Responsive Investment Contracts*, both contracts are considered to be fully benefit-responsive by the Plan Administrator; accordingly, the contracts were stated at contract value (which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses).

4. Investments (Continued)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract provided a promise to pay interest at crediting rates that were announced in advance and guaranteed for a specific period of time as outlined in the contract. The interest crediting rates were determined by Lincoln based on a specific formula tied to a current market index as outlined in the contract and were not based on the performance of the assets which back the investment contract. Such interest rates were reset quarterly.

Certain events limit the ability of the Plan to transact at contract value with the insurance company under the group annuity contract and the stable value account. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures, or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value with participants is probable. The direct transfer of assets to the MaineHealth Legacy 403(b) did not limit the ability to transact at contract value.

5. Fair Value Measurements

Fair value is the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability. The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity.

The fair value hierarchy for valuation inputs prioritizes the inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Each fair value measurement is reported in one of the three levels which is determined by the lowest level input that is significant to the fair value measurement in its entirety. These levels are:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

5. Fair Value Measurements (Continued)

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the net asset value of shares (based upon quoted market prices) at year end.

Pooled separate accounts: Valued based upon net asset value as determined by the trustees using the market prices of the underlying assets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with ASU 2015-07, certain investments measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy.

The Plan's assets carried at liquidation value, which is based on fair value in 2022, include Level 1 mutual funds of \$3,564,105 and pooled separate accounts, measured at net asset value, totaling \$278,486 at December 31, 2022.

There are no unfunded commitments associated with the pooled separate accounts. Redemption is allowed on a daily basis with these investments. These funds target asset allocations which seek a balance of growth and income.

6. Tax Status

Effective March 1, 2004, the Plan adopted a volume submitter plan sponsored by Lincoln Financial that was subsequently restated effective March 31, 2020. The restatement did not result in any significant changes to the Plan provisions and the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of March 13, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party-in-Interest Transactions

The Plan invested in certain investments which were managed by Lincoln Financial Group (the Plan's recordkeeper and trustee). Therefore, transactions with this party qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA. Certain fees incurred by the Plan are paid through revenue sharing, rather than direct payments. Notes receivable from Plan participants, the related interest income and transactions are also considered party-in-interest transactions.
