- Draft response to DOL or IRS letters because of missing CPA audit report – Hourly, minimum fee \$500
- Supply records to DOL due to a DOL subpoena – Hourly, minimum fee \$500
- Follow-up fee - \$200 per month on the first of each calendar month starting December 1, 2023, for which the filing is incomplete. This fee will continue to be charged until the complete 5500 including a CPA audit is filed, our engagement ends, or something else is negotiated in writing.

Penalty Information

The DOL can assess a penalty of up to \$2,568 a day for each day a plan administrator fails or refuses to file a complete return. The IRS may separately assess penalties of \$250 per day up to \$150,000 per late return.

We urge plans to file a complete Form 5500 with CPA audit report as soon as possible no matter which option they choose.

Additional information on Option 1

You may choose to file an incomplete return by the October 16, 2023, deadline without the audit report attached. When the DOL detects that an audit report is not attached, the DOL typically sends out a letter giving the employer 45 days (about 1 and a half months) to file a complete 5500 return. If the plan does not respond within that time, the DOL will issue a “notice of intent to assess a penalty” letter. It informs the plan administrator that penalties will be assessed in 30 days (about 4 and a half weeks) unless it can be demonstrated that a complete and accurate Form 5500 was timely filed. If not, the plan administrator’s only option is to negotiate a reduced penalty based on the facts and circumstances. This must be done during the 30-day period after the notice is received.

The DOL instructs that Part III, Line 3 of Form 5500 Schedule H must be completed accurately even if an audit report is not attached. This means that questions 3(a) and 3(b) would be left blank because the audit is not yet complete. If the plan has a signed engagement agreement or contract with an audit firm to complete the audit, line 3(c) would reflect that auditor’s information. If the plan has not officially hired an auditor yet, line 3(c) would be left blank as well.

You are not eligible for the DFVCP once you file an incomplete Form 5500, so you would potentially be subject to the unreduced penalties described above if you are unable to timely respond when the DOL contacts you regarding the missing audit. Thus, time is of the essence in getting the CPA audit report completed and Form 5500 filed.

This option is popular with CPA auditors who believe that the audit will be completed within 90 days (about 3 months). We do note that of our clients who did not timely file a 2021 Form 5500 because of a missing CPA report, less than 30% filed a Form 5500 with a completed report within 90 days (about 3 months) of the fully extended deadline.

Additional Information on Option 2 - DFVCP

You may choose to not file your 5500 by the October 16, deadline and utilize the DOL’s Delinquent Filer Voluntary Compliance Program (DFVCP) once the audit is complete, and the Form 5500 can be filed. Assuming the DOL does not initiate enforcement action before the Plan files under DFVCP, using the DFVCP has the advantage of assessing a limited sanction to file the return late. The DOL penalty to use the DFVCP is \$10 per day late (calculated from the original filing deadline of July 31, 2023) up to a maximum of \$2,000.

You are not eligible for the DFVCP once the DOL sends you an enforcement letter regarding the missing Form 5500, so you would potentially be subject to the unreduced fee described above. Thus, time is of the essence in getting the CPA audit report completed and Form 5500 filed.



An IRS notice or a DOL reminder email does not invalidate eligibility for DFVCP.

What does Nova recommend?

As a policy matter for the 2022 plan year, Nova has decided not to give advice about choosing between two non-compliant options, and it is not clear to us which option is lower risk.

If you believe that the late CPA report is due to staffing issues at your auditor’s firm, it would be reasonable to consider this as a factor in choosing an auditor next year or when negotiating contract terms next year.

We note that Option 1 is the preferred approach of the CPA firms to whom we speak. Antidotally, Option 2 is more popular among professionals who are not CPAs (Certified Public Accountants).

Nova Fees

Our regular fees contemplate timely filing of Forms 5500, and do not contemplate:

- Additional follow-up to clients and auditors after October 16, 2023.
- Any of our staff working on Form 5500 issues between January and March of the following year, which is our busiest time of year.

Thus, it is necessary for us to charge additional fees to clients who do not file their Form 5500 on time so that we can keep our fees as reasonable as possible for our clients overall.

DOL Contact Time

Nova has no special insight into what DOL enforcement activities will be for 2022 or for future filing years. Past enforcement practices are not necessarily predictive of future enforcement actions. The DOL receives Form 5500s electronically and if the DOL chooses to do so, the DOL could theoretically launch enforcement actions within weeks.

In the recent past, the DOL seems to have focused more on encouraging compliance rather than punitive enforcement actions. The AICPA has been discussing staffing shortages with the DOL and the DOL seems sympathetic to this issue. To the best of Nova’s knowledge, the DOL has not ever officially stated that filing without an audit report is the DOL’s preferred option in this circumstance. However, DOL FAQ (Frequently Asked Questions) 25 regarding Form 5500 filings acknowledges that this option exists. And some DOL commentary at AICPA meetings seems favorable to this approach. Regarding missing Form 5500 filings, in February 2023, the Chief of DOL’s Division of Reporting Compliance sent over 20,000 personal emails to plans who seemed to be missing a Form 5500 filing. The email was a reminder and is not considered an enforcement action so employers receiving this email are still eligible to participate in the DFVCP.
