My name is Sherry Roethig and I am the office manager for Michel Framing LLC. I am writing to you about the form 5500 that we requested an extension of time on. The company Michel Framing LLC. shut down operations in September of 2022. For the year ending 2022 the company filed taxes through our CPA and whatever forms our payroll service provider filed. When closing out the 401k plan/services to our employees, I sent out the notice of termination to all who were enrolled in the plan. I had 3 people file for a disbursement and receive payment. The rest of the employees either did not act on their notices or reply. Several of the mailed notices came back to the office and returned to us by USPS postal service. The same with W-2 notices, many came back to us in the mail. The reason for late filing was due to the company non operating and my own assumption and inexperience dealing with taxes and forms. I assumed that the payroll company or our CPA had filed all necessary forms in our interest. I am however willing to do whatever is needed to resolve this issue asap.
