We have performed audits of the financial statements of the Diamond Healthcare Corporation 401(k) Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of April 19, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period ended April 19, 2022, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of April 19, 2022 and December 31, 2021, and for the period ended April 19, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

## **Notes to Financial Statements**

### **1. Description of Plan**

The following description of the Diamond Healthcare Corporation 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

#### ***General***

The Plan is a defined contribution plan covering all employees of Diamond Healthcare Corporation (the “Company”) who have attained age eighteen or older and two months of service. The Diamond Healthcare Corporation 401(k) Plan Committee of the Board of Directors of the Company controls and manages the operation and administration of the Plan. Effective June 18, 2021, Principal Life Insurance Company (“Principal”), a qualified institution, serves as the trustee of the Plan. Prior to June 18, 2021, Wells Fargo Bank, N.A. (“Wells Fargo”), a qualified institution, served as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

On March 27, 2020, the Coronavirus Aid, Relief and Economic Security (CARES) Act was passed by Congress. The CARES Act, among other things, includes several relief provisions available to tax qualified retirement plans and their participants. Plan management evaluated the impact of the CARES Act on the Plan and adopted several provisions related only to 2020 regarding the expansion of allowed Plan distributions, the repayment of loans and the suspension of required minimum distributions. The Plan will be formally amended by the required date of December 31, 2025.

#### ***Merger***

Effective April 19, 2022, the Plan was merged into an affiliate’s 401(k) Plan, and all of the assets of the Plan were transferred by the trustee to the affiliate’s 401(k) Plan. Participants in the Plan were credited with account balances under the affiliate’s 401(k) Plan, immediately following the merger, which were equal to their account balances under the Plan immediately prior to the merger.

#### ***Contributions***

Each year, participants may contribute up to 100 percent of their pre-tax annual compensation, as defined in the plan document, subject to Internal Revenue Code (“IRC”) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless affirmatively electing not to participate or electing to contribute another amount. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. The auto-deferral rate increases annually by 1% until a maximum of 10% is reached. The Company provides a discretionary matching contribution of 25% of the first 4% of the participant’s salary each pay period. The Company may also provide a discretionary nonelective contribution. There were no discretionary nonelective contributions made in 2022. Contributions are subject to certain limitations.

#### ***Investment options***

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers mutual funds and a stable value collective trust fund as investment options for participants.

***Participant accounts***

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions, and plan earnings (losses), and charged with benefit payments, transaction fees related to notes receivable from participants and distributions, and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions plus earnings thereon is based on years of service. A participant is 20 percent vested after one year of credited service and 100 percent vested after five years of credited service.

***Notes receivable from participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. As of April 19, 2022, the outstanding loans were transferred to the surviving Plan of the Plan merger transaction. Principal and interest were paid ratably through payroll deductions.

***Payment of benefits***

On termination of service, death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or various installment and annuity options as provided by the Plan. In-service distributions are available from all fully vested sources after the participant reaches the age of 59.5 years or if a participant satisfies conditions of a financial hardship.

***Forfeitures***

At April 19, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$349,146, respectively. Forfeitures may be used to pay Plan expenses or to reduce Company contributions. During 2022, there were no forfeitures used to pay Plan expenses or reduce Company contributions. The balance of unused forfeitures were transferred into the merged Plan.

**2. Summary of Significant Accounting Policies**

***Basis of accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Investments valuation and income recognition***

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustees. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes receivable from participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Payment of benefits***

Benefits are recorded upon distribution.

***Administrative expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant's account.

***Subsequent events***

The Plan has evaluated subsequent events through October 5, 2023, the date the financial statements were available to be issued.

**3. Fair Value Measurements**

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1:** Observable inputs such as quoted prices in active markets.
- Level 2:** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3:** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at April 19, 2022 and December 31, 2021. The following is a description of the valuation methodologies used for assets measured at fair value:

**Mutual funds**

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the individual securities are traded.

**Stable value collective trust fund**

The Plan invests in a stable value collective trust fund for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the NAV per share provided by the trustees as a practice expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the stable value collective trust fund, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. The stable value collective trust funds are not required to be classified within a level on the fair value hierarchy.

**5. Exempt Party-In-Interest Transactions**

Certain Plan investments are units in funds managed by Principal. Fees paid by the Plan for investment management services were included as a reduction of the return on each fund. Fees paid to the trustees by the Plan for administrative services were \$10,249 the period ended April 19, 2022.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

## **7. Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (the “IRS”) stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval of the volume submitter plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated March 31, 2014 that the volume submitter plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of April 19, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **8. Risks and Uncertainties**

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

## **9. Non-Exempt Party-In-Interest Transactions**

There were unintentional delays by the Plan Sponsor in submitting participant’s loan payments to the custodian in the amount of \$6,746. These delinquent contributions constitute prohibited transactions.
