Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Vanguard Resources, Inc. Employees 401(K) Retirement Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets as of April 30, 2022 (in liquidation) and net assets available for benefits as of December 31, 2021 (ongoing), and the related statement of changes in net assets in liquidation for the period from January 1, 2022 to April 30, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) Audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of April 30, 2022 and December 31, 2021, and for the period from January 1, 2022 to April 30, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with U.S. generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 and Note 9 to the financial statements, the Plan Sponsor of Vanguard Resources, Inc. Employees 401(K) Retirement Plan elected to terminate the Plan effective February 2022, and management determined that liquidation was imminent. As a result, the Plan changed its basis of accounting from the ongoing basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter. All assets were distributed from the Plan by the end of April 2022. See Note 9 for further discussion.

1. DESCRIPTION OF THE PLAN

The following description of Vanguard Resources, Inc. Employees 401(K) Retirement Plan (the “Plan”) provides general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering certain classifications of employees of Vanguard Resources, Inc. (the “Company” or “Employer”) who have completed at least six months of service within the first year of employment and are at least 18 years of age. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Plan assets were held in trust and administered by National Life Group (“Trustee”). Effective March 31, 2021, the Plan discontinued contributions to the Plan and started a new defined contribution plan for current employees.

As a result, Plan management approved the termination of the Plan and its relationship with National Life Group (“Trustee”) effective February 2022. All funds held by participants with National Life Group were either paid directly to participants or transferred into individual retirement accounts in the name of the participant and independent of the Plan. See Note 9 for further discussion. The description of the Plan below is qualified in its entirety by the termination of the Plan.

Contributions – An eligible Participant may authorize the Company to withhold from one percent up to 100% of their eligible compensation not to exceed the annual limit established by the Internal Revenue Service. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participant contributions are invested in accordance with investment directions provided to the Trustee by each participant. Effective April 1, 2021, no further contributions were made to the Plan.

Employer Contributions – Effective January 1, 2011, the Plan Sponsor adopted the safe harbor provisions as promulgated by the Internal Revenue Service and the Department of Labor. Prior to April 1, 2021, Participants were matched 100% on all participant contributions up to 4% and 50% of all participant contributions up to 6% of eligible compensation. Contributions are subject to certain IRS limitations. Effective April 1, 2021, no further employer contributions were made to the Plan.

Participant Accounts – Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contribution and (b) Plan earnings, which are allocated proportionately among all participants based on their investment in each fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon and employer contributions made under the basic safe harbor matching effective in 2011. Effective February 1, 2022, as part of the Plan termination, all participants will become 100% vested in their Company profit-sharing and discretionary employer matching contributions.

1. DESCRIPTION OF THE PLAN (continued)

Payment of Benefits – Upon retirement age, a participant may elect to receive a lump-sum amount equal to the value of his or her account. Upon termination, a Participant’s vested balance may be rolled into a qualified plan or distributed in a lump sum payment. If a terminated participant has less than a \$5,000 vested interest and does not elect a distribution method for the termination benefit, the participant’s balance will be distributed in accordance with Plan provisions.

Withdrawals – Withdrawals during employment are permitted under certain circumstances. There are two types of withdrawals: hardship and non-hardship. A hardship withdrawal is available under limited circumstances, which the participant must document. A non-hardship withdrawal is available under certain circumstances, depending on the participant’s age, length of Plan participation, and/or type of account or sub-account involved.

Forfeited Accounts – Forfeited balances of terminated participants’ non-vested accounts are used to reduce future Company contributions or to pay Plan expenses. The Plan did not have a balance in the forfeiture account for the period from January 1, 2022 to April 30, 2022, and for the year ended December 31, 2021.

Administrative Expenses – Annual plan expenses are charged to each participant and consist of both a base administration charge distributed pro-rata to each participant and an annual fee charged per participant. Additionally, each participant is charged a pro-rata amount of the monthly variable asset charge which is based on total plan assets. Fees associated with specific transactions (loans, distributions, etc.) are also charged to the participant as incurred. All fees are deducted from the participants account as the fees are assessed.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – As discussed in Note 9, in February 2022, the Company elected to terminate the Plan, subject to provisions set forth in ERISA. As a result, the Plan changed its basis of accounting for the period subsequent to December 31, 2021 to the liquidation basis of accounting in accordance with U.S. generally accepted accounting principles (“GAAP”). Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process, and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process. As of December 31, 2021, remaining administrative expenses and interest income through liquidation were estimated by management and recorded in the Plan’s financial statements. All assets of the Plan were liquidated by April 30, 2022.

Use of Estimates – The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value, except for fully benefit responsive contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Investment Committee determines the Plan’s valuation policies utilizing information provided by the investment advisors and insurance company. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Non-fully benefit responsive contracts are reported at net surrender value which represents fair value. The net surrender value equals the accumulated cash contributions, plus interest credited, less surrender fees and withdrawals. These fixed individual annuity contracts are fully guaranteed by the life insurance company, National Life Group. Participants with assets held in annuity contracts may be subject to surrender fees if they elect to terminate the contract. Surrender fees range from 0% - 10% based on when the contract was purchased and the number of years the contract has been in effect. As of December 31, 2021, surrender fees, in the event of full termination, totaled \$153,765.

Payment of Benefits – Benefits are recorded when paid.

Risks and Uncertainties – Financial instruments which potentially subject the Plan to concentrations of credit risk consist primarily of securities in which the Plan invests. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the near-term could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Recently Adopted Accounting Pronouncements – The Plan adopted Accounting Standards Update No. 2013-07, “*Presentation of Financial Statements – Liquidation Basis of Accounting*”, which provides clarifying guidance for the liquidation basis of accounting, effective January 1, 2022. The adoption did not have a material effect on the financial statements, other than adding additional disclosures regarding the Plan’s termination and related liquidation of Plan assets, for the year ended December 31, 2022.

3. PARTY-IN- INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. Accordingly, transactions conducted by the trustee and custodian, National Life Group, and the Plan Sponsor, qualify as party-in-interest transactions. However, these transactions are exempt from the prohibited transactions rules under ERISA.

Fees paid by the Plan for the services provided by the Trustee amounted to **\$3,079** for the period from January 1, 2022 to April 30, 2022. All other plan administrative fees were paid directly by the Plan Sponsor for the period from January 1, 2022 to April 30, 2022.

4. INFORMATION CERTIFIED BY TRUSTEE – UNAUDITED

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee has certified to the Plan Administrator that the listing of investments (stated at fair value), together with all other transactions related to those investments, are complete and accurate as of April 30, 2022 and December 31, 2021, and for the period from January 1, 2022 to April 30, 2022. No auditing procedures were performed with respect to this information, except for comparing such information certified by the trustee with the related information included in the financial statements.

6. INCOME TAX STATUS

The IRS has determined and informed the Plan Administrator by a letter dated March 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Trustee believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of April 30, 2022 and December 31, 2021 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2019.

7. FIDELITY BOND

The Plan was covered by a fidelity bond for the period from January 1, 2022 to April 30, 2022, and for the year ended December 31, 2021, which was within the prescribed limits as set forth by the ERISA.

8. FAIR VALUE OF FINANCIAL INSTRUMENTS

FASB Accounting Standards Codification 820 (“FASB ASC 820”), “*Fair Value Measurements and Disclosures*”, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs – Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 Inputs – Inputs to the valuation methodology are other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly. These include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, inputs other than quoted prices that are observable for the asset or liability (for example, interest rates, volatilities, prepayment speeds, loss severities, credit risks and default rates) or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 Inputs – Significant unobservable inputs that reflect an entity’s own assumptions that market participants would use in pricing the assets or liabilities.

A description of the valuation methodologies used for assets and liabilities measured at fair value, as well as the general classification of such instruments pursuant to the valuation hierarchy, is set forth below. The Plan Administrator determines fair value based on quoted market prices, where available. If quoted prices are not available, fair value is estimated based upon other observable inputs. The Plan Administrator uses unobservable inputs when observable inputs are not available. Adjustments may be made to reflect the assumptions that market participants would use in pricing the asset or liability.

Fixed Annuity Contracts – Non-fully benefit responsive contracts are reported at net surrender value which represents fair value. The net surrender value equals the accumulated cash contributions, plus interest credited, less applicable surrender fees and withdrawals. These contracts are Level 3 since they use an entity’s own assumptions that market participants would use in pricing the contracts.

As of April 30, 2022, the Plan held no investments. The following table presents information about the Plan’s assets measured at fair value on a recurring basis and indicates the fair value hierarchy of the inputs utilized to determine those fair values as of December 31, 2021:

9. PLAN TERMINATION

Effective February 2022, the Plan Sponsor elected to terminate the Plan and distribute all assets from the Plan. In accordance with the Plan document, the account of each participant became fully vested to the extent then funded. Participants were notified of the termination and given the election to receive direct payouts or rollover their funds into a qualified retirement plan. For non-responding participants, their funds were automatically rolled into a traditional individual retirement account with National Life Group. All assets were distributed from the Plan by the end of April 2022.

10. SUBSEQUENT EVENTS

The Plan Sponsor has performed a review of subsequent events through October 3, 2023, which is the date the financial statements were available for issuance, and concludes there were no events or transactions occurring during this period that required recognition or disclosure in the financial statements. Any events occurring after this date have not been factored into the financial statements being presented.
