To the Participants and Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Binkley & Barfield, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTES TO THE FINANCIAL STATEMENTS

Note A - Description of the Plan

The following description of the Binkley & Barfield, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was established effective April 1, 1989 as a defined contribution plan for the benefit of eligible employees of Binkley & Barfield (the “Company”). The Plan is subject to the provisions of the Employee Income Security Act of 1974 (“ERISA”).

Administration

The Company has appointed Principal Financial Group (the “Custodian”) custodian and recordkeeper of the Plan.

Eligibility

Employees of the Company who have attained the age of 21, are generally eligible to participate in the Plan after satisfying the age requirement. The entry date of the Plan for eligible participants is on the first day of the calendar quarter following the date that a participant first satisfies the age requirement.

Contributions

Each year participants may contribute a percentage of their pre-tax annual compensation not to exceed the limitation (\$20,500 and \$19,500 in 2022 and 2021 respectively) set forth in Section 402(g) of the Internal Revenue Code (“IRC”). Participants may make after-tax Roth contributions. Participants who are (or will be) age 50 or older by the end of the calendar year may make pre-tax catch-up contributions that exceed the annual elective deferral limit. Participants’ total catch-up contributions during 2022 and 2021 cannot exceed \$6,500 and \$6,500, respectively.

The Company may contribute a discretionary matching contribution. During 2022, the Company made a discretionary matching contribution of \$545,139.

The Plan also provides for discretionary Company profit sharing contributions. During 2022, the Company made no discretionary employer profit sharing contributions.

Note A - Description of the Plan, continued

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution and an allocation of any non-elective contribution and earnings (losses) on the investments selected by the participant. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested interest in his or her account.

Investment Options

Upon enrollment in the Plan, participants may direct the investment of their contributions and the Company's contributions into various investments offered by the Plan.

Vesting

Participants are vested immediately in their elective contributions and rollover contributions plus any earnings on such contributions. The vesting of discretionary Company contributions plus any earnings thereon is based on years of continuous service (as defined) accrued by the participant while in covered employment. Participants become 100% vested on a six-year graded vesting schedule.

Participant Loans

Participants may borrow from their accounts on a pro-rata basis from all contribution sources up to a maximum equal to the lesser of \$50,000.00 or 50% of the participant's vested account balance. Loan terms must not exceed five (5) years unless the loan is to be used in the financing of the participant's homestead in which case the loan may be payable in terms of similar length provided by conventional lending institutions. The loans are secured by the vested balance in the participant's account and bear interest rates ranging from 4.25 to 8.00 percent. Principal and interest payments are made by means of payroll withholdings according to the terms of the promissory note. A participant may have only one loan outstanding at any time.

Participant Investment Rollovers

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

Payment of Benefits

Upon termination of employment due to death, disability, attainment of age 59 ½ or retirement a participant (or his/her designated beneficiary in the event of death) may elect to receive a lump-sum amount. For termination of employment due to other reasons, the vested interest in his or her account may be distributed as rollover to another plan, a lump-sum distribution or it may be left in the Plan if the account balance is greater than \$1,000.

Note A - Description of the Plan, continued

Forfeited Accounts

All employer contributions credited to a participant's account, but not vested, are forfeited by the participant upon his/her termination from the Plan. Per the Plan document forfeitures may be used to first reduce the Company's contributions and then to offset future employer contributions. As of December 31, 2022, there were no forfeitures that have not yet been applied.

Administrative Expenses

In 2022 the plan was primarily responsible for payment of fees. Such expenses paid by the participants during year ended December 31, 2022 were approximately \$95,466.

Note B - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amount of net assets available for the benefits and changes therein. Actual results could differ from those estimates.

Risk and Uncertainties

The Plan provides for various investment options. These investment options are exposed to market risk, which generally means the risk of loss in the value to certain investment securities due to changes in interest rates, commodity prices and general market conditions. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

Investment Valuation and Income Recognition

Investments are stated at fair value, which is determined using quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Investments in money market funds are valued at amortized cost, which approximates fair value. Net appreciation

Note B - Summary of Significant Accounting Policies, continued

(depreciation) in fair value of investments includes realized gains and losses on investments bought and sold during the year and unrealized appreciation (depreciation) of investments held at the end of the year.

The Plan offers investments in mutual funds and guaranteed investments contracts (GIC's). Mutual funds are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The guaranteed investment contract is equal to participant deposits minus participant withdrawals plus credited interest. Interest credited is net of expenses. Contract value may be subject to market value adjustments in connection with contract holder directed withdrawals or under limited circumstances for certain in-service participant withdrawals. Investments in fully-benefit responsive investment contracts are reported at contract value as discussed in Note C.

Subsequent Events

The Plan has evaluated subsequent events through December 1 2023, the date which the financial statements were available to be issued. No events have occurred subsequent to the date of the statement of net assets available for benefits that would require adjustment to, or disclosure in, the financial statements.

Contributions

Contributions from employees and the Company are recorded in the period in which the Company makes the payroll deductions from participant accounts.

Note C - Guaranteed Investment Contract with Principal Life Insurance Company

During 2022, the Plan had a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company ("PLIC"). Due to the merger (see note J) the year-end balance was in the amount of \$0.

A Guaranteed Interest Balance is established in connection with each applicable Rate Schedule and treated in accordance with its applicable Rate Schedule.

On any date, the value of a Guaranteed Interest Balance equals the sum of the Deposits to it, minus any payments, transfers, applications, or fees with respect to that Guaranteed Interest Balance on or before such date, plus any interest at its Guaranteed Interest Rate.

PLIC credits interest from the day after a Deposit is accepted until the date payment, transfer, or application occurs. If a payment, transfer, or application is less than the full value of the Guaranteed Interest Balance, then PLIC will cease crediting interest to the amount to be paid, transferred, or applied on the date such payment, transfer, or application occurs.

Note C - Guaranteed Investment Contract with Principal Life Insurance Company, continued

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by PLIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) Any representation to us by the Plan Sponsor becomes untrue, in a manner that materially affects our obligations or risks under this Contract, or the Plan breaches any material obligation under this Contract. (2) Any entity acting as an agent on behalf of a Plan, where such agent is unaffiliated with us, either (i) fails to provide any information which we reasonably request to perform our obligations and such failure is not remedied within 30 days, or (ii) fails to provide Participant records that, in our reasonable judgement, are necessary to confirm Benefit Events and transfers have been processed according to the terms of this Contract and such failure is not remedied within 15 days. (3) Communications to Participants from an employer, Participating Employer, Plan Sponsor, Plan fiduciary, or person acting on behalf of or pursuant to an understanding or agreement with the Participating Employer, Plan Sponsor or Plan fiduciary that influence Participants to withdraw or transfer all or a portion of Participants' Interests; however, communications to Participants of factual historical information that influence Participants to withdraw or transfer all or a portion of Participants' Interests will not be considered an early termination event. (4) Adoption of an amendment to a Plan, any change in practices, or any change in Participant withdrawal rights under a Plan that we reasonably determine may be materially adverse to our obligations under this Contract, unless we Announce to you that such change is acceptable. (If PLIC receives a detailed description of any amendment to a Plan, change in practices, or change in Participant withdrawal rights under a Plan prior to implementing such change, we will make a reasonable effort to review the description and announce within 30 days whether such change would be considered an early termination event). (5) The Plan Sponsor retains a Recordkeeper other than

Principal Life Insurance Company and we determine there has been a misrepresentation of the Recordkeeper's enforcement of the Equity Wash.

Note D - Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use to unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2022 and 2021.

Mutual funds: Valued at the net asset value (NAV) of shares held by the plan at the end of the year.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the

Note F – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note G – Tax Status

The IRS has determined and informed the Company's document provider by an opinion letter dated March 31, 2008, that the Volume Submitter Profit Sharing Plan with CODA is acceptable under section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. Although the Plan has not received a determination letter and has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been made in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note H – Party-in-Interest Transactions

The plan invests in participant loans. These transactions qualify as party-in-interest transactions. However, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

Certain Plan investments are funds managed by the Trustee and the Custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services and certain administrative fees related to the related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest transactions.

Note I – Prohibited Transaction

Due to an administrative error, there were participants that were not auto-enrolled in a timely manner. This is prohibited by the terms of the Plan document. Management has determined that the impact of this error is immaterial on the financial statements of the Plan. This failure was discovered and does not extend more than 9 ½ months after the end of the plan year of the failure and management is self-correcting this failure through the Self-Correction Program as set out in procedures in section 3.02(1) of Rev. Proc. 2013-12.

Note I – Benefit Claims Payable

At December 31, 2022 and 2021, there were no requested distributions that had not been paid.

Note J – Plan Merger

Binkley and Barfield, Inc. was acquired by DCCM, LLC and the Binkley and Barfield, Inc. 401(K) Plan was merged into the DCCM, LLC 401(k) plan.
