## INDEPENDENT AUDITOR'S REPORT

### To the Plan Administrator of Lecom Profit Sharing Plan

We have performed audits of the financial statements of Lecom Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Management has obtained a certification from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

- The information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audits* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTES TO FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2022 AND 2021

#### **NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Lecom Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering substantially all employees of Lecom, Inc. (“Employer”), who are age twenty-one or older and who have completed one year of service on a monthly basis. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### **Contributions**

Each year participants may contribute a portion of eligible compensation as defined in the Plan, subject to Internal Revenue Service limitations. Participants who attained the age of 50 during the plan year may also make pretax catch-up contributions. Salary deferrals consist of pre-tax and/or Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualifying defined benefit or defined contributions plans (rollover). The Company may also, at the discretion of the board of directors, make discretionary contributions and/or discretionary matching contributions to the Plan based on the participants’ elective deferrals. The Company did not make any of the discretionary contributions in 2022 and 2021.

##### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of the Employer contributions and Plan earnings thereon.

##### **Vesting**

All participants are immediately vested in their contributions and safe harbor contributions plus actual earnings thereon. Vesting in the Company's employer match and profit sharing contributions is based on years of services as defined by the Plan document. A participant is 100% vested after two years of credited service.

##### **Forfeitures**

Forfeitures attributable to terminated participants’ non-vested accounts are allocated to a forfeiture account and are to be used to either pay for certain plan expenses or reduce employer contributions. As of December 31, 2022 and 2021 forfeited non-vested accounts were \$13,999 and \$6,899, respectively. During the year ended December 31, 2022 forfeitures used to fund employer matching contributions and plan expenses amounted to \$3,027.

##### **Investment Options**

Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options offered by the Plan.

##### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes receivable are secured by the balance in the participant’s account and bear interest at rates that are commensurate with local prevailing rates, as determined by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deductions.

### **NOTE 1 – DESCRIPTION OF PLAN - Continued**

#### **Administrative Expenses**

The Plan pays the administrative expenses. These expenses include professional, custodian, bookkeeping, and other administrative expenses incurred by the Plan. Fees paid by the Plan for the administrative expenses amounted to \$3,952 for the year ended December 31, 2022.

#### **Payment of Benefits**

The benefit to which a participant is entitled is that which can be provided from the participant's vested account. The Plan provides retirement benefits for participants at the normal retirement age or later if the participant desires to continue employment. Benefits are also payable to participants or their designated beneficiaries upon, death, disability or other limited circumstances of the participant. The Plan also allows for in service withdrawals of Employer matching and fully vested profit sharing distributions after the attainment of normal retirement age.

### **NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

#### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

#### **Investment Valuation**

The Plan's investments are stated at fair value. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### **Risks and Uncertainties**

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Subsequent Events**

Subsequent events have been evaluated through October 31, 2023, which is the date the accompanying financial statements were available to be issued.

### NOTE 3 – INFORMATION CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company (American Funds), the custodian of the plan as of December 31, 2022 and 2021 has certified the completeness and accuracy of the investment information. This includes the investment information reflected in the accompanying statements of net assets available for benefits, the statement of changes in net assets available for benefits and the schedule of assets (held at end of year).

### NOTE 4 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust: Investments are measured at net asset value provided by the Administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is not a publicly traded quoted price in an active market but is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 5 – RELATED PARTY TRANSACTIONS

Plan investments are shares of mutual funds and fixed income accounts managed or issued by American Funds. American Funds is the custodian as defined by the Plan, and therefore, these transactions qualify as exempt party-in-interest transactions. Fees incurred by the Plan for investment management and recordkeeping services are deducted from net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

The Plan also paid certain fees for third party administration for the year ending December 31, 2022. The Company will incur most administration, legal and accounting expenses associated with the Plan. Notes receivable from participants represent a portion of the Plan's receivables. All of the above transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

### NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination participants will become 100% vested in their accounts.

### NOTE 7 - TAX STATUS

The Plan is based on a Prototype Non-standardized Profit Sharing Plan with CODA, which received an opinion letter from the Internal Revenue Service (IRS) dated April 2, 2012, stating that the Plan was designed in accordance with the provisions of the Internal Revenue Code (IRC). The Plan has not filed for its own determination letter from the IRS. The Prototype Non-Standardized Profit Sharing Plan has been amended since the date of the opinion letter. However, Plan management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and is exempt from taxation under the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
