Normal Retirement Date: The later of attained age of 65 or the date five years after plan entry date, but no later than 70.

Normal Retirement Benefit: The Accrued Benefit described above payable at Normal Retirement Date.

Normal Form of Benefit: Life annuity, or, if married, an actuarially equivalent 50% joint & survivor annuity.

Early Retirement Date: The first day of the month after age 55 with at least 5 years of vesting service for Idaho Veneer and 10 years of vesting service for Ceda-Pine Veneer.
