Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Klingner Employee Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Notes to Financial Statements

1. Description of Plan

Transfer of Plan Assets

Effective September 21, 2023, the Klingner Employee Profit Sharing Plan (the "Plan") was terminated and all of the assets held by the Plan were transferred to Klingner & Associates, P.C. Retirement Plan, an existing plan held by the same Plan Sponsor.

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that was established pursuant to a trust agreement effective January 1, 2019. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

An employee is eligible to participate in the plan upon meeting the age requirement of 21 years old and 1 year of service (1,000 hours). Entry dates are semiannually on January 1 and July 1.

Employer Contributions

The contributions made to the Plan by Klingner & Associates, P.C. (the "Company") are determined annually by the Board of Directors and are deposited by the Company prior to the due date of the corporate income tax return. Allocation of the employer contribution is based on plan compensation of participants. For the period ended September 21, 2023 and the year ended December 31, 2022, the Company did not make a profit sharing contribution to the Plan.

Employee Contributions

Participants may not make contributions to the Plan.

Participant Accounts

Each participant's account is credited with the allocations of (a) the Company's contribution, and (b) Plan earnings less expenses. Allocations are based on participant compensation paid during the Plan year for the Company's contribution and account balances for Plan earnings. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Vesting in the Company's contributions is based on years of service. Participants are 100% vested in the Company's contributions after six years of credited service.

Payment of Benefits

Upon termination of service, disability, or death, a participant with a vested account balance may receive a distribution equal to the value of the participant's vested interest in his or her account in the form of five annual installments.

Forfeitures

Forfeitures of contributions will be used as an additional discretionary employer contribution. During the period ended September 21, 2023 and the year ended December 31, 2022, \$-0- and \$12,870, respectively, of forfeitures were allocated back to participants.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through December 5, 2023, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

3. Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

Money Market, Mutual Funds and EFTs

Valued at the daily closing price as reported by the fund. It is held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

As of September 21, 2023, the Plan did not have any assets due to the transfer of plan assets described in Note 1. The following table sets forth by level, within the fair value hierarchy, the plan's assets at fair value as of December 31 2022:

4. Nonparticipant-Directed Investments

All of the investments of the Plan are nonparticipant-directed investments. Consequently, all of the net assets and changes in net assets are related to nonparticipant-directed investments.

5. Tax Status

The Plan is operating under a volume submitter plan of Polsinelli PC. The volume submitter plan obtained its latest opinion letter on March 31, 2014 in which the Internal Revenue Service stated that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator believes that the Plan, which was formed after the determination letter, is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code.
