### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements

We have performed an audit of the accompanying financial statements of Manufacturing Technical Solutions, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### 1. DESCRIPTION OF THE PLAN

The following description of Manufacturing Technical Solutions, Inc. 401(k) Profit Sharing (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan, which was established by (the Company), on June 1, 2001. The Plan merged into the Aeyon LLC 401(k) Profit Sharing Plan and Trust (the Aeyon Plan) effective December 31, 2022. See additional details in Note 8 to the financial statements. The Plan covered all eligible full-time employees of the Company. Employees were allowed to enter the Plan immediately upon their date of hire. Part-time employees who had not completed one year of service or who regularly worked less than 1,000 hours per year were not eligible to participate in the Plan, unless those employees exceeded 1,000 hours in a Plan year, at which time they became eligible to participate. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was most recently amended and restated effective January 1, 2021.

#### **Participant Contributions**

Participants could elect to contribute up to 100% of their eligible compensation, as defined by the Plan, not to exceed the maximum allowable contribution under the Internal Revenue Code (the Code), which totaled \$20,500 for the year ended December 31, 2022. Participants could also make Roth elective contributions. A participant's Roth elective contributions were allocated to a separate account maintained for such contributions. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions, subject to limitations imposed by the Code. Participants were permitted to make rollover contributions from another qualified plan.

#### **Company Contributions**

The Company provided a safe harbor matching contribution equal to 100% of salary deferrals not to exceed 3% of eligible compensation plus 50% of salary deferrals between 3% and 5% of compensation. All employees who were eligible to participate and make elective deferrals into the Plan were eligible to receive Company safe harbor matching contributions. Safe harbor matching contributions were calculated and remitted each pay period. Safe harbor matching contributions totaled \$492,301 for the year ended December 31, 2022.

The Plan could also make additional discretionary nonelective contributions to the Plan. All participants were eligible to participate in discretionary nonelective contributions. The Company did not elect to make a discretionary nonelective contribution to the Plan for the year ended December 31, 2022.

#### Participant Accounts

Each participant's account was participant-directed and was credited with the participant's contributions and Company contributions in accordance with the investment options selected by the participant. Plan earnings, losses, and administrative expenses were allocated to each participant's account based upon the balance in each account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants were immediately vested in their contributions as well as Company safe harbor matching contributions. Participants vested in Company discretionary nonelective contributions according to the following vesting schedule:

Participants became fully vested in all Company discretionary nonelective contributions upon the attainment of normal retirement age or in the event of death, disability, or termination of the Plan.

#### Forfeitures

Forfeitures of Company matching contributions could be applied reduce future Company matching contributions. Forfeitures became available to the Plan as of the earlier of the last day of the Plan year in which a former employee incurred five consecutive one-year breaks in service or a distribution of the participant's entire vested account balance occurred. Forfeitures available to the Plan totaled \$0 and \$126,526 as of December 31, 2022 and 2021. The forfeiture balance was transferred out as part of the transfer to the Aeyon Plan (Note 8). There were no forfeitures applied to reduce Company matching contributions for the year ended December 31, 2022.

#### Payment of Benefits

Upon termination of service, death, disability, normal retirement (age 65), or attainment of age 59 ½, a participant, or his or her beneficiary in the event of death, was entitled to a distribution of the participant's account balance. Distributions from the Plan were payable in the form of a lump sum payment or in the case of required minimum distributions, installment payments equal to the value of the participant's vested interest in his or her account. Upon termination, if a participant's account balance was less than \$1,000, the Plan could elect to automatically distribute the participant's vested account balance. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts could be withdrawn for a hardship purpose. Distributions were subject to the applicable provisions of the Plan agreement. Certain income tax penalties could apply to withdrawals or distributions prior to age 59 ½. As of December 31, 2022 and 2021, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan but had not received such distributions prior to year-end.

#### Plan Expenses

Expenses incurred in the administration of the Plan were required to be paid by the Trustee with assets of the Plan unless the Company, at its discretion, elected to pay them. The Plan paid direct expenses totaling \$3,450 during the year ended December 31, 2022. Distribution fees are paid by the Plan and its participants. Investment related expenses are included in net depreciation in fair value of investments.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### Risks and Uncertainties

The Plan provided for investments in financial instruments that are exposed to risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities may occur in the near term and materially affect the amounts reported in the statements of net assets available for benefits.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the Trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Fair Value Measurement

Accounting Standards Codification 820, *Fair Value Measurement (ASC 820)*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2     Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3     Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets' or liabilities' fair value measurement level within the fair value hierarchy are based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### Fair Value Measurement – cont'd.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Interests in registered investment companies:* Valued at the actively traded quoted closing price of shares held by the Plan at year-end.

*Guaranteed interest account:* Valued by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer. Since participants may transact at contract value or surrender value, the fair value is determined annually for financial statement reporting purposes only. In determining the reasonableness of the methodology, Plan management evaluated a variety of factors including existing contract provisions (crediting rate and minimum rate), economic conditions and contract value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2022. There were no Plan investments at fair value as of December 31, 2022.

### 3. INVESTMENTS

All investment data contained in the accompanying financial statements, including assets held as of December 31, 2022 and 2021, and interest and dividend income and net realized and unrealized depreciation in fair value of investments for the year ended December 31, 2022 was obtained or derived from the information supplied to the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the Custodian and Trustee of the Plan, respectively.

### 4. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Empower Trust Company, LLC. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

### 5. PLAN TERMINATION

The Company has the right under the Plan agreement to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. While not a Plan termination, as further described in Note 8, the Plan merged into the Aeyon LLC 401(k) Profit Sharing Plan and Trust effective December 31, 2022.

### 6. INCOME TAX STATUS

The Plan has adopted a pre-approved plan which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the Plan is qualified under Section 401(a) of the Code and therefore, the related trust is exempt from taxation. Subsequent to the issuance of the opinion letter, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties, and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2022 and 2021.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits in progress for any open tax periods.

**7. COMPANY CORRECTIVE CONTRIBUTIONS**

Subsequent to December 31, 2022, the Company determined that they did not properly calculate the safe harbor matching calculation on all eligible compensation during the year ended December 31, 2022. To correct this operational error, the Company is required to make qualified nonelective employer contributions (QNECs) to the affected employees for an aggregate contribution of \$408. The corrections will be remitted to the participants in the Aeyon Plan during 2023. Participants are 100% vested in these QNEC contributions.

**8. PLAN MERGER**

Effective December 31, 2022, the Plan merged with the Aeyon LLC 401(k) Profit Sharing Plan and Trust (the Aeyon Plan). In conjunction with this merger, the Plan's investment balances totaling \$14,645,437 were transferred out of the Plan to the Aeyon Plan effective December 31, 2022. As a result of this change, a blackout period was in effect from December 29, 2022, through January 3, 2023. During this time, participants were unable to access their accounts, obtain a distribution, or diversify their investments from the Plan and the Aeyon Plan. Participants were, however, able to make contributions directly to the Aeyon Plan during the blackout period.
