INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator of the
REH Company Capital Accumulation Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the REH Company Capital Accumulation Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the REH Company Capital Accumulation Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2022 and 2021 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the REH Company Capital Accumulation Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the REH Company Capital Accumulation Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Summary of the Plan Description

The following description of the REH Company Capital Accumulation Plan, formerly the Sinclair Capital Accumulation Plan, (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

On March 14, 2022, the Company sold Sinclair Oil Corporation and Sinclair Transportation Company to HollyFrontier Corporation and Holly Energy Partners, respectively. At that time, the majority of the Company’s employees were terminated or became employees of the acquiring entity. During 2022, the Plan continued to operate, covering the remaining employees of REH Services Company and SOGC, Inc. Effective December 31, 2022 the Plan merged with, and remaining participant balances were transferred into, the REH Services 401(k) Plan, the plan of an affiliated entity. Total net assets transferred to the REH Services 401(k) Plan consisted of investments with a fair value of \$119,778,922, employer contributions receivable of \$76,002, and profit-sharing contribution receivable of \$58,430.

The Plan consisted of both a profit-sharing component (“Profit-Sharing”) and a 401(k) component (“401(k)”). The Plan was established to provide retirement benefits for eligible employees of the Oil, Finance and Services subsidiaries of the REH Company (formerly the Sinclair Companies) (the “Employer” or the “Company”). Upon election, the participants could direct their balances and future contributions to various funds that were available in the Plan.

Eligibility

As of January 1, 2013 employees qualified to participate in both the Profit-Sharing component and the 401(k) component of the Plan upon being hired by the company.

Vesting

Employee contributions to the Plan vested immediately. Discretionary employer matching contributions to the 401(k) and Profit-Sharing contributions vested after three or more years of service, at which time these contributions were 100% vested. Due to the sale of the Plan Sponsor described previously, the Company vested all employees who were not retained.

Contributions

The Plan was a defined contribution plan. Employee contributions to the Plan's 401(k) component were at the election of eligible employees. Employees of the Company could contribute up to 100% of their annual compensation subject to certain limitations. Employees’ contributions for the year ended December 31, 2022 were limited to \$20,500 per employee under Internal Revenue Code (IRC) Section 402(g). Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions, which were limited to \$6,500 for the year ended December 31, 2022. Participants could elect whether their contributions were treated as traditional salary deferral contributions deducted from before-tax compensation or as Roth after-tax contributions. Participants could also contribute amounts representing distributions (rollovers) from other qualified defined benefit or contribution plans. The Employer contributed a matching percentage up to a maximum of 6% for the year ended December 31, 2022.

Contributions (continued)

For the profit-sharing contribution, the Plan allowed the Employer to make a discretionary contribution to the Plan out of current or accumulated profits. For the year ended December 31, 2022 the Employer contributed an amount equal to 4% of each participant's eligible compensation. The maximum annual addition to a participant's account could not exceed the lesser of \$61,000 (\$67,500 including catch-up contributions) or 100% of a participant's compensation for the year ended December 31, 2022. The total profit-sharing contribution for the year ended December 31, 2022 was \$1,184,151.

Termination

Upon termination of employment due to retirement at or after age 62, disability or death, the participant would become fully vested. Upon such event, the full value of the participant's account would be distributed to the participant in a lump sum payment or in periodic installments, or in the case of death, to the participant's beneficiaries. If the participant terminated employment for any reason other than retirement, death or disability, the vested portion would be payable to the participant. The unvested portion would be forfeited and held in the Plan to reduce future employer contributions. Upon termination of employment, an individual could choose to keep the vested value of his or her account invested in the Plan if the vested value was greater than or equal to \$1,000. When the individual reached age 70½, the Plan was required to commence making periodic distributions to the individual based on Internal Revenue Code (IRC) requirements.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Administrative Committee determines the Plan's valuation policies. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. All Plan assets were transferred to the REH Services 401(k) Plan before close of business on December 31, 2022.

Fees and Administrative Expenses

The fees of the Trustee and the fees of the money managers are charged against the income of the Plan. The majority of administration costs required to maintain the Plan are paid by employees.

Forfeited Accounts

Upon termination of a participant's employment, the non-vested portion of a participant's account shall be forfeited. Any forfeitures occurring during a Plan year could be used to reduce employer contributions. As of December 31, 2021 the balance of net assets included in forfeited nonvested accounts was \$83,497. Employer contributions for the year ended December 31, 2022 were reduced by \$59,950 from forfeited nonvested accounts. The total of \$36,094 of forfeited assets was transferred to the REH Services 401(k) Plan at the merger of the plans.

Excess Contributions Payable

There were no amounts payable to participants for contributions in excess of amounts allowed by the IRS at December 31, 2022. Amounts payable to participants at December 31, 2021 totaling \$7,475 for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as excess contributions. The Plan distributed the 2021 excess contributions prior to April 15, 2022.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Benefit Payments

Benefit payments are recorded when paid.

3. Tax Status

Effective December 1, 2021, the Plan entered into Adoption Agreement #001 under the Fidelity Management Volume Submitter Profit Sharing Plan with CODA, which has received a favorable opinion letter dated March 31, 2014 from the Internal Revenue Service that the plan is acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan Administrator believes that the Plan was being operated in compliance with applicable IRC requirements.

4. Plan Termination

As described in Note 1, effective December 31, 2022 the Plan merged with, and remaining participant balances were transferred into, the REH Services 401(k) Plan, the plan of an affiliated entity. Participants in the merged plan are subject to the same vesting terms as they were under the REH Company Capital Accumulation Plan

5. Fair Value Measurements

Generally accepted accounting principles for Fair Value Measurements established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable inputs developed using estimates and assumptions and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 and 3 inputs are used only when Level 1 inputs are not available.

Fair Value Measurements – Level 1: the fair values of the investments in registered investment companies are based on quoted market prices, Level 2: the fair values of these collective trust funds are valued at the net asset value of their underlying assets as provided by the Trustee of these funds. The underlying assets are principally composed of investment securities, for which there are readily available quoted market prices.

6. Guaranteed Investment Contract with Insurance Company

The Plan had maintained a fully benefit-responsive investment contract with the Prudential Trust Company (Prudential). Prudential maintains the contributions in the general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. Because a guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract was presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Prudential, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value of credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2021 was \$43,060,811. The crediting interest rate was based on a formula agreed upon with the issuer and was reviewed quarterly for resetting.

Guaranteed Investment Contract with Insurance Company (continued)

Certain events limited the Plan's ability to transact at contract value with the issuer. Such events included the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on completing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-off of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974, as amended.

7. Investments

The statements of net assets available for benefits as of December 31, 2022 and 2021, the statement of changes in net assets available for benefits for the year ended December 31, 2022, the accompanying notes to the financial statements were prepared in part or entirely from information certified by Fidelity Management Trust Company (Fidelity), the trustee of the Plan, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

The information certified by Fidelity includes zero investments at December 31, 2022, and dividend and interest income of \$2,925,863 and net depreciation in fair value of investments of \$43,845,656, for the year then ended.

8. Related Party Transactions

Certain Plan investments were shares of mutual funds managed by Fidelity. Fidelity was the trustee as defined by the Plan and, therefore, these transactions qualified as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$122,533 for the year ended December 31, 2022. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

9. Subsequent Events

Subsequent events were evaluated through December 6, 2023, the date the financial statements were available to be issued.
