As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the period ended February 28, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Gen II Fund Services (Colorado) 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Gen II Fund Services (Colorado) 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Gen II Fund Services (Colorado) 401(k) Plan's ability to continue as a going concern for a reasonable period of time.



Emphasis of Matter – Plan Termination and Use of Liquidation Basis of Accounting

As further discussed in Note 10 to the financial statements, Plan Management made a decision to terminate the Gen II Fund Services (Colorado) 401(k) Plan and determined that liquidation is imminent. As a result, in accordance with accounting principles generally accepted in the United States of America, Gen II Fund Services (Colorado) 401(k) Plan has changed its basis of accounting from the accruing basis of accounting used to the present the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

1. Description of Plan

The following description of the Gen II Fund Services (Colorado) (the “Company”, the “Plan Sponsor”) 401(k) Plan (the “Plan”) provides only general information. (The Plan was formerly the Stone Pine Company 401(k) Plan.) Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a participant-directed defined contribution plan, under which participants may direct their contributions into various investment options (generally mutual funds) offered by the Plan. An employee may participate on the first day of the month after completing three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA). Empower Trust Company, LLC and Empower Annuity Insurance Company serve as the Plan custodians and trustees and Empower serves as the plan recordkeeper. The Board of Trustees is responsible for the oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

Plan Merger

On August 2, 2021, Stone Pine Accounting, LLC was acquired by Gen II Fund Services, LLC, a leading fund administration provider. As a result of this transaction, the Stone Pine Company 401(k) Plan was renamed as Gen II Fund Services (Colorado) 401(k) Plan. After acquisition, plan management approved the merger of this Plan into the Gen II Management LLC 401(k) Plan, effective January 9, 2023. As a result, all investments then held were transferred from the Plan into the Gen II Management LLC 401(k) Plan on February 21, 2023. See Note 10 of the financial statements for plan termination information.

Contributions

Participants may generally defer annual compensation to a specified limit (\$22,500 in 2023 and \$20,500 in 2022), as defined in the Plan and by statute. Annual additions to the plan are also limited to the lesser of annual compensation or a statutory limit (\$66,000 in 2023 and \$61,000 in 2022). Participants may also transfer in amounts representing distributions from other qualified plans (rollovers). Contributions are also subject to other statutory limitations, with certain “catch-up” adjustments also permitted for participants age 50 or older. Participant contributions are limited to 100% of eligible Compensation as defined in the Plan document.

The Company can contribute additional discretionary matching contributions. No discretionary contributions were made in 2023 or 2022. The Plan is a Safe-Harbor plan, with a matching contribution of 100% of the first 3% of deferrals, then 50% of the deferrals greater than 3%, but less than or equal to 5% (4% maximum).

Participants may designate all or a portion of their elective deferrals as Roth elective deferrals.

1. Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and Company Safe Harbor contributions, as well as allocations of the Company discretionary contributions (if any) and Plan earnings. Participant accounts are charged with an allocation of administrative expenses (mainly Empower fees) that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, Safe Harbor contributions, and earnings thereon. Vesting in non-Safe Harbor Company contributions and earnings thereon is based on total years of vesting service. A year of service is determined by the hours of service method.

The vesting schedule for non-Safe Harbor Contributions is as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts an amount equal to the lesser of \$50,000 (with certain reductions for loans already outstanding) or 50% of their vested account balance. The loans are secured by the balance in the participants' account and bear interest rates that are commensurate with prevailing rates at the origination of the loan. Principal and interest are paid ratably through semi-monthly payroll deductions, generally over terms not exceeding five years, with longer terms for loans used to acquire a primary residence.

Payment of Benefits

Distributions under the Plan are generally made in lump sums although partial withdrawals are permitted. Hardship distributions are permitted, and in-service distributions may be made if the participant has reached age 59 ½. Distributions of less than \$1,000 to terminated participants do not require participant consent.

Forfeited Accounts

At February 28, 2023 and December 31, 2022, forfeited non-vested accounts totaled \$0 and \$73, respectively. Forfeitures may be used to reduce employer contributions and to pay Plan expenses. In 2022, \$2,606 were used to pay plan expenses. In 2023, \$73 were transferred to the new plan as a result of the Plan's termination.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the liquidation basis of accounting in accordance with FASB ASC 962-40 Plan Accounting – Terminating Plans.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are generally reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustees determine the Plan's valuation policies based on input from the custodian and recordkeeper. See note 8 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is reported on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS, if any, are recorded as a liability with a corresponding reduction to contributions.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the related participant and are expensed when they are incurred. No allowance for credit losses has been recorded as of February 28, 2023 and 2022.

Payment of Benefits

Benefits are recorded when paid.

Expenses

The Company paid for certain direct Plan administrative and other expenses, which are excluded from these financial statements. Additionally, Company employees provide certain administrative duties at no charge to the Plan. Certain fees are paid through revenue sharing from plan investments.

3. Tax Status

The Plan has not obtained a determination letter, but the volume-submitter plan document has received a letter dated March 31, 2014 from the IRS that its form is acceptable under section 401 of the Internal Revenue Code. The Plan has since been amended, but the Plan Trustees believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable tax authorities.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of February 28, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Because plan management believes that the Plan had no taxable income, no income tax returns have been filed for 2023 or prior years.

6. Party in Interest Transactions

Empower and its affiliates receive 12(b)(1) fees or similar revenue-sharing from Plan investments, and these are included in net appreciation. Empower also collects for recordkeeping, trustee and other services. Empower acts as the Plan custodian and trustee. Therefore, these transactions qualify as party in interest transactions.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Section 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

8. Fair Value Measurements (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at February 28, 2023 from those used in the prior year.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Fund: Valued at unit price, published daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

9. Stable Value Investment

The Plan has investments in the Key Guaranteed Portfolio Fund, a general account product of Empower Annuity Insurance Company of America offered through a group annuity contract. The contract allows for participants to transact at unit quoted price. However, certain events (such as premature termination of the contracts, plant closings, layoffs, plan termination, bankruptcy, mergers, and early retirement incentives) will be subject to a market value adjustment. Management does not believe such events are likely to occur in the near future. Participants should refer to the contract for a complete review of its provisions.

10. Termination of the Plan upon Merger

Effective January 9, 2023, the Plan Sponsor approved an addendum to merge plan assets with the Gen II Management LLC 401(k) Plan. On February 28, 2023, the merger was finalized and the plan was terminated. All participants were fully vested in their account balances. The account balances were liquidated and transferred to the surviving plan as soon as administratively practicable. As a result of the imminent liquidation, the 2023 financial statements have been presented on the liquidation basis of accounting. This had no impact on the values of the assets reported in the financial statements. No liabilities were recognized in connection with the termination.
