Note 1 Description of Plan

The following description of the Apollo Bank (the "Company") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which was established on March 11, 2002, is a defined contribution 401(k) profit sharing plan covering employees of the Company who have completed at least one hour of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan oversight is performed by the Plan trustees, who are officers of the Company, and Pension Services, Inc., the third-party administrator ("TPA"). John Hancock Life Insurance Company ("Custodian") receives and invests the contributions and Plan earnings as directed by the participants.

Contributions to the Plan

The Plan allows participants to make tax-deferred contributions (compensation deferrals) up to the maximum limits imposed by the Internal Revenue Code. The Company may make a discretionary contribution, which is allocated to participants active on the last day of the Plan year. The Company provides a match equal to 50% of the first 6% of employees' compensation with a maximum of 3% employer match.

Rollovers

The Plan permits participant designated rollover contributions into plan. The plan is liquidated and there were no activities in the plan from September 30, 2022.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continued service. A participant is 100 percent vested after three years of credited services.

Forfeited Accounts

Forfeitures of non-vested participant account balances can be used to pay administrative expenses of the Plan and/or to reduce contributions otherwise required of the employer. During February 17, 2023 no forfeitures were used to pay administrative expenses. At February 17, 2023 there was no unused forfeiture funds.

Note 1 Description of Plan (Continued)

Distribution of Benefits

Participants or their beneficiaries are eligible to receive distributions from their account upon retirement, permanent and total disability, death, or financial hardship, as defined. Employees who terminate employment prior to the occurrence of one of the above events have 60 days from the date of their account distribution to invest the funds in a qualified tax deferred investment without taxation or penalty.

Notes Receivable from Participants

Loans to participants are allowed under the provisions of the Plan. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The plan allows participants to have no more than two loans outstanding at a point in time. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants are considered parties-in-interest transactions. All notes outstanding at the date of liquidation were considered as distributions out of the plan.

Note 2 Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the trustees to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation include the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis of accounting. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses was considered necessary as of February 17, 2023 and December 31, 2022. At February 17, 2023, notes receivable from participants had no balance and at December 31, 2022 notes receivable from participants had a balance of approximately 149,000.

Note 2 Summary of Significant Accounting Policies (Continued)

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions payable for the February 17, 2023 and December 31, 2022 plan period.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Note 3 Information Prepared and Certified by Custodian

Certain information related to investments disclosed in the accompanying financial statements including investments held at February 17, 2023 and December 31, 2022 and net appreciation in fair value of investments for the periods then ended was obtained or derived from information supplied to the trustees and certified as complete and accurate by John Hancock Life Insurance Company, the custodian of the Plan.

Note 4 Plan Termination

On September 27, 2022, the trustees expressed their intent and passed the resolution to terminate the Plan. The Plan was terminated because the Company that sponsors the Plan was acquired by another Company. Eligibility and benefits in the plan froze as of September 30, 2022 and all participants became fully vested as of September 30, 2022. Benefits held under the Plan are fully distributed to plan participants on or before February 17, 2023.

Note 5 Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the trustees believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 Fair Value Measurements

Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- * quoted prices for similar assets or liabilities in active markets;
- * quoted prices for identical or similar assets or liabilities in inactive markets;
- * inputs other than quoted prices that are observable for the asset or liability;
- * inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at February 17, 2023 and December 31, 2022.

Pooled separate accounts: Pooled separate accounts are valued at the net asset value (NAV) or equivalent based on units of the pooled separate accounts. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV.

The preceding methods described, may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table summarizes investments measured at fair value based on the NAV per share practical expedient as of February 17, 2023 and December 31, 2022. There are no participant redemption restrictions for these investments; the redemption notice is applicable only to the Plan.

The Plan uses the NAV to determine the fair value of all the underlying investments which (a) do not have a readily determinable fair value and (b) prepare their financial statements consistent with the measurement principles of an investment company or have the attributes of an investment company.

Note 7 Related Party Transactions and Parties in Interest Transactions

Certain Plan investments are managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. John Hancock Life Insurance Company provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement ("MSA") between the Company and John Hancock.

John Hancock receives revenue from mutual fund service providers for services John Hancock provides to the funds. This revenue is used to offset certain amounts owed to John Hancock for its administrative services to the Plan. If the revenue received by John Hancock from such mutual fund service providers exceeds the amount owed under the MSA, John Hancock remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. As of February 17, 2023 and December 31, 2022 there were no excess amounts. The Plan or Plan Sponsor may make a payment to John Hancock for administrative expenses not covered by revenue sharing.

Note 8 Subsequent Events

The Plan has evaluated subsequent events through November 28, 2023, the date the financial statements were available to be issued and determined no additional items required disclosures.
