Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Oxiten USA LLC 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets in liquidation as of December 19, 2022, the statement of net assets available for benefits as of December 31, 2021 (ongoing), and the related statement of changes in net assets in liquidation for the period from January 1, 2022 to December 19, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 19, 2022 and December 31, 2021 and for the period from January 1, 2022 to December 19, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matters – Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Managers of the Board approved a plan of liquidation on March 31, 2022 and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Also as described in Note 1, pursuant to the Plan's termination, the net assets of the Plan were fully distributed as of December 19, 2022. Our opinion is not modified with respect to these matters.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 – DESCRIPTION OF PLAN

Oxiteno USA LLC 401(k) Retirement Savings Plan (the Plan), was a qualified retirement plan covering substantially all eligible employees of Oxiteno USA LLC (the Company). The Plan was originally established by the Company effective November 28, 2008 and was most recently amended and restated effective September 27, 2021. The Plan was subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and was administered by the Company. The following description of the Plan provides only general information. Participants should refer to the legal plan document and trust agreement for a more complete description of the Plan's provisions.

The Company's Board of Director's elected to terminate the Plan effective March 31, 2022, and to distribute Plan assets as soon as administratively practicable. In accordance with the Plan provisions, the Company vested 100% of the Plan's assets as of March 31, 2022. All Plan assets were distributed on December 19, 2022.

Eligibility: Prior to termination, in order to participate in the Plan, an employee must have been at least 21 years old and have completed one month of service. Employees were automatically enrolled on the first day of the month following completion of the age and service eligibility requirements.

Contributions: Prior to termination, participants could elect to defer a percentage of their eligible compensation into the Plan after they had satisfied the Plan's eligibility requirements, as a pre-tax contribution. The percentage of their eligible compensation elected would be withheld from each payroll and contributed to an account in the Plan on their behalf. Participants could elect to defer up to 70% of their eligible compensation, not to exceed the dollar limit set by law. Participants who were projected to be age 50 or older by the end of the taxable year and who were making deferral contributions to the Plan could also make a catch-up contribution of up to \$6,000 to the Plan. The Plan included an auto-enrollment provision whereby newly eligible employees were automatically enrolled in the Plan after 30 days of employment at a deferral rate of 3% of eligible compensation, unless they affirmatively elected to opt out of the Plan or elected a deferral rate other than 3%. The automatic deferral feature also provided for an annual increase of 1% in the percentage deferred each year until the deferral reaches 6%

The Company had elected to make safe harbor matching contributions to all eligible participants in an amount equal to 100% of the first 6% of a participant's eligible compensation, contributed to the Plan as deferral contributions.

The Company could make an additional discretionary or non-elective employer matching contribution on behalf of eligible Plan participants. Discretionary matching contributions, if made, would be computed by the Company based on participants' eligible compensation deferred to the Plan each Plan year. The Company would limit the matching contributions to 4% of a participant's eligible compensation contributed to the Plan. Non-elective employer matching contributions were computed by the Company based on participants' eligible compensation contributed to the Plan each payroll period. There were no additional discretionary or non-discretionary matching contributions made during the current Plan year.

Participants and eligible employees could roll over part or all of an eligible rollover distribution they receive from an eligible retirement plan into this Plan.

Participant Accounts: Each participant's account was credited with the participant's contributions and allocations of (a) the Company's contributions (b) Plan earnings or losses and was charged with his or her withdrawals and an allocation of administrative expenses. Allocations were based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account. Each participant directed the investment of his or her account to any of the investment options that were available under the Plan.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Investment Options: Participants could direct the investment of their entire interest in the Plan into various investment securities. Prior to termination, the Plan offered various mutual funds, a self-directed brokerage account and a money market fund. Participants could make changes to their investment direction as allowed under the Plan, including transferring any contributions from one investment option to another at any time.

Vesting: Prior to termination, participants were immediately vested in their contributions, including rollover contributions, safe-harbor matching contributions, discretionary matching contributions, and non-elective employer matching contributions and any earnings thereon.

Retirement, Death, and Disability: Prior to termination, a participant was entitled to 100% of his or her account balance upon retirement, death, or disability.

Notes Receivable From Participants: Prior to termination, participants could borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of a participant's vested account balance, reduced by an outstanding loan balance, if any, during the previous 12 months. A participant could only have one loan outstanding at a time. Loans were adequately secured by the balance in the participant's account and bore a reasonable rate of interest. Principal and interest payments were paid ratably through payroll deductions over a term that did not exceed five years, unless the loan was obtained to acquire a principal residence.

Payment of Benefits: Prior to termination, upon termination of employment due to death, disability, or normal retirement, a participant could receive either a lump sum payment equal to the value of the vested interest in their account or installments over a period of assumed life expectancy. Upon termination of employment for reasons other than death, disability, or normal retirement, lump sum distributions could be made at the participant's election. If a participant's total vested benefit was \$1,000 or less when they terminated employment, their entire vested benefit would be distributed to them in a lump sum, even if the participant did not consent to a distribution.

Participants who had attained age 59½ could receive an in-service distribution from the Plan from fully vested accounts prior to termination of employment. A participant could request a hardship withdrawal to satisfy certain immediate and heavy financial needs. In the event of a participant's death, the participant's Plan benefit was payable to the spouse or designated beneficiary or beneficiaries.

Forfeited Accounts: Prior to termination, forfeitures were retained in the Plan and could be used to pay administrative expenses or reduce employer contributions.

Administrative Expenses: Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net depreciation.

Subsequent Events: The Plan has evaluated subsequent events through November 20, 2023, the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: Due to the Company terminating the Plan effective March 31, 2022, it was determined by Plan management that termination was imminent and therefore, the financial statements were prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP) for the period from January 1, 2022 to December 19, 2022. The change in accounting basis did not result in any adjustments. For the year ended December 31, 2021, the financial statements of the Plan used the accrual basis of accounting in accordance with GAAP.

Estimates: The preparation of the financial statements in accordance with GAAP requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Risks and Uncertainties: The Plan held various investments. Investments were exposed to various risks such as interest rate, market, liquidity, credit and risks resulting from global events. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments would have occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits in liquidation.

Investment Valuation and Income Recognition: The Plan's investments were reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. See *Note 4* for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the Plan year.

Notes Receivable From Participants: Notes receivable from participants were measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they are incurred. No allowance for credit losses has been recorded as of December 19, 2022 or December 31, 2021.

Payment of Benefits: Benefits were recorded when paid.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 19, 2022 and December 31, 2021, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2022 to December 19, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Money Market Fund: The fair values of money market investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Self-Directed Brokerage Account: Primarily held in mutual funds and common stock. Common stock is valued at the closing price reported on the active market on which the individual securities are traded.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. Some administrative expenses of the Plan were paid directly by the Company. Certain plan investments and notes receivable from participants were managed by the trustee. These transactions qualified as party-in-interest transactions. Such transactions were permitted under the provisions of the Plan and were exempt from the prohibited transaction rules under ERISA.

NOTE 6 – TAX STATUS

The Company adopted a non-standardized pre-approved profit-sharing plan with a CODA sponsored by Fidelity Management & Research Co. The non-standardized pre-approved profit sharing plan obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the pre-approved profit sharing plan, as then designed, was applicable under 401 of the Internal Revenue Code (IRC) and for use by the employer for the benefits of its employees. Although the Plan has been amended from the original pre-approved document, Plan management believes that the Plan was being operated in accordance with the IRC.

GAAP requires the Company to evaluate the tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 19, 2022 and December 31, 2021, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.
