We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about W. G. Yates & Sons Construction Company Employee Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.


In performing an audit in accordance with generally accepted auditing standards, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of the W. G. Yates & Sons Construction Company Employee Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of W. G. Yates & Sons Construction Company (the Sponsor), The Yates Companies, Inc., Superior Asphalt, Inc., Merit Electrical, Inc., MEI Electrical, Inc., Yates Engineering Corporation, Edwards Electric Service, LLC, Spectrum Bloomfield, LLC and Spectrum Resorts, LLC (collectively, the Companies). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by W.G. Yates & Sons Construction Company (the Sponsor), and a committee appointed by the board of directors of the sponsor. The committee has overall responsibility for the operation and administration of the Plan. The committee determines the appropriateness of the plan's investment offerings, monitors investment performance and reports to the plan's Trustee.

Plan Assets

Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively "Empower") are the trustees of the Plan in 2023 and 2022. The values of plan assets and information about changes in net assets available for benefits have been certified by Empower in 2023 and 2022, to be complete and accurate.

Contributions

A participant can defer up to the allowed limit (the lesser of 25% of earnings or \$22,500 in 2023) of compensation annually. Participants age 50 and older may make an additional \$7,500 catch-up contribution. The Plan allows the Company to match a percentage, which is determined by the board of directors at their discretion. The Company matches 100% of deferrals up to 3% of compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Except for 401(k) deferrals, participants are not allowed to contribute personal funds to the Plan. Participants have the option to make pre-tax or Roth contributions subject to the aforementioned limitations.

Note 1. Description of the Plan (continued)

Eligibility

To be eligible for participation, employees must be 21 years of age and be employed for nine months. The entry date is quarterly on January 1, April 1, July 1, and October 1. Employees must work 500 hours in a year to avoid a break in service.

Additional Employer Contribution

Active participants are eligible to share in and benefit from the profits of the Company in such amounts as the Company determines at its discretion each year. A portion of the Company's profits each year may be contributed by the Company for the benefit of all employees who participate in the Plan. The amount, if any, contributed to the Plan each year is determined by the Company.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Companies' matching contributions and plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is fully vested after 5 years of service. A participant's non-vested equity is forfeited upon termination. The non-vested portions of employer matching contributions, which are forfeited, reduce future matching contributions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his account, a joint and survivor annuity, or equal installments over his life expectancy. For termination of service for any other reasons, a participant may receive the value of the vested interest in his account as a lump sum distribution.

Notes Receivable from Participants

The Plan does not allow loans to participants.

Insurance

A fidelity bond insures the Plan for \$1,000,000.

Note 1. Description of the Plan (continued)

Investment Options

Employees can direct both employer and employee contributions into forty-four investment options including self-directed brokerage accounts. Participants may change their investment options daily.

Forfeited Accounts

Forfeited non-vested accounts totaled \$0 at March 31, 2023 and December 31, 2022, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Common stocks are valued at quoted market prices, which represent the fair value of shares held by the Plan at year / period end.

Purchases and sales-of-securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change includes the Plan's gains and losses on investments bought and sold as well as held during the year / period.

Note 2. Summary of Significant Accounting Policies (continued)

Payment of Benefits

Benefits are recorded when paid.

Administrative Fees

The Plan's expenses are paid either by the Plan or W.G. Yates & Sons Construction Company (the Sponsor), as provided by the plan document. Expenses that are paid directly by the Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan, which are paid by the Plan, are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net change in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan's management has evaluated subsequent events through December 7, 2023, the date on which the financial statements were available to be issued.

Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Note 3. Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2023 and December 31, 2022.

Common stocks – Valued at the closing price reported on the active market on which the individual securities trade.

All valuation methodologies have been consistently applied during 2023 and 2022.

Note 4. Expenses Paid by the Plan Sponsor

No administrative fees for the Plan were paid by the plan sponsor, W. G. Yates & Sons Construction Company.

Note 5. Tax Status

The Plan obtained its latest determination letter on November 19, 2001, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 5. Tax Status (continued)

The Plan accounts for uncertain tax positions in accordance with ASC 740-10. No penalties or interest were accrued or charged to expenses for the period / year ended March 31, 2023 or December 31, 2022. Currently, none of the returns in the U.S. federal jurisdiction or the U.S. state jurisdiction are under examination by any taxing authority. The statute of limitations for the U.S. federal jurisdiction, as well as the U.S. state jurisdiction, is three years. The income tax returns prior to fiscal year 2019 are closed.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Information Certified by Trustee

The Plan's investments were held by Empower in 2023 and 2022. The Plan's financial information, including investment values, investment income, and fees is included in the financial statements and supplemental schedule based on information certified by Empower as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The balances certified by Empower at March 31, 2023 and December 31, 2022 totaled \$0 and \$1,285,015, respectively.

Note 8. Party-in-Interest Transactions

The Plan pays fees to Trustmark National Bank, Great West Life & Annuity Insurance Company, Great West Trust Company, LLC, Empower Annuity Insurance Company of America, Empower Trust Company, LLC and Empower Retirement Advisory Services for trust services, investment advisory / management and third-party administration of the Plan. The Plan also pays audit fees to Rea, Shaw, Giffin & Stuart, LLP. All of these transactions qualify as party-in-interest transactions.

Note 9. Plan Amendments

In January 2020, Congress passed the Setting Every Community Up for Retirement Enhancement Act of 2020 that contained the largest package of retirement system reform in over a decade. Many of the provisions of the SECURE Act became effective on January 1, 2020 and require significant changes to plan administration and recordkeeping.

The COVID-19 outbreak in the United States caused business disruption through mandated and voluntary closings of businesses in numerous industries. As of March 27, 2020, Congress passed the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act").

The Plan was amended in September 2022 to comply with the provisions of these laws.

Additionally, the Plan was amended in September 2022 to allow Roth contributions, Roth in-plan rollovers and Roth in-plan transfers.

Note 10. Plan Merger and Termination

The companies covered by the Plan are under common control with other companies that have a separate defined contribution plan called the Jesco / Blaine 401(k) Plan. The administrative committees of both plans have approved a plan to merge the two plans. The merger plan calls for the assets of the Plan to be merged with the Jesco / Blaine 401(k) Plan, the Jesco / Blaine 401(k) Plan to be renamed, and the W. G. Yates & Sons Construction Company Employee Trust to be ultimately terminated.

On December 30, 2022, the mutual fund and group annuity contract investments of the Plan totaling \$54,215,360 were transferred to the Jesco / Blaine 401(k) Plan. The remaining assets in the Plan as of December 31, 2022, were common stocks held in self-directed brokerage accounts and were transferred on January 5, 2023.

The Jesco / Blaine 401(k) Plan was amended and restated on January 1, 2023. The amended plan was renamed The Yates Companies, Inc. 401(k) Plan.
