### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We were engaged to perform audits of the financial statements of Insurance Information Technologies, Inc. Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits - liquidation basis as of November 3, 2023 (liquidation date) and March 31, 2023, and the related statement of changes in net assets available for benefits - liquidation basis for the period from April 1, 2023 through November 3, 2023 (liquidation date), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Insurance Information Technologies, Inc. Employee Stock Ownership Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 3, 2023 (liquidation date) and March 31, 2023, and for the period from April 1, 2023 through November 3, 2023 (liquidation date), stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Disclaimer of Opinion**

We do not express an opinion on the financial statements of Insurance Information Technologies, Inc. Employee Stock Ownership Plan referred to in the first paragraph. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

## **Basis for Disclaimer of Opinion**

Insurance Information Technologies, Inc. Employee Stock Ownership Plan does not have sufficient accounting records and supporting documents relating to certain information summarized in Note 3 to the financial statements. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

## **Emphasis of Matter- Plan Termination and Use of Liquidation Basis of Accounting**

As described in Note 1 to the financial statements, the governing body of the Company approved the termination of the Plan effective April 13, 2021. Accordingly, the Plan has changed its basis of accounting from the ongoing Plan basis to the liquidation basis.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Our responsibility is to conduct an audit of Insurance Information Technologies, Inc. Employee Stock Ownership Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of Insurance Information Technologies, Inc. Employee Stock Ownership Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

## 1. Description of Plan

The following brief description of the Insurance Information Technologies, Inc. Employee Stock Ownership Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**Termination** - On April 13, 2021 the Company was sold and as a result the Company approved the termination of the Plan effective April 13, 2021. As of November 3, 2023, all account balances were distributed from the Plan in accordance with the terms of the Plan.

**General** - The Plan was established as of April 1, 2002. The Plan was an employee stock ownership plan, as defined in the Internal Revenue Code ("Code"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The sponsor of the Plan was Insurance Information Technologies, Inc. (the "Company").

**Participating Employer** - The participating employer in the Plan was Insurance Information Technologies, Inc.

In 2007, the Plan purchased Company stock using the proceeds of a loan from the Company, and held the common stock in a suspense account established under the Plan. The borrowing was to be repaid over a period of twenty years by fully deductible Company contributions to the trust fund. As the Plan made each payment of principal, an appropriate percentage of stock was allocated to eligible employees' accounts.

In January of 2021, the Company completed a releverage transaction using the proceeds of a loan from the Company, and held the common stock in a suspense account established under the Plan. The borrowing was to be repaid over a period of eight years by fully deductible Company contributions to the trust fund. As the Plan made each payment of principal, an appropriate percentage of stock was allocated to eligible employees' accounts.

**Eligibility** - Prior to the termination, employees who completed one year of employment, with 1,000 hours of service, and were at least 21 years of age were eligible for participation in the Plan on the next plan entry date. Plan entry dates were April 1 and October 1.

**Forfeitures** - Forfeitures that arose under the Plan during a year would be allocated to the participant's accounts in the proportion that each participant's compensation for the year bore to all participants' compensation for that year. As of April 14, 2021, participants' accounts became nonforfeitable due to termination of the Plan.

## 1. Description of Plan (continued)

**Contributions** - The Company could make contributions to the Plan at the discretion of the Board of Directors. Company contributions could be made in cash or shares of Company stock. For any year during which an ESOP loan was outstanding, the Company was obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equaled the amount that was necessary to enable the Plan to make its regularly scheduled payments of principal and interest that were due on its term loan. Due to Plan termination, there were no Company contributions to the Plan during the period from April 1, 2023 through November 3, 2023.

**Investment Income Allocation** - Allocation of investment gains or losses were based on each participant's account balances.

**Vesting** - Vesting in a participant account was based on years of service. A participant would have no vested interest in his or her accrued benefit until they had completed two years of vesting service, at which point the account would vest ratably through six years of service, until 100% vested. Employee accounts that were not previously distributed in full became fully vested as of April 14, 2021 due to the termination of the Plan.

**Retirement, Death and Disability** - A participant (or his beneficiary) was entitled to 100% of his account balance upon retirement, death or disability.

**Payment of Benefits** - Upon retirement, death, or disability, a participant was eligible to receive distributions of the vested account balance in equal annual installments over a period of three years beginning in the first Plan year following the Plan year in which the participant terminated service. Upon termination of service other than retirement, death, or disability, the benefits would be paid out in equal annual installments over a period of five years beginning in the second Plan year following the Plan year in which the participant terminated service.

**Voting Rights** - Each participant was entitled to direct the Trustee as to how to vote the shares that were allocated to his or her account with respect to any proposed merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of a trade or business, or any similar transactions that are specified in regulations interpreting Section 409(e)(3) of the Code. The Trustee would vote any allocated shares for which instructions were not given by a participant. The Trustee would also vote any unallocated shares on behalf of the collective best interest of plan participants and beneficiaries.

**Participant Accounts** - Separate employer stock accounts and other investment accounts were established to record the participants' interest under the Plan. As of the last day of each plan year, the employee stock and cash investment accounts that were maintained under the Plan were credited with:

*Company Stock Account:*

- (A) Allocable shares of employer stock purchased and paid for by the Trust or contributed by the Company to the Trust;
- (B) Allocable share of the Company stock released from the suspense account;
- (C) Allocable share of any forfeitures of Company stock arising under the Plan;
- (D) Any stock dividends declared and paid during the year on Company stock credited to the participant's account;

*Other Investment Account:*

- (A) Allocable share of any contribution made by the Company in cash or property other than Company stock that is not used to purchase Company stock or to repay an ESOP loan;
- (B) Allocable share of any forfeitures from the other investment account of other participants arising under the Plan;
- (C) Any cash dividends paid on Company stock, other than those distributed directly to the participant or used to repay an ESOP loan;
- (D) Allocation of earnings on other investment accounts.

**Put Option** - Under federal income tax regulations, the employer stock that was held by the Plan and its participants and was not readily tradable on an established market, or was subject to trading limitations, included a put option. The put option was a right to demand that the Company buy any shares of its stock distributed to participants for which there was no market. The put price was representative of the current appraised value of the stock. The Company could pay for the purchase with interest over a period of five years. The purpose of the put option was to ensure that the participant had the ability to ultimately obtain cash.

**Diversification** - Diversification was offered to participants close to retirement so that they could have the opportunity to move part of the value of their investment in Company stock into investments that were more diversified.

Participants that had attained age 55 and completed at least 10 years of participation in the Plan could elect to diversify a portion of their accounts. Diversification was offered to each eligible participant over a six-year period. In each of the first five years, a participant could diversify up to 25% of the shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage would change to 50%.

## 2. Summary of Significant Accounting Policies

**Basis of Presentation** - The Plan's financial statements are presented using the liquidation basis of accounting for the period from April 1, 2023 through November 3, 2023 and for the year ended March 31, 2023 in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates** - The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes in net assets therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Information Certified by Trustee** - Information concerning Plan assets and changes in net assets available for Plan benefits has been certified as being complete and accurate.

**Investment Valuation and Income Recognition** - The Plan carried its investments in marketable securities with readily determinable fair value at their fair values. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Since a readily ascertainable market did not exist for the investment in the common stock of the Company, the fair value of the Company's common stock was determined by annual independent appraisals.

Purchases and sales of securities were recorded on a trade-date basis. Realized gains and losses from security transactions were reported on the average cost method. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

**Risks and Uncertainties** - The Plan investments consisted primarily of the Company's common stock, which was exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques.

The information included in the accompanying financial statements was obtained from data that has been prepared and certified both as to completeness and accuracy by the trustee.

## 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

*Level 1*: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2*: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3*: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

## 5. Administrative Expenses

Certain expenses for maintaining the Plan were paid directly by the Company and were not reflected within the financial statements. There were no fees relating to the administration of the Plan for the period from April 1, 2023 through November 3, 2023.

## 6. Tax Status

The Plan has received a determination letter from the Internal Revenue Services dated February 2, 2023, stating that the termination of the plan does not affect the status of the plan under the Internal Revenue Code. The Plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken a significant uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan is subject to routine audits by taxing jurisdictions; however, the Plan is no longer subject to income tax examinations for years prior to 2020.
