Dear Sir/Madam,

I am writing regarding a Form 5500SF matter. I recently received a notice that my form 5500 was not received in the allotted time frame. On July 27th, 2023, I submitted my form to the Department of Labor, and received confirmation number 47398933. Per the instructions on my confirmation page, my form is not officially received until the status reads "Filing Received" from the DOL, which was displayed on the page. The Acknowledgement ID that I received from the DOL was 20230727132400NAL0007352515001.

Today, I received a letter from the IRS stating that my form was never filed by the DOL, despite the confirmation number, Acknowledgement ID, and the status "Filing Received" displayed on my EFAST account. Per the letter, I should file my return as soon as possible to minimize any penalty. I logged into my EFAST account and discovered my form was returned (despite the "Filing Received" message) due to errors that were made when PayChex, the company we secured for our 401K, completed the Form 5500SF. Per the instructions supplied by the "Validate" option on EFAST, I have corrected the errors and resubmitted the form.

I am asking you to please waive any penalty and/or interest my company may have accrued due to this error. I have attached copies of my confirmation page, and my EFAST account displaying "Filing Received".
