Attached please find the Final Form 5500-SF (Short Form Annual Return/Report of Small Employee Benefit Plan) filed with respect to the Butler Hospitality [401(K) Plan] (the "Plan"), for the short plan year ending March 31, 2023. B Hospitality Corp. (*dba* Butler Hospitality), the Plan Sponsor, filed a no asset voluntary petition for relief under Chapter 7 of the United States Bankruptcy Code (the "Bankruptcy Code") on September 20, 2022. Subsequently, the case changed to an asset case. On December 1, 2022, the Office of the United States Trustee appointed me to serve as the Chapter 7 trustee in the bankruptcy case (the "Bankruptcy Trustee").

As the Bankruptcy Trustee, and pursuant to section 704(a)(11) of the Bankruptcy Code, I shall continue to perform the obligations required of the administrator of the Plan. Accordingly, I have overseen the termination and liquidation of the Plan, and I have signed the Final Form 5500-SF for the short plan year ending March 31, 2023, solely in my capacity as the Bankruptcy Trustee. The third-party administrator for the Plan was ADP Retirement Services, which prepared the 2023 Final Form 5500-SF. As a result of the Plan Sponsor's bankruptcy, and given my limited role as Bankruptcy Trustee, I cannot confirm the accuracy of all the information contained in the 2023 Final Form 5500-SF (notwithstanding the fact that I have signed the form).
