## INDEPENDENT AUDITORS' REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Keno Kozie Services 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets in liquidation available for benefits as of December 31, 2022 and the statement of net assets available for benefits as of December 31, 2021, and the related statement of changes in net assets in liquidation available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2022 and 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the liquidation basis of accounting for 2022 and with accounting principles generally accepted in the United States of America for 2021.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities section of our report. We are required to be independent of Keno Kozie Services 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of a Matter – Plan Termination**

As discussed in Note 10 to the financial statements, the Plan Sponsor terminated the Plan effective December 31, 2022. All assets were transferred out of the Plan by December 31, 2022, which is the date through which the current period financial statements are reported. Accordingly, the Plan changed its basis of accounting to the liquidation basis on the Plan's December 31, 2022 financial statements.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the liquidation basis of accounting for 2022 and with accounting principles generally accepted in the United States of America for 2021, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Keno Kozie Services 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.

Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.


In performing an audit in accordance with generally accepted auditing standards, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the liquidation basis of accounting for 2022 and accounting principles generally accepted in the United States of America for 2021.

**1. DESCRIPTION OF THE PLAN:**

The following description of the Keno Kozie Services 401(k) Plan (the “Plan”) provides only general information. The Plan was established with an effective date of January 1, 2021, and the most recent Amended and Restated date was July 1, 2021. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General –

The Plan is a defined contribution plan covering substantially all eligible employees of Keno Kozie Services, LLC (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan’s Investment Committee determines the appropriateness of the Plans investment offerings, monitors investment performance, and reports to the Plans Board of Trustees.

The Plan’s federal identification number is 86-1580183 and the plan number is 001.

The Plan was terminated effective December 31, 2022 (see Note 10). The Plan description described below notes the provisions of the Plan effective prior to termination of the Plan.

Participation –

Employees are eligible to participate in the Plan after reaching 18 years of age and completion of 3 months of service. Employees become a participant on the first day of the month following the completion of the eligibility requirement. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan upon becoming eligible.

Contributions –

The plan provides for employee 401(k) deferral contributions up to 86% of pretax eligible earnings, as defined in the plan, subject to annual limits established by the Internal Revenue Services. Participants who have attained age 50 may make catch-up contributions in addition to their regular deferral contributions. All 401(k) deferral contributions are made out of pretax earnings through salary reductions and are subject to certain IRS limitations. These contributions are not subject to federal income tax until withdrawn. Taxes are the responsibility of the individual participants and not the Plan. Participants are also allowed to make after-tax Roth 401(k) contributions, which are also subject to certain IRS limitations and are subject to federal income tax in the year of deferral, in most cases, are not subject to federal income taxes when distributed. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 3% of eligible compensation. Contributions are automatically invested in a designated balanced fund until changed by the participant. The Company contributes 25% of the first 6% of base compensation that a participant contributes to the Plan. The Company may elect to make a discretionary nonelective contribution to the Plan.

Contributions – (Continued)

The nonelective contribution will be allocated to employees eligible to participate in the Plan and is allocated to employees based on the ratio of their eligible earnings to the eligible earnings of all employees who will share in the contribution. Contributions are subject to certain statutory limitations. The Company did not make a discretionary nonelective contribution to the Plan during 2022.

Participant Accounts –

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, when applicable, and (b) Plan earnings (losses), as well as an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting –

Participants are always 100% vested in their contributions plus earnings thereon. Participants also become fully vested in their employer contributions if they are employed with the Company upon reaching the Plan's normal retirement age, 65, or upon death or permanent disability. Participants vest in their employer contributions in accordance with the following table:

6 years or more	100%

Forfeitures –

At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$0 and \$70, respectively. These accounts can be used to pay plan expenses or used to reduce future employer contributions. No forfeitures were used to reduce administrative expenses during the years ended December 31, 2022. During 2022, employer contributions were reduced by \$22,648 from forfeited nonvested accounts.

Notes Receivable from Participants –

Participants may borrow a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances from their accounts. The \$50,000 maximum is reduced by the highest outstanding loan balance the employee had under the Plan during the previous 12-month period. Repayment of loans shall be determined by mutual agreement, but in no event will the term exceed five years unless the loan is used to purchase a principal residence, and then the term shall be limited to a period of 30 years. Outstanding loans must be repaid before a new loan can be taken out. The interest rate applied to the loan will be the prime rate as published in The Wall Street Journal on the 14<sup>th</sup> of each month, plus one percentage point. The loans are secured by the participant's account balance. Principal and interest is paid ratably through monthly payroll deductions.

Disbursements –

A participant may elect to receive payment of benefits upon termination, retirement, disability, after attaining the age of 59 ½ or death. The Plan allows hardship withdrawals of the employee's elective deferrals, as well as of any vested matching contributions or vested nonelective contributions.

Benefits may be paid in a lump-sum distribution, paid as a direct rollover to an individual retirement account, or the participant may select from various periodic installment options as soon as practicable after employment with the Company has ended. Participants may elect to defer commencement of distributions until April 1 of the calendar year after they attain age 70 ½ at which time minimum distribution must be made in accordance with applicable regulations. Until such time as the funds are distributed, the participant is entitled to receive a pro rata share of fund earnings. Benefits may also be paid to an eligible participant as an eligible rollover distribution.

Investment Options –

Participants direct the investment of their account balances into various investment options offered by the Plan. The Plan currently offers various registered investment companies and common/collective trusts as investment options for participants. The participants are able to change their investment options on a daily basis.

Administration of the Plan –

Keno Kozie Services, LLC is the Plan's sponsor and administrator. ADP Retirement Services acts as a record keeper for the Plan. Reliance Trust Company is the Plan's custodian.

**2. SUMMARY OF ACCOUNTING POLICIES:**

**Basis of Accounting –**

For the year ended December 31, 2022, the financial statements of the Plan are prepared on the liquidation basis of accounting. For the year ended December 31, 2021, the financial statements of the Plan are prepared on the accrual basis of accounting. There were no material changes to the financial statements as a result of the change to liquidation basis.

**Use of Estimates –**

The preparation of financial statements in conformity with the liquidation basis of accounting (2022) and accrual basis of accounting (2021) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amount of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition –**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policy. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan's investments are exposed to risks such as interest rate, credit and overall market volatility. Due to these risk factors, it is reasonably possible that changes in the value of investments will occur in the near term and could materially affect the amounts reported in the financial statements.

**Net Realized and Unrealized Appreciation (Depreciation) in Fair Value of Investments –**

Net realized gain (loss) on the sales of investments is calculated as the difference between the net proceeds and the cost of the investments on a specific identification basis.

Net unrealized gain (loss) in the fair value of investments is calculated as the difference between fair value of assets held at the beginning of the year or acquired during the year and the fair value of assets at the end of the year.

**Contributions Receivable –**

The Plan had no contribution receivables from the Company and employees relating to contributions not yet funded as of December 31, 2022.

Notes Receivable from Participants –

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2022 and 2021, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

Payments of Benefits –

Benefits are recorded when paid.

Operating Expenses –

Certain expenses of maintaining the Plan are paid by the Plan Sponsor and therefore excluded from their financial statements. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Record keeping, administrative, and investment advisory fees are paid by the Plan and included in administrative expenses and allocated to all participant's accounts.

**3. INVESTMENTS:**

Fair Value Measurements –

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e. an exit price.) The Plan's investments are reported at their fair value at the measurement date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of fair value hierarchy are as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the entity has the ability to access.
- Level 2 - Valuations based on quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable data for substantially the full term of the assets or liabilities.
- Level 3 - Valuations based on inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Financial assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of assets and liabilities and their placement within the fair value hierarchy levels.

Following is a description of the valuation methodologies used for assets measured at fair value:

- Registered Investment Companies (Level 1): The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).
- Common/Collective Trusts: This investment is valued using the NAV provided by the Plan's third party administrator. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The inputs used in the valuing the underlying investments in the common collective trust included quoted prices from similar assets or liabilities in active that are not active, inputs other than quoted prices that are observable for the assets or liabilities and inputs that are derived principally from or corroborated by observable market data

The methods described above might produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the different methodologies or assumptions used to determine fair value of certain financial instruments could result in a different fair value measurement as of the reporting date.

Investments are administered and maintained by Reliance Trust Company (the "Custodian"). The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the Custodian.

**7. TAX STATUS OF THE PLAN:**

The Plan has adopted prototype plan documents sponsored by the Custodian. The Internal Revenue Service (IRS) has determined and informed the Custodian by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirement of the IRC and therefore believe that the Plan is qualified and the related trust in tax-exempt.

The liquidation basis (2022) and accrual basis (2021) of accounting require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan sponsor has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or a disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. If applicable, the Plan would recognize penalties and interest on uncertain tax positions as a deduction from net assets.

**8. RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**9. PLAN TERMINATION:**

The Plan was terminated effective December 31, 2022. All assets of the Plan were transferred to the HBR Managed Services LLC 401(k) Plan by December 31, 2022, which is the date through which the current financial statements are presented.

**10. SUBSEQUENT EVENTS:**

The Plan has evaluated subsequent events through October 12, 2023, the date on which the financial statements were available to be issued.
