Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Rocket Oil Company, LLC 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits – liquidation basis as of October 31, 2022 and the statement of net assets available for benefits as of December 31, 2021, the related statement of changes in net assets available for benefits – liquidation basis for the ten months ended October 31, 2022 and the statement of changes in net assets available for benefits for the year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Rocket Oil Company, LLC 401(K) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 31, 2022 and December 31, 2021, and for the periods then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Rocket Oil Company, LLC 401(k) Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the

audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note 2 to the financial statements, the governing body of the Rocket Oil Company, LLC 401(k) Retirement Savings Plan approved a plan of liquidation on October 31, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the accrual basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Rocket Oil Company, LLC 401K Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 – PLAN ADMINISTRATION AND DESCRIPTION

The following brief description of the Rocket Oil Company, LLC 401(k) Retirement Savings Plan is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

A. General

Rocket Oil Company, LLC provides its employees a defined contribution plan under code section 401(k) of the Internal Revenue Code. The Plan is also subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An employee who is at least twenty-one years of age, has worked a year, and has worked 1,000 hours is eligible to participate in the plan. The plan was formed effective January 1, 2016.

B. Contributions

The Plan has four sources of contributions made by either the participant or employer:

The first is an employee elective deferral contribution. Participants may contribute 1% to 90% of pretax salary up to a maximum of \$20,500 for 2022 and \$19,500 for 2021. All participants who have attained age fifty before the close of the taxable year shall be eligible to make "statutory catch-up contributions" in accordance with the IRS code. The allowable catch-up contribution for 2022 and 2021 was \$6,500.

The second is Roth elective deferrals, which are also permitted by the plan.

The third source of contributions is Employer matching contributions. All participants are eligible to receive the matching contributions. Matching contributions are calculated based on 100% of the first 3% of compensation. Matching contributions will be determined each payroll period.

The fourth is a participant rollover contribution. Participants may also contribute rollover or transfer amounts representing distributions from other qualified defined benefit or contribution plans.

C. Participants' accounts

Each participant account is credited with the participant's contribution and allocation of the Company's contribution, plan earnings and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Vesting

Participants are always 100 percent vested in their contributions. Employer contributions are vested as follows:

E. Forfeitures

Forfeitures of non-vested Company contributions are used to reduce any matching or discretionary contributions made by the employer. Forfeitures used for the periods ended October 31, 2022, and December 31, 2021 were \$14,979 and \$3,032, respectively.

F. Payments of Benefits

Benefits are payable upon the occurrence of any of the following events:

- (1) In-service distributions can be paid when a participant reaches age 59 1/2;
- (2) Attainment of normal retirement age (age 65);
- (3) Death while employed by the employer;
- (4) Disability, when it is determined that an employee is totally and permanently disabled;
- (5) Termination of employment; and
- (6) Termination of the Plan;
- (7) Hardship withdrawals from participant deferral accounts are allowed only if one of the following criteria are met: payment for medical expenses, purchase of primary residence, payment of tuition and educational fees for post-secondary education, and payments to prevent eviction and/or foreclosure on the mortgage of your primary residence.

On termination of service due to death, disability, retirement, or voluntary separation, a participant or beneficiary will receive a single lump sum cash payment equal to the vested value of the participant's account.

G. Plan Termination

The Plan was terminated at the close of business on October 31, 2022, and all assets transferred on at that time into the Principal Ease 401(k) Plan. The interests of all participants and beneficiaries accrued to the date of the termination become non-forfeitable.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Method of Accounting

The financial statements are prepared on the accrual basis of accounting for the year ended December 31, 2021 in that revenues are recognized when earned and expenses are recognized when incurred. The financial statements are prepared on the liquidation basis of accounting for the ten months ended October 31, 2022. Assets are valued at their estimated liquidation basis instead of fair market value.

B. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In accordance with the policy of stating investments at market value, net unrealized appreciation or depreciation for the year is reflected in the Statement of Changes in Net Assets Available for Benefits. Sales and purchases of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis.

Dividends are recorded on the ex-dividend date. Gains or losses are recognized on the date the investment is sold. See Note 6 for additional information.

D. Income Taxes

The Plan, which is a prototype plan of ADP, LLC, obtained its latest determination letter on October 6, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, followed the applicable requirements of the Internal Revenue Code. The plan is qualified and therefore, qualifies under Internal Revenue Code Section 401(a) and the trust is exempt from federal income taxes. The Company is required to file and does file Form 5500 with the Internal Revenue Service. On October 31, 2022, the Plan was terminated, and assets transferred to the Principal Ease 401(k) Plan. The Principal Ease 401(k) Plan uses the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan. This plan has a favorable determination letter dated June 30, 2022.

E. Date of Management's Review

Subsequent events were evaluated through December 7, 2023, which is the date the financial statements were available to be issued.

F. Reclassification

Certain comparative figures have been reclassified to conform to the current year presentation.

NOTE 3 - INVESTMENTS

The following is a summary of the information included in the Plan's financial statements and financial schedules for 2022 and 2021 which was prepared by the custodian of the Plan assets and furnished to the plan administrator. The plan administrator has obtained a certification from the custodian that such information is complete and accurate.

- A) Investments at the beginning and end of the year.
- B) Changes in net assets resulting from investment activities.
- C) Information included in the Supplementary Schedule of assets held at the end of the year.

NOTE 4 - RISKS AND UNCERTAINTIES

The Plan invests in mutual funds offered by Reliance Trust. These securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of certain investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE 5 – RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Reliance Trust was a party-in-interest as of December 31, 2021 and October 31, 2022.

NOTE 6- FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan can access.

Level 2 – quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, inputs other than quoted prices that are observable for the asset or inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of October 31, 2022 and December 31, 2021.

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.
