Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of SupplyLogic 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of February 28, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period ended February 28, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above, related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the financial Statements section of our report. FEBRUARY 28, 2023 AND DECEMBER 31, 2022

A. Description of Plan

The following description of the SupplyLogic 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- 1. General.** The Plan is a defined contribution plan covering substantially all employees of SupplyLogic, LLC (Employer or Plan Sponsor) who attained age 21 and completed three (3) months of service, with certain exclusions. Employees may enter the Plan immediately following the date that the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Administrative and Investment Committee is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Plan Merger and Transfer of Assets

During 2022, SupplyLogic, LLC acquired Webb Mason, LLC. In connection with the acquisition, effective as of January 1, 2023, SupplyLogic, LLC dba SLWM became the successor Plan Sponsor and Plan Administrator to the Webb Mason, LLC Plan, and the Webb Mason, LLC Plan name was changed to SLWM 401(k) Plan.

Effective as of January 1, 2023, all participants of the Plan became participants of the SLWM 401(k) Plan and no further contributions were permitted to the Plan. The net assets of the Plan participants remained in the Plan until the transfer of assets was completed.

On February 28, 2023, the net assets of the SupplyLogic 401(k) Plan totaling \$6,387,475 were transferred to the SLWM 401(k) Plan.

- 2. Contributions.** Contributions are subject to certain Internal Revenue Service (IRS) limitations. Each year, participants may contribute up to 100% of pretax annual compensation up to the maximum allowed by law or \$20,500 (in 2022; thereafter as adjusted by the U.S. Secretary of the Treasury) in a calendar year. Participants who have obtained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make Roth elective deferrals and contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants may also elect to make voluntary after-tax contributions. The Plan has an auto-enrollment feature. Participants direct the investment of the contributions into various investment options offered by the Plan. The Employer may make discretionary contributions. Effective February 2022, the matching formula was 50% up to 5% of pay contributed.
- 3. Participant Accounts.** Each participant's account is credited with the participant's contributions and matching contributions, as well as allocations of any other employer discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

A. Description of Plan (continued)

4. **Vesting.** Participants are immediately vested in their contributions plus actual earnings thereon, as well as qualified matching contributions, safe-harbor contributions and any other qualified non-elective contributions. Vesting in the Employer contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six (6) years of credited service or upon reaching normal retirement age, death or becoming disabled while an employee.

The years of vesting service is determined as follows:

5. **Notes Receivable from Participants.** The Plan allows for loans to participants. Generally, the loan amount may not exceed \$50,000 or 50% of the participant's vested account balance, and the term of the loan may not exceed five years unless the proceeds are used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the market rate ranging from 5.25% to 9.5%. Principal and interest payments on the outstanding loans are made through payroll deductions. Loans are considered in default if any scheduled loan repayment is not made as required.
6. **Payment of Benefits.** On termination of service due to death, disability or retirement, participants (or their designated beneficiaries) who have a balance greater than \$5,000 may elect to receive the total vested balance in a lump sum distribution or installments or may leave the balance in the Plan until the minimum distribution is required. A participant with a vested balance of less than \$5,000 will receive a mandatory lump sum distribution. A distribution of vested balances between \$1,000 to \$5,000 will be rolled over to an IRA unless the participant makes an affirmative election to either receive or roll over the distribution. Balances under \$1,000 will be paid as a lump sum distribution.

In-service distributions are allowed for participants upon attainment of age 59 ½. Financial hardship withdrawals are permitted set forth in the Plan to satisfy an immediate and heavy financial need.

Forfeited Accounts. At December 31, 2022, forfeited nonvested accounts totaled \$32,431. These accounts can be used to restore forfeitures, reduce the Employer's contribution, or offset Plan expenses. For the period ended February 28, 2023, no contributions were funded, and no plan expenses were paid from forfeited nonvested accounts. The transfer out of the Plan on February 28, 2023, included the \$33,299 balance in forfeited nonvested accounts. See Note A. Description of Plan – 1. General: *Plan Merger and Transfer of Assets*.

7. Plan Amendments.

Effective February 1, 2022, the Plan was amended and restated for the legislative and statutory changes in Plan provisions.

See Note A. Description of Plan – 1. General: *Plan Merger and Transfer of Assets.*

B. Summary of Significant Accounting Policies

Basis of Accounting: The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Net investment returns reflect certain fees paid by the investment funds to their affiliated investment advisors, transfer agents, and others as further described in each fund prospectus or other published documents. These fees are deducted prior to allocation of the Plan's investment earnings activity and thus are not separately identifiable as an expense.

Notes Receivable from Participants: Notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of February 28, 2023 or December 31, 2022. Delinquent participant loans are reclassified as distributions based on the terms of the Plan.

Corrective Contributions: Corrective contributions include qualified nonelective contributions or other plan corrections and are generally recorded in the year of the event as 'other employer contributions' in the statement of changes in net assets available for benefits. Any associated receivable is presented as 'other employer contribution receivable' as of the Plan's year-end.

B. Summary of Significant Accounting Policies (continued)

Corrective Distributions: Corrective distributions include Plan corrections that are generally recorded in the Plan year deemed payable to participants. Corrective distributions may also be required in the event that employee contributions exceed contribution limitations of the Plan allowed by the IRS. These amounts are netted against contributions in the statement of changes in net assets available for benefits and the associated liability is presented as ‘excess contribution payable’ as of the Plan’s year-end.

Payment of Benefits: Benefits are recorded when paid.

Expenses: Generally, the Plan’s administrative fees and expenses are shared by the Plan and the Plan Sponsor. Expenses paid by the Plan Sponsor are excluded from these financial statements. The Plan’s individual account fees and expenses are charged directly to participant accounts. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events: The Plan has evaluated subsequent events through December 1, 2023, the date the financial statements were available to be issued.

C. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable held at February 28, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest, and dividends, and interest on notes receivable for the period ended February 28, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

D. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification Topic 820 (ASC Topic 820) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at February 28, 2023 and December 31, 2022.

Mutual funds: mutual funds, which are actively traded, are valued at quoted market prices on nationally recognized securities exchanges and represent the net asset value (NAV) of shares held by the Plan at year-end and are classified as Level 1 within the valuation hierarchy.

Money market fund: mutual fund, which aims to pay money market interest rates, is valued based on the performance of the underlying assets and are classified as Level 1 within the valuation hierarchy.

As of February 28, 2023, there were no investments held by the Plan. See Note A. Description of Plan – 1. General: *Plan Merger and Transfer of Assets*.

E. Plan Termination and Partial Termination

The Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions allocated to their accounts. As a result of a reduction of the Plan Sponsor's workforce in 2023, the SLWM 401(k) Plan experienced a partial plan termination as defined by ERISA. Under ERISA, a partial plan termination may occur if a significant percentage of the Plan participants are terminated because of an action taken by the Plan Sponsor. All affected employees who were participants in the SLWM 401(k) Plan became 100% vested at the time of the partial plan termination.

F. Tax Status

The IRS has determined and informed the Plan Sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for the years prior to 2020.

G. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

H. Related Party Transactions and Party-In-Interest Transactions

During 2023 and 2022, Fidelity Management Trust Company was the trustee and the custodian of the Plan. The financial statements include recordkeeping and trustee expenses and fees paid by the Plan.

Fees paid during the year for accounting and other professional services rendered by parties-in-interest were based on customary and reasonable rates for such services.

The Plan issued notes to its participants, which are secured by the participants' balance.

These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.
