## Independent Auditor's Report

Participants and Plan Administrator  
TranSmart 401K Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of TranSmart 401K Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 1, 2023, December 31, 2022 and 2021, the related statements of changes in net assets available for benefits for the period ended January 1, 2023 and year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter—Plan Merger**

As discussed in Note 8 to the financial statements the Retirement Plan Committee of TranSmart, Inc., the Plan's sponsor, approved a resolution to merge the TranSmart 401K Plan into the Plan Sponsor's parent company sponsored plan, Atlas Technical Consultants 401(k) Plan, effective January 1, 2023. All assets of the TranSmart 401K Plan were transferred to the Atlas Technical Consultants 401(k) Plan on January 3, 2023. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

#### Note 1. Description of Plan

The following description of TranSmart 401K Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution salary reduction plan covering substantially all employees of TranSmart, Inc. and TranSmart Technologies, Inc. (collectively, the Company). Employees are allowed to participate in the Plan after one month of service and attaining the age of 21. The Plan qualifies as a tax-exempt plan under the provisions of the Internal Revenue Code (IRC) and complies with the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

As discussed in Note 8, the Plan was merged into Atlas Technical Consulting 401(k) Plan as a result of the Company being sold to Atlas Technical Consulting.

**Contributions:** Each year, participants may contribute up to 90% of their compensation, as defined by the Plan, up to the maximum percentage allowable by the Internal Revenue Service (IRS). Participants who will attain the age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan allows for Roth elective deferrals to be made to the Plan. The Plan allows for Company matching contributions equal to 100% of deferrals up to \$500 for participants employed on the last day of the year. The discretionary non-elective contribution requires participants to complete six months of service. For 2023 and 2022, there was no Company matching contribution or non-elective discretionary contribution. The Plan allows for a non-elective contribution to be made annually for employees who are employed at the end of the plan year at an amount equal to 3% of eligible compensation. No non-elective contribution was made by the Company in 2023 or 2022. Contributions are subject to certain limitations.

**Participant accounts:** Each participant's account is credited with the participant's contributions, Company matching contributions, discretionary non-elective contributions and allocations of plan earnings and losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions and the discretionary non-elective contributions. Participants are vested as follows for the Company matching contributions: after one year of service, 25%; after two years of service, 50%; after three years of service, 75%; and after four years of service, 100%. Effective January 1, 2021, the non-discretionary Company match vests as follows: after two years of service, 20%; after three years of service, 40%; after four years of service, 60%; after five years of service, 80%; and after six years of service, 100%.

**Participant investment options:** Upon enrollment in the Plan, a participant may direct their accounts in a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time throughout the year.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a reasonable lending rate. Participants may have one loan outstanding at a time. Note maturities range from one to five years, unless for the purchase of a personal residence, in which note maturities may not exceed 10 years. Principal and interest are paid ratably through monthly payroll deductions.

#### Note 1. Description of Plan (Continued)

**Payment of benefits:** Upon termination of employment, a former participant is entitled to receive the entire vested amount of their account in a single lump-sum payment in cash. If a participant's account value exceeds \$1,000 but is less than \$5,000, the administrator shall provide for the payment of such to the participant in a lump-sum within a reasonable time following termination. Upon death of a participant, the participant's accounts shall be payable to their beneficiary. A participant of the TranSmart Technologies 401(K) Retirement Plan who merged in on July 10, 2018, who has attained age 59½ or is disabled, but who has not terminated employment, is entitled to have the participant contributions portion of their accounts paid to him or her under the previous options. Also, former participants of the TranSmart Technologies 401(K) Retirement Plan may take a distribution upon attainment of disability from all eligible sources.

**Forfeited accounts:** At January 1, 2023, December 31, 2022 and 2021, forfeited nonvested accounts totaled approximately \$0, \$0 and \$7,900, respectively. These accounts will be used to reduce future Company contributions or pay plan expenses. In 2023 and 2022, no amounts were used to reduce Company matching contributions and no amounts were used to pay plan expenses.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits, and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price which would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accounted for on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document.

**Payment of benefits:** Benefit payments to participants are recorded when paid.

**Administrative expenses:** Administrative expenses can be paid either by the Company or from the Plan's assets. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

#### Note 3. Information Certified or Provided by Fidelity Management Trust Company, the Trustee

The Plan Administrator has obtained certifications from the trustee, that the information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosures under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and the supplemental schedule related to the following assets:

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Board (ASC) 820 are described below.

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 1, 2023, December 31, 2022 and 2021.

**Shares of registered investment companies:** Shares of registered investment companies are valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

**Money market fund:** Money market fund is valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily NAV and to transact at that price.

There were no investments measured at fair value held as of January 1, 2023 and December 31, 2022. The following table sets forth by level, within the fair value hierarchy, the Plan's assets measured at fair value as of December 31, 2021:

Plan management has evaluated the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the period ended January 1, 2023 and the years ended December 31, 2022 and 2021, there were no transfers in or out of Level 3.

#### Note 5. Related-Party and Party-in-Interest Transactions

Fidelity Management Trust Company (Fidelity) provides recordkeeping services to the Plan. Fidelity is the trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. The Plan paid \$0 and \$21,389 in fees to Fidelity during the period ended January 1, 2023 and the year ended December 31, 2022.

Certain employees of the Company provide administrative services to the Plan. These employees are not paid from the Plan for their services. In addition, the Company pays certain other outside administrative expenses on behalf of the Plan.

#### Note 6. Tax Status

The Plan has adopted the Pre-Approved Defined Contribution Plan of Fidelity Management & Research Company. The Fidelity Management & Research Company Pre-Approved Defined Contribution Plan has received an advisory letter from the IRS as to the Pre-Approved plan's qualified status. The Pre-Approved plan advisory letter has been relied upon by this Plan. The Plan has been amended since the Pre-Approved plan received the advisory letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

#### Note 7. Risks and Uncertainties

Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### Note 8. Merger and Subsequent Event

On October 11, 2022, the Plan Committee of TranSmart, Inc., the Plan's sponsor, approved a resolution to merge the TranSmart 401K Plan into the Plan sponsor's parent company sponsored plan, Atlas Technical Consulting 401(k) Plan, effective January 1, 2023. All assets of the TranSmart 401K Plan were transferred to the Atlas Technical Consulting 401(k) Plan on January 3, 2023.

The Plan Sponsor's management has evaluated subsequent events through December 13, 2023, the date on which the financial statements were available to be issued.
