### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of The Uniontown Hospital Employee Controlled Retirement Account, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of February 6, 2023, and June 30, 2022, and the related statements of changes in net assets available for benefits for the period from July 1, 2022, through February 6, 2023, and the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Uniontown Hospital Employee Controlled Retirement Account's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

**Note 1: Description of the Plan**

***General***

The following description of The Uniontown Hospital Employee Controlled Retirement Account (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan according to Section 403(b) of the Internal Revenue Code. The Plan is sponsored by Uniontown Hospital for the benefit of its employees. West Virginia University Hospitals, Inc. (WVUH) is the Hospital's sole corporate member. West Virginia University Health System, Inc. (WVUHS) is the sole corporate member of WVUH.

Former Plan participants now employed by other WVUHS affiliates are allowed to transfer their accounts to their new affiliated plans under the Plan's Plan-To-Plan Transfer provisions. During the year ended June 30, 2022, such transfers totaled \$45,606 and are reported as transfers to 403(b) plan in controlled group in the statement of changes in net assets available for benefits.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Executive Council of Uniontown Hospital serves as the administrator of the Plan. State Street Bank and Trust Company (State Street) serves as plan custodian and Transamerica Retirement Solutions Corporation (Transamerica) serves as plan record keeper.

***Plan Amendments and Merger***

The Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

Effective January 1, 2023, the Hospital's Board of Directors amended the Plan to provide that no employer (or other) contributions be made to the Plan after the contributions for the last Hospital pay period ending on or before January 1, 2023. At that time, all active Hospital employees commenced participation in the affiliated West Virginia University Health System 403(b) Retirement Savings Plan (WVUHS 403(b) Plan).

The Plan was also amended to provide for the merger of the Plan into the WVUHS 403(b) Plan, effective as soon as administratively practicable after January 1, 2023. The formal merger date was February 6, 2023. Upon the transfer of the Plan's assets to the successor WVUHS 403(b) Plan on the date of merger, the Plan ceased to exist.

***Contributions***

Prior to January 1, 2023, the Hospital made contributions of 2 to 6 percent of eligible wages based on the number of points earned by eligible full-time or part-time employees who had completed 90 days of service, or for occasional or casual employees who had completed 1,000 hours of service. Points were determined by the participant's age plus the participant's years of service as of the day before the beginning of each plan year. Contributions are subject to certain limitations.

***Participant Investment Account Options***

Investment account options available include various funds. Each participant has the option of directing the contributions into any of the separate investment accounts and may change the allocation daily.

***Participant Accounts***

Each participant's account is credited with the Hospital's contribution and plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in the Hospital's contributions plus earnings thereon.

***Payment of Benefits***

Upon termination of service, participants may elect to receive a lump-sum amount equal to the value of their account or have the balance rolled to an IRA or another plan.

**Note 2: Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Hospital or the Plan, at the Hospital's discretion.

**Note 3: Certification of Plan Custodian**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, State Street, a qualified institution, has certified the following investment information included in the accompanying financial statements is complete and accurate:

- Investments as shown in the statement of net assets available for benefits as of June 30, 2022.
- Investment income (loss) as shown in the statements of changes in net assets available for benefits for the periods ended February 6, 2023 and June 30, 2022.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

**Note 4: Disclosures about Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities.

Level 1 securities include mutual funds and are valued at the net asset value (NAV) of shares held at year-end. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

**Note 5: Investment Contract with Insurance Company**

The Plan holds a fully benefit-responsive investment contract with Prudential Retirement Insurance and Annuity Company (Prudential). Prudential maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Prudential, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract permits Prudential to terminate the investment contract upon 90 days' advance notice if Prudential determines that the continued operation of the fund is no longer commercially desirable for the class of business to which the contract belongs and Prudential notifies in writing all investors belonging to that class of business that the fund is being terminated. In conjunction with the Plan's merger, the contract was discontinued with no adjustment to the contract value transferred to the WVUHS 403(b) Plan.

**Note 6: Related Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives, of such persons.

Certain plan investments are invested in a fund managed by State Street, the custodian of the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Direct expenses paid to Transamerica, the Plan's recordkeeper, totaled \$29,202 and \$51,580 during the periods ended February 6, 2023, and June 30, 2022, respectively.

Direct expenses payable to Henderson Brothers, the Plan's investment advisor, totaled \$18,455 and \$37,328 for the periods ended February 6, 2023, and June 30, 2022, respectively.

Certain legal and accounting fees and certain other administrative expenses relating to the Plan are paid by the Hospital. In addition, the Hospital provides certain administrative services at no cost to the Plan.

**Note 7: Tax Status**

The Plan, together with its investment vehicles, was intended to be a tax-sheltered annuity plan under Section 403(b) of the Internal Revenue Code of 1986, as amended. The Plan operated under a pre-approved volume submitter 403(b) plan document sponsored by Transamerica Retirement Solutions LLC. Therefore, the plan administrator believes the Plan was designed and operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

**Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
