Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of ESG Operations, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits for the period ended February 28, 2023 (Date of Merger), and for the years ended December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the period beginning January 1, 2023 and ending February 28, 2023 (Date of Merger), and for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of ESG Operations, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution, or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of February 28, 2023 (Date of Merger), and December 31, 2022 and 2021, and for the period beginning January 1, 2023 and ending February 28, 2023 (Date of Merger) and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Emphasis of Matter

As discussed in Note 1, effective February 28, 2023, the Plan was merged into the Inframark 401(k) Savings Plan. Participants ceased participation in the Plan and their balances were transferred.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of ESG Operations, Inc. 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about ESG Operations, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore, is not a guarantee that an audit conducted in accordance with generally accepted accounting standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the ESG Operations, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees of ESG Operations, Inc., Environmental Services Group, Utili-Vision, Inc., and Utilichem, Inc. (the “Companies”) who have completed three months of service and are age 18 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective October 15, 2021, the Plan Sponsor merged with Inframark, LLC. Until February 28, 2023 (Date of Merger), employees of the Plan Sponsor continued to participate in the ESG Operations, Inc. 401(k) Profit Sharing Plan. Effective as of the close of business on February 28, 2023 (Date of Merger), employees of the Plan Sponsor ceased participation in the Plan and began participating in the Inframark 401(k) Savings Plan effective March 1, 2023. The Plan merged into the Inframark 401(k) Savings Plan to form a single plan, effective February 28, 2023, and as a result all remaining participant account balances were transferred to the Inframark 401(k) Savings Plan on March 1, 2023, the first banking workday following the merger date.

The contributions receivable as of February 28, 2023 (Date of Merger), presented on the Statement of Net Assets Available for Benefits, represent Employer matching contributions which were deposited directly into the Inframark 401(k) Savings Plan.

Eligibility for Participation

Employees of the Companies are generally eligible to participate in the Plan on January 1, April 1, July 1, and October 1 after the completion of three months of service, and attaining the age of 18.

Contributions

Each year, participants may contribute a portion of their compensation as defined in the Plan. The Plan allows participant contributions up to 100% of eligible compensation, up to the maximum allowed by the Internal Revenue Service (“IRS”). The Companies contribute 3% of base compensation for each participant, regardless of if the employee contributes to the Plan or not. The Plan also provides for a discretionary profit sharing contribution determined by the Board of Directors (the “Board”). All contributions are subject to the limitations provided in ERISA and the Internal Revenue Code (“IRC”). No profit-sharing contributions were made to the Plan for the year ended December 31, 2022.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and an allocation of (a) the Company’s contribution, if any, (b) Plan earnings or losses, and (c) forfeitures of terminated participants’ non-vested accounts, as applicable. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1 - DESCRIPTION OF THE PLAN - CONTINUED

Participants' Investment Options

Participants must direct their salary deferral contributions and any matching or discretionary profit sharing contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options any time throughout the year and have direct access to Lincoln Financial Group through the internet or telephone.

Vesting

Participants are immediately vested in their voluntary contributions as well as the Companies' safe harbor contributions, plus actual earnings thereon. Vesting in the Companies' profit sharing contribution portion of their accounts, plus earnings thereon, is based on years of services. A participant is 100% vested after six years of credited service for profit sharing contributions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount or in installments. If a participant's vested account balance is less than \$5,000, the participant will receive a lump sum distribution. If a participant's vested account balance is greater than \$5,000, the participant may receive the value of the vested interest in his or her account as a lump sum distribution, or the participant may elect to wait until he or she reaches normal retirement age or death, in which they will receive distributions as discussed above. For termination or service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Notes Receivable From Participants

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest from 4.25% to 8.50%, which is commensurate with local prevailing rates at the time of issuance. Loans must be repaid in quarterly payments within five years, or longer for purchase of a primary residence.

Plan Termination

Prior to the final transfer of the Plan's assets to the Inframark 401(k) Savings Plan, the Companies had the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan had been terminated, participants would have become 100% vested in their accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value except for the fully benefit responsive investment contract which is held at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowances for credit losses have been recorded as of December 31, 2022 and 2021. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Transfers from the Plan

For the period January 1, 2023 through February 28, 2023 (Date of Merger), net transfers to the Inframark 401(k) Savings Plan were \$23,546,635.

NOTE 3 - FAIR VALUE MEASUREMENTS

Financial Accounting Standard Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, Fair Value Measurement (“ACS 820”) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets, or liabilities (Level 1 Measurement) and the lowest priority to unobservable inputs (Level 2 measurements). The three levels of the fair value hierarchy under this guidance are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level or any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

At February 28, 2023 (Date of Merger), the Plan held no investments.

NOTE 4 - INVESTMENT CONTRACT

The Plan holds investments in an investment contract with Lincoln National Life Insurance Company (“Lincoln”). The assets invested under this contract are reported as the Stable Value Fund in the Plan’s accounting records which are considered fully benefit responsive. Lincoln maintains the contributions to the account, and the account is credited with actual earnings on the underlying investments and decreased for Plan withdrawals and administrative expenses.

Because this contract meets the fully benefit-responsive investment contract criteria, the contract is reported at contract value. Contract Value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a periodic basis.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual agreements may be affected by future economic, financial, and regulatory development.

Certain events limit the ability of the Plan to transact at contract value with the issuer. The Plan Administrator believes that any events that would limit the Plan’ ability to transact at contract value with participants are probable of not occurring.

NOTE 5 - ADMINISTRATIVE EXPENSES

Certain administrative functions are performed by officers or employees of the Companies. No such officer or employee receives compensation from the Plan. The majority of all administrative expenses are paid directly by the Companies. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments.

NOTES TO FINANCIAL STATEMENTS

NOTE 6 - CERTIFIED INVESTMENTS

All investment information disclosed in the accompanying financial statements, including investments held at December 31, 2022 and 2021, and net appreciation (depreciation) in fair value of investments and interest and dividend income period beginning January 1, 2023 and ending February 28, 2023 (Date of Merger) and for the year ended December 31, 2022, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Lincoln Financial Group, the custodian of the Plan.

NOTE 7 - INCOME TAX STATUS

The Plan uses a volume submitter 401(k) plan created by Lincoln Financial Group, the Plan's service provider. Lincoln Financial Group received an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2014, which states the volume submitter 401(k) plan satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has not obtained an individual determination letter and has been amended since receiving the Lincoln Financial Group opinion letter, the Plan Administrator and the Plan's tax counsel believe the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. The Plan Administrator believes the Plan has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.

NOTE 8 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are units of mutual funds managed by Lincoln Financial Group. Lincoln Financial Group is the custodian of the Plan's assets and therefore qualifies as a party-in-interest. Fees paid by the Plan for the investment management services amounted to \$14,590 for the period beginning January 1, 2023 and ending February 28, 2023, and \$70,089 for the year ended December 31, 2022. This party-in-interest transaction is exempt from the Prohibited Transaction Rules of ERISA. There are no other related parties or party-in-interest transactions.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
