Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Bashas' RetirementPlus Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The schedule of delinquent participant contributions for the period ended January 1, 2023 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Bashas' RetirementPlus Plan (the Plan), is provided for general information purposes only. Reference should be made to the Plan document for a complete description of the Plan's provisions.

General

The Plan was a defined contribution plan originally effective as of January 1, 1992. The Plan had been restated and amended throughout the years to comply with tax legislation. The Plan was most recently amended effective December 14, 2021 and restated effective January 1, 2023 to transfer sponsorship to Raley's Arizona, LLC (the Company) in connection with the purchase of Bashas'. The Plan was subjected to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Bashas' Welfare & RetirementPlus Plans Administrative Committee was responsible for the oversight of the Plan and determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Effective January 1, 2023, Bashas' RetirementPlus Plan merged into Raley's Arizona, LLC (the Company) in connection with the purchase of Bashas' and became a participating employer on the effective date.

Eligibility

The Plan excluded leased employees, union members, nonresident aliens, and independent contractors. All other employees were eligible to participate in the Plan upon satisfaction of the eligibility requirements of age 18 and one year of service, as defined by the Plan, and enter the Plan monthly coinciding with or next following the date the eligibility requirements were satisfied.

Contributions

Participants could have elected to defer up to 75% of compensation, subject to Internal Revenue Code (IRC) limitations. Participants age 50 and older by the end of the Plan year may make catch up contributions.

The Company might have at its discretion, made a matching contribution to the Plan. In order to be eligible for an allocation of the match contribution, participants must have been employed on the last day of the allocation period. This requirement was waived if the participant is no longer employed with the Company as a result of retirement, death, or disability. Matching contributions to the Plan for the period ended January 1, 2023 and December 31, 2022 were \$- and \$2,469,662, respectively.

Participants could have also contributed amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

NOTE 1 DESCRIPTION OF THE PLAN (CONTINUED)

Participant Accounts

Each participant's account was credited with the participant's contribution, an allocation of the Company's discretionary matching contributions, if applicable, and Plan earnings or losses. Participant accounts were charged with an allocation of administrative expenses that are paid by the Plan. Allocations were based on participant earnings or account balances, or participant transactions as defined. The benefit to which a participant was entitled to the benefit that could have been provided by the participant's vested account.

Vesting

Participants were always 100% vested in their 401(k) elective deferrals and rollover contributions, plus earnings thereon.

Vesting in Employer contributions was based on a five-year graded schedule. Participants became 20% vested after completion of one year of service, as defined by the Plan, and an additional 20% for each year of service thereafter. Once the participant had been credited with five years of service, they are 100% vested. This vesting schedule applied to participants with a date of hire on or after January 1, 2013. Prior to January 1, 2013, all participants were 100% vested in their accounts at all times. Notwithstanding the above, a participant was fully vested upon reaching normal retirement age, death, or permanent disability.

Payment of Benefits

Upon termination of employment, death, disability, or retirement, a participant could have elected to receive the value of their account in the form of a lump sum distribution. The Plan allowed for in-service distributions once the participant had attained age 59½, and hardship distributions subject to Plan provisions.

If a participant terminated employment and the participant's account balance did not exceed \$1,000, the Plan administrator could have authorized the immediate cash-out payment without the participant's consent.

Forfeited Accounts

Forfeited nonvested accounts are used to reduce future contributions. Forfeited nonvested accounts as of January 1, 2023 and December 31, 2022 totaled \$-0- and \$20,465, respectively. There were no forfeitures used to reduce 2023 or 2022 contributions.

Notes Receivable from Participants

Participants could have borrowed from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever was less. Note terms are up to five years. If the loan is to purchase the principal residence of the participant, the loan term could have been up to 15 years. The notes are secured by the balance in the participant's account and bear interest at prime rate. Principal and interest are paid ratably through payroll deductions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefit payments are recorded when paid.

Use of Estimates

The preparation of the Plan's financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period, and, when applicable, disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of January 1, 2023 and December 31, 2022. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Expenses of the Plan

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to benefit payments are charged directly to the participant's account and are included in administrative expense. Investment-related expenses are charged to participants accounts and are also included in administrative expense.

Subsequent Events

The Plan has evaluated subsequent events through December 7, 2023, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Delaware Charter Guarantee & Trust Company dba: Principal Trust Company, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment and notes receivable information reflected on the accompanying statements of net assets available for benefits as of January 1, 2023 and December 31, 2022 and the statement of changes in net assets available for benefits for the period and year then ended.

NOTE 4 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at January 1, 2023 and December 31, 2022.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Funds: Valued at the net asset value (NAV) of units of a bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The Plan uses fair value measurements to record fair value adjustments to certain assets and liabilities and to determine fair value disclosures.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in conditions in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

NOTE 6 TAX STATUS

The IRS issued favorable determination letters on the form of the Plan. The Plan has been amended since receiving the determination letters; however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

The Plan investments were managed by Principal Trust Company for the period ended January 1, 2023 and the year ended December 31, 2022. Principal is the trustee as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions.

NOTE 8 PLAN TERMINATION

The Company reserves the right to terminate the Plan. Effective January 1, 2023, Bashas' RetirementPlus Plan merged \$118,963,817 into Raley's Arizona, LLC (the Company) in connection with the purchase of Bashas' and became a participating employer on the effective date.

Most of the delinquent contributions were the result of a change in payroll systems during 2022 and are not customary for the Plan.
