INDEPENDENT AUDITOR'S REPORT

To The Plan Trustees

Opinion

We have audited the financial statements of Matheson Trucking Health and Welfare Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan benefit obligations as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits and of changes in plan benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and plan benefit obligations of the Plan as of December 31, 2022 and 2021, and the changes in its net assets available for benefits and plan benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Substantial Doubt About the Entity’s Ability to Continue as a Going Concern

The accompanying financial statements have been prepared assuming that the plan will continue as a going concern. As discussed in Note 7 to the financial statements, Matheson Trucking, Inc. (the “Company”) has suffered recurring losses from operations and has stated that substantial doubt exists about the Plan’s ability to continue as a going concern due to expected loss of significant revenue generating contracts in the short term. Management’s evaluation of the events and conditions and management’s plans regarding these matters are also described in Note 7. The financial statements do not include any adjustments that might result from the outcome of this uncertainty. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Responsibilities of Management for the Financial Statements (Continued)

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

NOTES TO FINANCIAL STATEMENTS

December 31, 2022 and 2021

NOTE 1: **DESCRIPTION OF PLAN**

The following description of the Matheson Trucking Health and Welfare Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Matheson Trucking Health and Welfare Plan (the "Plan") was established on January 1, 2013 to provide health and welfare benefits to eligible employees and covered dependents of Matheson Trucking, Inc. ("Trucking"), and its wholly-owned subsidiaries, Matheson Postal Services, Inc. ("Postal"), and Matheson Flight Extenders, Inc. ("Flight"), collectively (the "Plan Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Certain assets of the Plan are held in Voluntary Employees' Beneficiary Association (VEBA) trust (the "Trust").

Full-time Trucking employees who are regularly scheduled at least 30 hours per week are eligible to participate and are covered the first day of the month following the date of hire. Full-time Postal and Flight employees who are regularly scheduled at least 30 hours per week are eligible to participate and are covered the first day of the month following 60 days of service.

Contributions

The Plan Sponsor makes contributions to the Plan as needed to fund claims for Trucking employees. For Postal and Flight Extender employees covered under the Service Contract Act, the Plan Sponsor contributes to the Plan based on an hourly funding formula. Any deficiency of the Plan's net assets over benefit obligations is funded by the Plan Sponsor on a pay-as-you-go basis.

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections and to extend coverage to their eligible dependents. Participants pay the full cost of dental and vision coverage, supplemental and dependent life insurance and supplemental accidental death and dismemberment insurance programs based on the current group rate premium costs. These contributions are deducted monthly from the employees' wages, however for all employees not covered by the Service Contract Act, such contributions are not separated from employer contributions when remitted to the Trust and are therefore included in Employer Contributions on the Statements of Changes in Net Assets Available for Benefits. The Plan Sponsor pays the full cost of basic life insurance and basic accidental death and dismemberment insurance for eligible employees enrolled in medical coverage. Terminated, retired, and totally disabled participants electing continued coverage contribute monthly amounts as provided by the Plan.

Benefits

The Plan provides medical, dental, prescription drug, vision coverage, life insurance, disability benefits, and accidental death and dismemberment benefits covering eligible employees of the Plan Sponsor and their dependents.

Self-Insured Benefits

Claims for medical, dental and vision benefits are subject to various deductible and co-payment amounts. The Plan provides these benefits on a self-funded basis, subject to a stop loss limit. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and then are reimbursed by either the Plan's VEBA trust or the general assets of the Plan Sponsor. Despite the Plan's utilization of third-party claims' processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

NOTE 1: **DESCRIPTION OF PLAN (Continued)**

Self-Insured Benefits (Continued)

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan actual utilization pattern of specific drugs.

Insured Benefits

The Plan fully insures life insurance, accidental death and disability, and short-term disability and long-term disability benefits. The Plan purchases annual insurance contracts for these insured benefits. Premiums for basic life and accidental death and disability insurance are paid by the Plan Sponsor. Premiums for all other insured benefits are paid by the employee through payroll deductions.

Stop Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

NOTE 2: **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are maintained on the accrual basis of accounting in accordance with generally accepted accounting principles of the United States (U.S. GAAP).

Concentration of Credit Risk

The Plan maintains its cash in bank deposit accounts which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts and the Plan's management believes it is not exposed to any significant credit risk on cash.

Claims Incurred But Not Reported

Claims that have been incurred but not reported to the Plan are due to a lag in the timing of reporting incurred claims. An estimate of claims incurred but not reported has been included in these financial statements. The Plan self-funds medical, prescription, vision and dental benefits provided to participants but insures life, accidental death and dismemberment, and short-term and long-term disability benefits. As of each December 31, there are self-funded claims that have been incurred on which benefit payments will be made subsequent to that date. The liability for claims payable and claims incurred but not reported (IBNR) was estimated by developing completion factor using the claims patterns, claims trend rates, and actual lag data provided by the Plan's claims processor for the prior 24 months and applying the factor to the claims that were paid for each insurable month. These amounts are paid by the Plan only if claims are ultimately submitted and approved for payment.

Payment of Benefits

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators. Premiums paid through either the Company's general assets or the VEBA trust are recorded as premium payments when paid.

Refunds and Rebates

The Plan receives various refunds and rebates from the Plan claims administrators, insurance providers and brokers. These refunds and rebates are recorded when earned. Refunds and rebates due as of the financial statement date are reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates of \$260,600 and \$185,500 for the years ended 2022 and 2021, respectively, have been netted against claims paid.

Administrative Expenses

All administrative expenses may be paid by the Plan unless paid by the Plan Sponsor. During the years ended December 31, 2022 and 2021, the Plan paid for substantially all administrative expenses, which consisted of claims administration fees, broker fees and other miscellaneous expenses.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Income Taxes

The Trust is a qualified voluntary employees' beneficiary association (VEBA) and has received a favorable tax determination letter, dated June 29, 2016, from the Internal Revenue Service indicating that the Plan is exempt from federal income tax under section 501 (c)(9) of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has determined that as of December 31, 2022 there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine examinations by taxing authorities; however, there are currently no examinations for any tax periods in progress.

Estimates and Assumptions

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and benefit obligations and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTE 4: RISKS AND UNCERTAINTIES

The liability for claims payable and claims incurred but not reported was estimated by applying claims completion factors for the prior 24 months claims patterns, claim trend rates, and actual lag patterns of the Plan. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and benefit obligations.

NOTE 5: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan pays administrative expenses to third party administrators and professional service providers of the Plan. The transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

The Plan Sponsor, a related party, makes contributions to the Plan as needed to fund claims for Trucking employees. Any deficiency of the Plan's net assets over benefit obligations is funded by the Plan Sponsor on a pay-as-you-go basis.

NOTE 6: PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Plan Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 7: BANKRUPTCY

Effective May 5, 2022, Matheson Postal Services, Inc. and Matheson Flight Extenders, Inc. had filed petition for Chapter 11 bankruptcy. The Company continues to operate and make contributions to the Plan. The Company contracts with United States Postal Service (USPS) and more than 90% of its revenue is generated from various USPS contracts. These USPS contracts are expiring between October 2023 and January 2024. The Company may not be able to operate as a business into the future (less than 12 months subsequent to the financial statement date) without replacing the lost revenues with new revenue streams or renegotiating the expiring contracts with USPS. As of the date of these financial statements, the Company does not have any future plans to replace USPS revenues and renegotiation of USPS contracts is unlikely. The Company does not believe it will have sufficient funds necessary to maintain its operations considering its current financial condition, obligations, and other expected cash flows. There is substantial doubt about the Company's ability to continue as a going concern within one year after the date these financial statements are issued.

NOTE 8: SUBSEQUENT EVENTS

Plan management has evaluated events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Plan management has evaluated subsequent events through December 15, 2023, the date the financial statements were available to be issued and has determined that no subsequent events have occurred that should be disclosed other than the matter described in Note 7 and the one noted below.

On November 14, 2023, the governing body of the Plan made an election to terminate the Plan effective January 31, 2024.


