### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of PRA Holdings, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2022 and 2021 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

## Notes to Financial Statements

### 1. Description of Plan

The following description of the PRA Holdings, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### ***General***

The Plan was a defined contribution plan covering substantially all employees of PRA International Operations, Inc., Pharmaceutical Research Associates, Inc., and Research Pharmaceutical Services, Inc. (collectively the “Company”) who had one month of service and were age 18 or older. The Administrative Committee of the Company controlled and managed the operation and administration of the Plan. Fidelity Management Trust Company (the “Trustee”) served as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### ***Plan Merger***

As of December 31, 2022, the Plan’s accounts and assets totaling approximately \$589,000,000 were in the process of being transferred to ICON Clinical Research, LLC 401(k) Plan. The Plan was subsequently dissolved.

#### ***Contributions***

Each year, participants could contribute compensation, as defined in the Plan document, subject to certain Internal Revenue Code (“IRC”) limitations. Participant salary deferrals could be traditional 401(k) (pretax) or Roth 401(k) (after-tax), and other additional after-tax contributions. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts.

In 2022, the Company contributed a matching contribution of 100% of the first 3% of compensation that a participant contributed to the Plan and 50% of the next 3% of compensation that a participant contributed to the Plan. Additional amounts could be contributed at the discretion of the Company’s board of directors. The Company made no additional contributions in 2022. Contributions are subject to certain limitations.

#### ***Investment Options***

Participants directed the investment of their accounts into various investment options offered by the Plan. The Plan offered various mutual funds and a stable value collective trust fund as options prior to the liquidation and transfer of assets on December 31, 2022.

#### ***Participant Accounts***

Each participant’s account was credited with the participant’s contributions, Company contributions, if any, and allocations of Plan earnings. The account was charged with benefit payments, transaction fees, and allocations of administrative expenses and Plan losses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account.

### ***Vesting Provision***

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts, if any, plus actual earnings thereon was based on years of continuous service. Participants were vested in Company contributions at 20% after each year of service. A participant was 100 percent vested after five years of credited service. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### ***Notes Receivable from Participants***

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. The loans were secured by the balance in the participant's account and bore interest at rates which were commensurate with local prevailing rates as determined by the Plan administrator. Outstanding loans of approximately \$6,800,000 as of December 31, 2022 were transferred to the ICON Clinical Research, LLC 401(k) Plan. Outstanding loans bore interest rates ranging from 3.25% to 7.00%. Principal and interest were paid ratably through payroll deductions.

### ***Payment of Benefits***

On termination of service, death, disability, retirement, or for other reasons, a participant could elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount as provided by the Plan document. Amounts contributed on a before-tax basis could only be withdrawn upon demonstration of financial hardship, disability, or after the participant reaches the age of 59.5 years.

### ***Forfeitures***

At December 31, 2022 approximately \$5,900,000 of forfeited nonvested accounts were transferred to the ICON Clinical Research, LLC 401(k) Plan. At December 31, 2021, forfeited nonvested accounts totaled approximately \$2,700,000. In 2022, forfeitures of \$132,693 were used to offset Plan expenses.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with Accounting Principles Generally Accepted in the United States of America ("GAAP").

### ***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

***Payment of Benefits***

Benefits are recorded upon distribution.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable and distributions) are charged directly to the participant's account.

***Subsequent Events***

The Plan has evaluated subsequent events through December 11, 2023, the date the financial statements were available to be issued.

**3. Fair Value Measurements**

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

**Level 1:** Observable inputs such as quoted prices in active markets.

**Level 2:** Inputs other than quoted prices in active markets that are either directly or indirectly observable.

**Level 3:** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2022 and 2021. The following is a description of the valuation methodologies used for assets measured at fair value.

**Mutual funds**

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

**Stable value collective trust fund**

The Plan invests in a stable value collective trust fund for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the Net Asset Value (“NAV”) per share provided by the trustee as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The stable value collective trust fund is not required to be classified within a level on the fair value hierarchy.

There were no assets in the Plan as of December 31, 2022. The following table sets forth by level within the fair value hierarchy the Plan’s assets accounted for at fair value on a recurring basis as of December 31, 2021:

#### **5. Exempt Party-In-Interest Transactions**

Certain Plan investments were managed by Fidelity Advisor, a related party to the Trustee. As described in Note 2, the Plan paid certain expenses related to the Plan operations and investment activity to various service providers, including Fidelity Advisor. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid by the Plan for administrative services were \$507,317 for the year ended December 31, 2022. These transactions qualify as exempt party-in-interest transactions under ERISA.

#### **6. Income Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (the "IRS") stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on the IRS approval of the prototype plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated June 30, 2020 that the prototype plan document was designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
