### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Evoque 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of April 19, 2023, December 31, 2022 and 2021, the related statements of changes in net assets available for benefits for the period January 1, 2023 through April 19, 2023 and for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of April 19, 2023, December 31, 2022 and 2021, and for the period January 1, 2023 through April 19, 2023 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. **Emphasis of Matter—Plan Merger**

As discussed in Note 1 to the financial statements, all plan assets were transferred to the control of the BuildWise Pooled Employer Plan (BuildWise PEP) on April 3, 2023, with the exception of the guaranteed investment contract, which transferred out as of April 19, 2023. Our opinion has not been modified with respect to this matter.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Note 1. Plan Description

The Evoque 401(k) Plan (the Plan) is a defined contribution plan covering substantially all employees of Dawn U.S. Holdings, LLC d/b/a Evoque Data Center Solutions (the Company, Plan Sponsor or Administrator). The Plan is designed to comply with the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and the Internal Revenue Code (IRC).

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. In the event of any conflict between this description and the Plan agreement, the Plan agreement will govern.

**General:** Employees become eligible upon date of hire. Nonresident aliens who receive no earned income from the Company within the United States of America, leased employees, an individual considered by the Company to be an independent contractor who is later determined by the Internal Revenue Service (IRS) to be an employee, and an employee participating in any other profit-sharing plan to which the Company contributes directly or indirectly are not eligible to participate in the Plan. Employees may begin participating in the Plan on the earliest date on which the employee meets the eligibility criteria.

The Plan Administrator has the responsibility to administer the Plan in accordance with its terms. The Company has the responsibility to establish and maintain the investment policy, select investment funds available to the participants, periodically evaluate investment performance and recommend changes in investment options.

Delaware Charter Guarantee & Trust Company (d/b/a Principal Trust Company) is the asset custodian and trustee (custodian or trustee) and is responsible for the custody and management of the Plan's assets. Principal Life Insurance Company (Principal) is the Plan's recordkeeper and is responsible for maintaining participants' accounts and executing participant-initiated transactions.

**Plan merger:** During 2023, the Compensation Committee of Dawn U.S. Holdings, LLC, the Plan's sponsor, voted, to merge the Plan into the BuildWise PEP. Evoque employees became participants in the BuildWise PEP on April 1, 2023. All plan assets were transferred to the control of the BuildWise PEP on April 3, 2023, with the exception of the guaranteed investment contract, which transferred out on April 19, 2023.

**Financial statement presentation:** These financial statements include the period from January 1 to April 19, 2023 and the years ended December 31, 2022 and 2021. The Plan elected to defer the filing of its financial statements with its Form 5500 for the year ended December 31, 2022, as permitted by 29 CFR 2520.104-50, since the following Plan year ended April 19, 2023, is a short year of seven months or less. Accordingly, the Plan has included statements of net assets as of April 19, 2023, December 31, 2022, and December 31, 2021, along with statements of changes in net assets for the period from January 1 to April 19, 2023 and for the year ended December 31, 2022, as required by DOL regulations when such election is made.

#### Note 1. Plan Description (Continued)

**Contributions:** Employees can make elective and voluntary pre-tax contributions, with a maximum contribution percentage of 50% of eligible compensation, as defined in the Plan agreement, not to exceed the maximum amount allowable under the IRC. Participants are automatically enrolled in the Plan at a deferral percentage rate of 3% of eligible compensation. Participants may opt out of the Plan or elect a different percentage once enrolled. On January 1 of each year, there is an annual increase of 1% for all active participants. Participants have the option to opt out of the annual increase or elect any percentage to increase deferrals by each year. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make contributions to the Plan in the form of rollover funds from another qualified plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company matches a discretionary amount of each participating employee's contribution up to a certain maximum. The percentage of elective deferral match is solely determined by the Company as specified in the Plan agreement. For the period ended April 19, 2023 and the year ended December 31, 2022, the matching contribution was 80% of each employee's contribution amount up to the first 6% of the participating employee's eligible wages. The Company may elect to make profit sharing contributions to the Plan. No profit-sharing contributions were made during the 2023 or 2022 plan years.

**Participant accounts:** Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Company's matching contribution (as defined in the Plan agreement), profit-sharing contributions, if any, rollovers, and applicable earnings or losses on investments.

**Vesting:** Participants have a fully vested interest in their participant elective deferral, catch-up, Roth and rollover contributions, plus actual earnings and losses thereon. The Plan provides 100% vesting upon death, disability and at retirement. Participants become 100% vested in employer matching and profit sharing contributions, after one year of service under the Plan agreement.

**Notes receivable from participants:** Participants may borrow from their vested fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have three loans outstanding at a time. Loans bear interest based on the rates available for similar loans from commercial lending institutions determined by the loan administrator. Loans are secured by the balance in their participant account and must be repaid within a maximum of five years or ten years if loan is used to acquire a dwelling unit. Loans outstanding at December 31, 2022, bear interest at rates that range from 4.25% to 8.00% and mature through April 2031. Principal and interest are paid ratably through payroll deductions, which are made at least monthly. There were no notes outstanding as of April 19, 2023.

**Payment of benefits:** Participants are eligible to receive the vested balance of their accounts upon death, retirement, termination of employment or total and permanent disability as either a lump sum payment or an annuity payment. Upon termination of service, if the participant's account balance is \$5,000 or less, a participant may elect a lump-sum distribution. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. In-service withdrawals from a participant's account are allowed once a participant reaches age 59½. Once a participant reaches age 72, they are required to start withdrawing a minimum amount each year.

**Hardship withdrawals:** The Plan provides for participant withdrawals in the event of financial hardship. Hardship withdrawals are approved upon meeting the IRC requirements for a hardship withdrawal.

**Forfeited accounts:** Forfeitures of non-vested participant accounts are used to pay Plan administrative expenses and then to fund employer contributions. For the period from January 1, 2023 through April 19, 2023, and the year ended December 31, 2022, the Plan used approximately \$23,000 and \$39,000, respectively, of forfeited non-vested accounts to pay Plan administrative expenses. The Plan had a forfeited non-vested account balance of approximately \$0, \$22,000, and \$43,000, respectively, at April 19, 2023 and years ended December 31, 2022 and 2021.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Use of estimates:** The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to use estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** All of the Plan's investments are reported at fair value with the exception of the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan's Company determines the Plan's valuation policies utilizing information provided by the trustee and custodian. See Note 4 for discussion of fair value measurements.

**Risks and uncertainties:** The Plan provides for investments in various investment securities, which in general, are exposed to various risks, such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Payment of benefits:** Benefit payments are recorded when paid.

**Administrative expenses:** Expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value investments.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are reclassified as distributions. No allowance for credit losses has been recorded as of April 19, 2023 or December 31, 2022 and 2021.

#### Note 4. Fair Value Measurements

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurement, establishes a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology includes quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 19, 2023, and years ended December 31, 2022 and 2021.

**Common collective trust funds:** Common collective trust funds are valued at net asset value (NAV). The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

**Pooled separate accounts:** Pooled separate accounts are valued at the NAV or equivalent based on the units of the pooled separate accounts. The NAV, as provided by the trustee, is used as a practical expedient to estimate the fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods used to value investments may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5. Fully Benefit-Responsive Investment Contract

The Plan has the Principal Fixed Income Guaranteed Option in its investment portfolio, which is a fully benefit-responsive guaranteed interest contract issued by Principal, which is reported at contract value. Principal maintains the contributions in a general account. The account is credited with contributions, earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a semiannual basis for resetting.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value daily. Contract value represents contributions made to the fund, plus earnings, less participant withdrawals and administrative expenses. If the value of the guaranteed interest balance is to be paid, transferred, or applied in full, and any fees for that balance are due but unpaid, Principal will deduct such fees before making such payment, transfer, or application. Payments or transfers made in accordance with the guaranteed interest contract are subject to the limitations contained in the agreement with Principal and will be made in full within three business days after the date payment or transfer has been requested. In the event that market conditions are such that Principal determines they will not allow for the orderly transfer or sale of financial instruments, up to an additional 30 days may be required for Principal to make such payments or transfers. The net credit rating as of April 19, 2023, December 31, 2022 and 2021, was a 4.35%, 4.35% and 1.60%, respectively, effective annual rate.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include Plan termination, Plan merger, liquidation of contract and insolvency of the Plan Sponsor. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

#### Note 6. Tax Status

The Plan is a prototype non-standardized profit-sharing plan sponsored by Principal Life Insurance Company. The prototype plan has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is tax-exempt. The Plan Sponsor has determined that it is eligible and has chosen to rely on the current IRS prototype plan opinion letter. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 7. Related-Party and Party-in-Interest Transactions

Certain Plan investments include a fixed annuity contract, collective trust funds and pooled separate accounts managed by the trustee and custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions. Certain administrative fees related to the administration of the Plan are paid by the Company. The Plan also has notes receivable from certain of its participants. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibited transactions rules under ERISA.

During the Plan years ended December 31, 2022 and 2021, the Company inadvertently failed to deposit participant deferrals within the required timeframe as stated by the United States DOL regulations. The DOL considers late deposits to be non-exempt prohibited transactions. The lost earnings and excise tax payments were made in 2022 from the Company's assets and not from assets of the Plan. There were no late deposits for the period from January 1, 2023 to April 19, 2023.
