INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of
Legacy EJY Subsidiary LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Legacy EJY Subsidiary LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 (in liquidation) and December 31, 2021 (ongoing), and the related statement of changes in net assets available for benefits for the year ended December 31, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Legacy EJY Subsidiary LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier ("qualified institution") in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2022 and December 31, 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("U.S. GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Legacy EJY Subsidiary LLC 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of a Matter - Terminating Plan and Liquidation Basis of Accounting

As more fully described in Note 9 to the financial statements, on November 3, 2022, the Plan's sponsor resolved to terminate the Plan, effective November 30, 2022, and determined liquidation is imminent. As a result, the Legacy EJY Subsidiary LLC 401(k) Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the financial statements as of December 31, 2021 to the liquidation basis of accounting used in presenting the financial statements as of and for the year ended December 31, 2022. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

1. Description of Plan

The following description of Legacy EJY Subsidiary LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description and/or Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was adopted by Enjoy Technology, Inc. (the “Company”) on January 1, 2016. On January 1, 2018, the Plan adopted Automatic Data Processing Prototype 401(k) and Profit Sharing Plan. Effective August 1, 2022, the Plan was restated and amended to bring the Plan into compliance with legislative and regulatory changes. Effective October 1, 2022, the Plan name was changed from Enjoy 401(k) Plan to Legacy EJY Subsidiary LLC 401(k) Plan. The Plan was terminated, effective November 30, 2022. The Plan was defined as a contribution retirement plan of the profit-sharing type containing a cash or deferred arrangement described in Internal Revenue Code (“IRC”) Section 401(k). All employees of the Company were eligible to participate in the Plan upon employment. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and certain provisions of the IRC. The plan administrator was responsible for oversight of the Plan. The plan administrator determined the appropriateness of the Plan’s investment offerings and monitors investment performance.

Plan Administration

The Company filed for Chapter 11 bankruptcy on June 30, 2022. The Company was the administrator of the Plan with the authority and responsibility for all matters in connection with the operation and administration of the Plan. Reliance Trust Company was the appointed trustee for the Plan in 2022 and 2021, and acted at the direction of the Plan’s administrator.

Contributions

Employees who elected to participate in the Plan could contribute a portion of their salary up to 90% of their compensation for that period, or up to the limits imposed by Section 402(g) of the IRC. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could elect to make Roth 401(k) contributions to the Plan. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Effective January 1, 2019, the Plan was amended to eliminate discretionary employer matching contribution provision. Participants directed the investment of their contributions into various investment options offered by the Plan. No contributions were allowed to the Plan after September 30, 2022.

Participant Accounts

Each participant’s account was credited with the participant’s contributions, Company contributions, Plan earnings or losses, and rollovers from other qualified plans. Plan earnings or losses were allocated based upon each participant’s account balance. Certain fees were charged to the fund investments and were offset against Plan investment income and loss as presented on the statement of changes in net assets available for benefits. Participants should refer to the prospectuses of these funds for details on the various types and amounts of investment fees charged to the Plan and their individual accounts. The benefit to which a participant was entitled was the benefit that can be provided from the participant’s vested account.

Vesting

Participant contributions, rollovers, and net earnings on these contributions, were fully vested when made or earned.

Participants were fully vested upon retirement, death, disability, or plan termination.

Notes Receivable from Participants

Participants were allowed one note receivable at any time and could borrow from their fund accounts a minimum of \$1,000 up to 50% of the value of their account balance, or \$50,000, whichever is less. Note receivable terms ranged from one to five years, except for notes receivable used to purchase a primary residence, which had a longer term. The notes receivable were secured by no more than fifty percent of the balance in the participant's account and bore interest at a rate commensurate with local prevailing rates at the time the note receivable originated. Interest rates on notes receivable from participants as of December 31, 2022 ranged from 4.25% to 7.50% per annum. Principal and interest were paid in equal installments through biweekly payroll deductions, personal checks from employees on leave, or cashier's checks for the full payoff of the notes receivable.

Payments of Benefits

When participants left the Company, upon retirement or for any other reason, those participants (or their beneficiaries) received the vested value of their account in a single lump-sum payment. The Plan also allowed for in-service withdrawals upon a participant attaining the age of 59½, or having a hardship. In-service withdrawals could be taken from the pre-tax elective deferral account, matching contributions, profit sharing contributions, and rollover accounts as long as they were vested, with the exception of hardships that could not be taken from matching contributions or profit sharing contributions. In addition, the Plan allowed for withdrawals of any rollover contributions at any time.

In order to receive distributions, participants (or their beneficiaries) were required to file the appropriate forms with the Third Party Administrator of the Plan. Account values were determined as of the day the distribution was made.

Distributions under the Plan were generally made as soon as possible after the date of retirement, date of death, or termination of employment. Mandatory distributions of account balances under \$5,000 were made as soon as possible. In the event of a mandatory distribution less than \$1,000 if the participant did not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the plan administrator paid the distribution in a lump sum.

Investment Options

Upon enrollment in the Plan, a participant could direct his or her contributions in percentage increments into a series of mutual funds and a common collective trust offered by the Plan. Participants could change their investment options at any time.

2. Summary of Significant Accounting Policies

Plan Termination and Liquidation Basis of Accounting

On November 3, 2022, the Plan's sponsor resolved to terminate the Plan, effective November 30, 2022. It was further resolved that, after the effective date of Plan termination, participants would become fully vested in their accounts, the Plan would not accept contributions and there would be no benefit accruals. Participants had the option to request a distribution of their entire account balance, or their balance would be rolled over into an individual retirement account at American Century Investments.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, disclosure of contingent assets and liabilities and changes in net assets available for benefits. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2021 excess contributions to the applicable participants prior to March 15, 2022. No liability for excess contributions was recorded as of December 31, 2022.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

Information Certified by the Trustee

Reliance Trust Company has prepared and certified as complete and accurate the Plan's schedule of investment assets, notes receivable from participants, transactions, and net realized and unrealized gains and losses on investments, and interest and dividend income, which was used to prepare the accompanying financial statements and supplemental schedule.

3. Fair Value Measurements

Accounting standards for fair value measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under these accounting standards are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2022 and 2021:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Common/collective trusts: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may have occurred daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserved the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations would be carried out in an orderly business manner.

5. Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments in mutual funds may have been managed by Reliance Trust Company, the trustee of the Plan. Any purchases and sales of these funds were performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, were permitted under the provisions of the Plan, and were specifically exempt from the prohibition of party-in-interest transactions under ERISA.

6. Tax Status

The Plan used a non-standardized pre-approved plan document sponsored by ADP, LLC. ADP, LLC received an opinion letter from the IRS dated October 6, 2020, which states that the non-standardized pre-approved plan document satisfies the applicable provisions of the IRC. The Plan itself had not received a determination letter from the IRS. However, the Plan's management believes that the Plan was designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provisions for income tax have been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan took an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Company does not believe the Plan had any uncertain tax positions. The Plan may be subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan provided for various investment options in any combination of mutual funds offered and a common collective trust by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

As of December 31, 2022 and 2021, approximately 46% and 44%, respectively, of net assets were held in two funds.

8. Subsequent Events

In accordance with accounting standards affecting disclosures of subsequent events, the Plan evaluated subsequent events for recognition and disclosure through October 16, 2023, the date which these financial statements were available to be issued.

The distribution of Plan assets to participants was completed in January 2023, and the Plan had a final return Form 5500 filing and report as of January 31, 2023.

Management concluded that no other material subsequent events have occurred since December 31, 2022 that required recognition or disclosure in these financial statements.
