We have performed audits of the financial statements of Creative Drive Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 29, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to July 29, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2021 and July 29, 2022 and for the period from January 1, 2022 to July 29, 2022, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

NOTE A - DESCRIPTION OF PLAN

The following description of the Creative Drive Retirement Plan (f/k/a The KSC Kreate, LLC 401(k) Profit Sharing Plan) (the "Plan") provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan. The KSC Kreate, LLC 401(k) Profit Sharing Plan was formed on January 1, 2013, covering all eligible employees of KSC Kreate, LLC. Effective March 1, 2016, the Plan was amended to allow for the change in Plan Sponsor and the legal name of the Plan. As part of the amendment, the Plan Sponsor became Creative Drive, Inc. (the "Company" or "Sponsor"), and in conjunction with the change in sponsor, the legal name of the Plan was changed to Creative Drive Retirement Plan. Employees are eligible to receive safe harbor contributions upon their election to enroll into the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Effective July 29, 2022, the Plan was merged into the Accenture US 401(k) Match & Savings Plan, total assets of \$19,102,827 were transferred out of the Plan, and on the same date the plan was terminated. Participants received credit for their service in the Plan for purposes of eligibility and vesting in the Accenture US 401(k) Match & Savings Plan.

Plan Administration

The Plan is administered by the Company. Effective as of March 1, 2016, the Company engaged Ascensus Trust Company ("Trustee") as the trustee for the Plan. The trustee also serves as the Custodian of the Plan's investments and the Plan's record keeper.

Eligibility and Contributions

All full-time employees of the Company are eligible to become participants in the Plan subsequent to the completion of three months of service and reaching an age of 21 years or older.

Each year, participants may elect to contribute up to 100% of their annual eligible pretax compensation, as defined in the Plan, subject to maximum dollar limitations established by the Internal Revenue Code ("IRC"). The total per employee maximum allowable tax deferred contribution to the Plan under the IRC was \$20,500 plus catch-up contributions of \$6,500 for employees age 50 or over for 2022. Participants may also contribute amounts representing distributions from other qualified plans ("rollovers"). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Sponsor will make matching contributions to the account of each eligible participant in an amount equal to 100% of the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the participant's elective deferrals that exceed 3% of the participant's compensation but do not exceed 5% of the participant's compensation. The Plan provides for the Sponsor to make discretionary profit-sharing contributions. For the period ended July 29, 2022, there were no discretionary profit-sharing contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution, matching contributions, any discretionary profit-sharing contributions and allocations of investment earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Each participant is permitted to have only one loan outstanding at any time with the maximum loan amount being \$50,000 (reduced by the highest outstanding loan balance in the previous 12 months) or one-half of the participant's vested account balance in the Plan (reduced by the current outstanding loan balance, if any), whichever is less. No loans will be given for under \$1,000 and loans are not permitted from Roth deferrals. The loans are secured by the balance in the participant's account and bear interest at the current prime rate. As of July 29, 2022, there were \$0 in notes receivable from participants. In 2021, interest rates on these loans ranged from 3.25% to 5.50%. Principal and interest is paid ratably through payroll deductions.

Investment Options

Upon enrollment in the Plan, a participant may direct his or her contributions plus actual earnings thereon to be invested in any of the investment options offered by the Plan. Participants may change their investment options selections on any business day as defined by the Plan.

Vesting

Participants are immediately fully vested in both his or her own contributions and Company matching contributions plus/minus actual earnings thereon. Participants vest in the discretionary profit-sharing contributions as follows:

Participants employed on or after retirement age, 65 years old for Plan years ended on July 29, 2022 and and December 31, 2021, are 100% vested in the discretionary profit-sharing contributions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or his or her beneficiaries may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. No annuities are allowed under the Plan. If a participant meets certain hardship criteria, benefits may also be received as an in-service withdrawal. No participant consent is required for automatic payouts if the vested account balance is less than \$1,000.

Benefits paid to participants are recorded as deductions from net assets available for benefits when paid.

Forfeitures

Forfeitures of discretionary profit-sharing contributions result from participants who terminate their employment prior to the time they are fully vested. If the participant is rehired before incurring five one-year breaks in service, the account balance as of the termination date is restored. The forfeited balance will be

used to cover administrative expenses. During the Plan period ended July 29, 2022 there was no forfeitures.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of the financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net Appreciation(Depreciation) in Fair Value of Investments

Net realized and unrealized appreciation(depreciation) of the fair value of investments is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation in fair value of investments and includes the Plan's realized gains and losses on investments bought and sold during the year, as well as unrealized gains and losses on investments held at the end of the period.

Risks and Uncertainties

The Plan provides for investment options in a variety of investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market volatility, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Administration of Plan

Certain administrative functions are performed by officers or employees of the Company. No such officers or employees receive compensation from the Plan. All costs, expenses, and fees incurred in administering the Plan, to the extent not paid by the Company, are incurred by the participants. Certain administration expenses are paid directly by the Company. Fees paid by the Company on behalf of the Plan were approximately \$2,800 for the Plan period ended July 29, 2022.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2022 or 2021.

NOTE C - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Transfers between levels within the fair value hierarchy are recognized by the Plan on the date of the change in circumstances that require such transfer. There have been no changes in the methodologies used at July 29, 2022 and December 31, 2021.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds - Valued at the Net Asset Value (“NAV”) of shares held by the Plan at year end. The mutual funds provide for daily redemptions by the Plan at reported NAVs with no advance notice requirement.

Self-directed brokerage accounts - Common stock and preferred stock, mutual funds, and exchange traded funds traded in active markets on national and international securities exchanges are valued at closing prices on the last business day of each period presented.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or

NOTE D - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at July 29, 2022 and December 31, 2021, and net appreciation(depreciation) in fair value of investments, dividend and interest income, and interest income on notes receivable from participants for the period from January 1, 2022 through July 29, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company, the trustee for the Plan.

NOTE E - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Notes receivable from participants are considered party-in-interest transactions because they are transacted with Plan participants. Certain Plan investments include mutual funds managed by the Trustee. These investments and transactions qualify as party-in-interest transactions.

Fees paid by the Plan to the Trustee for administrative services were approximately \$3,000 for the period from January 1, 2022 through July 29, 2022.

NOTE F - TAX STATUS

The underlying non-standardized prototype plan has received an opinion letter from the Internal Revenue Service ("IRS") dated March 31, 2014, stating that the written form of the underlying prototype document is qualified under Section 401(a) of the IRC, and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(a) of the IRC. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan management believes the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of both July 29, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan's policy is to recognize interest and penalties as a component of administrative expenses, and there were no interest and penalties recognized during the period ended July 29, 2022. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events of the Plan through October 24, 2023, which is the date these financial statements were available to be issued.
