INDEPENDENT AUDITOR'S REPORT

To the Trustee and Participants of
Patio Food Products, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Patio Food Products, Inc. 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 15, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period from January 1, 2023 to June 15, 2023 and for the year ended December 31, 2022, and the related notes to the financial statements (collectively, financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 15, 2023 and December 31, 2022, and for the period from January 1, 2023 to June 15, 2023 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Patio Food Products, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Under the Plan, any affiliate of Patio Food Products, Inc. can also adopt the Plan. The following were adopting employers: Patio Drive Inn Restaurant, Inc.; Patio Restaurant of Aurora, Inc.; Patio Restaurant of Bolingbrook, Inc.; Patio Restaurant of Darien, Inc.; Patio Restaurant of Lombard, Inc.; and Patio Restaurant of Orland Park, Inc.

All adopting employers will be collectively referred to as "Company."

General

The Plan was a defined contribution plan covering all employees of the Company who had attained the age of 21 and completed one year of service, except for union employees and non-resident aliens. Initial enrollment was available each January 1 and July 1 after reaching eligibility. The Plan was subject to the provisions of the Employee Retirement Income Security act of 1974 (ERISA). The Plan's Trustee was responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Effective June 15, 2023 the Plan transferred all assets to another qualified employee benefit plan. See Note 6.

Contributions

Each year, participants could have contributed up to 100% of pretax annual compensation, as defined in the Plan agreement. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could have also contributed amounts representing distributions from other qualified defined benefit or defined contribution plans.

Discretionary matching contributions may have been made on behalf of all participants who made a pretax contribution to the Plan. A participant would share in matching contributions regardless of service completed during the Plan year. The Company elected to match 25% of a participant's elective deferral contribution limited to 6% of eligible compensation. For the period from January 1, 2023 to June 15, 2023 and for the year ended December 31, 2022, the Company made matching contributions totaling \$9,921 and \$24,032, respectively.

Participants directed the investment of their contributions into various investment options offered by the Plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions and Company matching contributions, as well as allocations of Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

NOTE 1 - DESCRIPTION OF THE PLAN, CONTINUED

Vesting

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts was based on years of continuous service. A participant was 100% vested after six years of credited service.

Notes Receivable from Participants

Participant loans were not permitted under the Plan.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant could elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments in accordance with the Plan agreement. For termination of service for other reasons, a participant received the value of the vested interest in his or her account as a lump sum distribution.

Forfeited Accounts

At June 15, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$0 and \$1,516, respectively. These accounts could have been used to pay administrative expenses of the Plan or to reduce Company matching contributions. For the period from January 1, 2023 to June 15, 2023 and for the year ended December 31, 2022, no amounts were used to pay administrative expenses or to reduce Company matching contributions. On June 15, 2023, the Plan transferred forfeited nonvested accounts of \$1,516 to another qualified employee benefit plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustee determined the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements.

Investment Valuation and Income Recognition, Continued

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits were recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Investment related expenses were included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

Subsequent events have been evaluated through December 15, 2023, the date that the financial statements were available to be issued.

NOTE 3 - CERTIFIED INVESTMENTS

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, John Hancock Life Insurance Company (U.S.A.) (John Hancock USA), a qualified institution, has certified that the following information included in the financial statements and ERISA-required supplemental schedule is complete and accurate:

NOTE 4 - FAIR VALUE MEASUREMENTS

Fees paid by the Plan for investment management, recordkeeping, and transaction processing services amounted to \$8,111 and \$16,911 for the period from January 1, 2023 to June 15, 2023 and for the year ended December 31, 2022, respectively.

NOTE 5 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS, CONTINUED

Gateway Pension Services, Ltd., the pre-approved plan sponsor, provides certain administrative services to the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping and transaction processing services amounted to \$974 and \$1,767 for the period from January 1, 2023 to June 15, 2023 and for the year ended December 31, 2022, respectively.

In addition, various advisors provided investment advisory services to the Plan. Fees paid by the Plan for investment advisory services amount to \$4,291 and \$13,528 for the period from January 1, 2023 to June 15, 2023 and for the year ended December 31, 2022, respectively.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6 - PLAN TERMINATION

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

As stated in Note 1, the Company terminated the plan effective June 15, 2023 and transferred the Plan's assets to a professional employer organization's defined contribution plan.

NOTE 7 - TAX STATUS OF PLAN

The Plan adopted a non-standardized form of a pre-approved plan sponsored by Gateway Pension Services, Ltd. The pre-approved plan has received an opinion letter from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of June 15, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator has no reason to believe Form 5500 is subject to examination for years prior to 2019.



